MEANING OF THE NAME

The surname Hollingworth is derived from a place in northeast Cheshire, of the same name, supposedly the place called "Holisurde" in the Domesday Book for Cheshire, pronounced "Hollis-worth," but probably intended to be "Hollinworth." It is in the Parish of Mottram-in-Longdendale, a few miles south of Manchester. (It is possible that several separate families using this place as a surname came into existance at an early day. There are two other places with this name in Lancashire north of Manchester. The Cheshire place was a barren wasteland at the time of Domesday (1086) and it was not until about the time of Magna Carta (1215) that we find any person using the name as a personal family surname. This was "Tomas De Holinewurth" (here the name is transliterated into Latin) who was a signatory on a charter of about that period. The two Anglo-Saxon words, Holegn (or Holyn), 'a holly bush,' and Work (or Worke), meaning an enclosure, or farmstead, are said to be the origin of the placename Hollingworth in Cheshire. More loosely, it signifies "A farm enclosed by holly bushes," or "Holly Farm." The earliest form of the surname was Hollingworth, in the old orthography, Hollyngworthe, but in later centuries a medial "s" came to be used by some of the families, not much earlier than the early 1600s. Five generally used forms, Hollingsworth, Hollingworth, Hollingworth, Hollinworth and Hollandsworth, are found in the indexes to births, marriages and deaths for England beginning in 1837, and in most of the telephone or city directories of the large cities in England and the United States of America.

INTENT OF THIS QUARTERLY

To publish verbatim copies or abstracts of records of the family world wide from the earliest times to the present. Hollingsworth Register is now in its Thirteenth Year. Nearly every instance of the surname in the U.S. Census schedules, 1790-1870 has been published in this quarterly. About two million pages were searched to produce that result, not to mention searching all kinds of other records. We know of no other family magazine which has even attempted to do this.

GEORGIA HOLLINGSWORTH FAMILIES, PART ONE OF A SERIES

JESSE HOLLINGSWORTH

JESSE HOLLINGSWORTH, progenitor of a large family, not simply confined to the state of Georgia, but represented in Mississippi, Alabama, California, Tennessee and other states, finds our attention as the subject of the first article in this continuing series. In inaugurating the Georgia series, we have attempted to pick as the title for each article, the name of the established ancestor, the one who can be documented clearly in connection with the living representatives of the family. Although Jesse's father, or grandfather, may have initiated the emigration into Georgia, we have no proof, nor do we even know the names of these surposed emigrants. So we pick Jesse as the natural beginning. He was probably born before 1770, basing our guess on the known period of birth of several of his sons. The place of birth is not known. He certainly could have been a native of Georgia. But this writer believes he was born in North Carolina. This is not pure speculation, as the reader vill see. Jesse Hollingsworth died before 1830, probably in Twiggs or Docley County, Georgia. (See further.)

The name of Jesse's wife has not been discovered.

The earliest record yet found of Jesse Hollingsworth appears in the Jefferson County Tax Digests for the year 1796, page 33, Hampton and Fuzel District. He was taxed on 250 acres of third quality land on Brushy Creek which adjoined land of Aquila Mathews. Other neighbours were William Frizel, Hugh Wilson and James Smith. Jesse owned one slave. In the same county's 1799 list, page 51, Capt. Hampton's District, Jesse was taxed for 345 acres. His name appears on the lists of 1801 (page 18), 1802 (p. 9), 1803 (p. 2), and 1804 (p. 49), (the last tax list available to us for Jefferson County, Ga.) taxed during these years for either 250 or 260 acres, the figures changing in each list. Most other early records of Jefferson County were lost. The oldest book of deeds and mortgages, 1797-1798; 1803-1808, has been personally examined (on microfilm) by this writer. No entry of the name was found.

In the First Land Lottery, Jesse Hollingsworth (Hollinsworth) drew one blank and one prize. The Vayne District Grant Book, page 29, at the Office of the Surveyor-General, Atlanta, shows that the prize draw was for a tract of land in the First District of Vayne County, Georgia, Lot No. 70. It was registered 26 Feb., 1806. The office of Ordinary for Wayne has reported by letter to this writer that there is no record of this land, or of Jesse Hollin(g)sworth, on the books of the county! This avenue for further research was thus, perhaps temporarily, blocked. (REGISTER, Vol. 2, p. 18.)

The last record we have of Jesse Hollingsworth in Jefferson

County is a Head-Right Grant for 95 acres of land, recorded in 1808. (Book "G", p. 354, Index to Headright & Bounty Grants, Surveyor-General Dept., Atlanta, Ga., page 83. Editor has photocopy.)

Jefferson County, Georgia was set off in 1796, from parts of Burke and Warren Counties. Since Jesse's name appears in the new county's first Tax List, it is natural to assume that his land was purchased prior to the erection of Jefferson as a county. The land on Brushy Creek probably had been in Burke County. In 1870 a courthouse fire destroyed almost all of Burke's official records! There were other Hollingsworths living in Burke in those days, Zebulon Hollingsworth being probably the oldest of them. He had arrived in the colony and secured a Head-Right Grant for 150 acres in St. George Parish (later Burke County) in 1774. (Book M-201, same source.) Valentine Hollingsworth, Zebulon's brother, obtained a 50 acre grant the same year. (Ibid Book H, p. 107.) The Tax Defaulters' Lists for Burke, 1790 (published in newspapers of the period, thus being saved) list Zebulon's name in Capt. Dill Sapp's District, and the 1793 publications of Defaulters show a Stephen Hollingsworth's name appearing in Capt. Bryant McCuller's Tax District. (See: The Georgia Genealogical Magazine, by Folks Huxford - the best Georgia publication in this field - January, 1964, p. 74, quoting The Augusta Chronicle and Gazette of the State, Issue of August 24, 1793. Also see The National Genealogical Society Quarterly, March, 1966, Vol. 54, No. 1, pp. 42, 43.)

The late Clyde D. Hollingsworth, Sylvania, Georgia, a noted historian and genealogist, did remarkable research into Georgia's Hollingsworths. In "The Hollingsworth Family of Screven County, Georgia," (1952), he published most of his findings. The work was produced with an additional background of on-the-spot research in the counties of Sampson, Duplin, Bladen and New Hanover Counties, North Carolina, and at the Archives in Raleigh, N.C. Mr. Hollingsworth's work proved beyond doubt that the two above described men, Zebulon and Valentine Hollingsworth, of St. George's Parish, Georgia, were two of the sons of Stephen and Anne (Robinson) Hollingsworth who were early settlers on the North-East Branch of Cape Fear River, in what then (1746) was New Hanover County. Subsequent work by this writer only served to strengthen and clarify the finding. Stephen3 was the son of Henry2 and Lydia (Atkinson) Hollingsworth, and Henry² was of course, the son of Valentine Hollingsworth the Quaker Immigrant. Let us state here, not prematurely, we hope, that it is our opinion that Jesse Hollingsworth was a descendant of Valentine Hollingsworth the Immigrant, through his son Henry, then Stephen3 and was probably a grandchild of Stephen3 himself, through one of his sons, Zebulon4or Valentine4.

It should be noted here, that Clyde D. Hollingsworth because of the unfortunate incorrectness of Grimes' Abstract of the Will of Catherine Hollingsworth Edwards of Bladen County, N.C., (1755), was unaware that "the other Stephen3 Hollingsworth," the Baptist clergyman, had settled, in 1735, on the North West Branch of Cape Fear River, then in Bladen County! He therefore equated the records of the two men in some instances, though he was aware that two, and even three or perhaps four Stephens, lived in that area. (See REGISTER, Vol. 2, pp. 142 et seq.)

Briefly tracing the movements of this family: Henry Hollingsworth and Lydia (Atkinson), his wife, removed from the New Castle County, Delaware, area, to Cecil County, Maryland, where Henry died. Henry departed from the Quaker religion. Stephen3 Hollingsworth was baptized into the Church of England on the day before his marriage to Anne, the daughter of James Robinson. (Records of the Emmanuel Church, New Castle County, Delaware, Bartism dated Feb. 17, 1716/17; Marriage ibid, Feb. 18, 1716/17.) Stephen and his cousin, Abraham3 Hollingsworth, obtained two tracts called "Partners Parcells," on the east and west sides of Elk River in Cecil County, Maryland, surveyed 25 November, 1719. (Rent Roll from Calvert Papers, Cecil County, p. 163.) The first part contained 400 acres and the second part 100 acres. In the same period, tracts of land for Lvd-ia, Abraham, and Thomas Hollingsworth were laid out in the same vicinity. (Ibid, pp. 86, 166.) Stephen3 removed to Orange County, Virginia and obtained a grant of 472 acres in 1734 on the west side of Shenandoah River. (The Hollingsworths of Screven County, Georgia, p. 11.) His daughter, Lydia, in 1735, was married to John Ross in the Quaker Meeting at Hopewell. Stephen evidently did not approve of the wedding (being then of the Established Church) and his name is not on the certificate, though the names of Abraham3 and Ann Hollingsworth, still devoted Quakers, are. Stephen Hollingsworth and his family then removed to Cape Fear River and he obtained a grant on Muddy Creek in New Hanover County in 1746 which fell by right to his oldest child and heir at law, Henry4 Hollingsworth. (We plan to devote a future article to this family.) In several private deeds, recorded in Cecil County, Maryland, and New Hanover and Duplin Counties, North Carolina, Henry4 Hollingsworth disposed of the lands of his "honoured father, Stephen Hollingsworth, Dec'd," to his several brothers. In one of these, Henry recited that he was the son of Stephen and the grandson of Henry and Lydia Hollingsworth, thus establishing absolute proof that the North Carolina family in Sampson and Duplin Counties was the same as that which had lived earlier in Cecil County, Maryland. (To be published later.)

Clyde D. Hollingsworth's book, p. 12, 13, shows more of the information regarding Stephen's family, and that the names of his children were: Lvdia, (m. John Ross); Henry (m. Marv Murrah); James (married twice; 2nd wife Elizabeth Thomas); Zebulon - who emigrated to Georgia; Valentine, ditto; and Timothy, the voungest, who was of Lovalist sympathies during the Revolution and lived in east Florida; (married Susannah Johnson.) New Hanover deeds establish the names of all the men above listed. It is doubtful that there were any other sons. Now, can we eliminate any of these in our search to "pin down" the father of our subject, Jesse Hollingsworth? Yes.

Henry4 may be eliminated. By Marv Murrah he had sons James, Henry, Zebulon. The lineage of none of these makes room for Jesse. James4 had by his two wives, sons William, Jacob, and Henry. He also had daughters Rachel who m. Benjamin Lanier, Ann who m. Kedar Harrell, Hannah who m. Andrew Cox, Mary m. _Fountain; Celia, m. _Pickett, Sarah and Lydia. Suffice to say, none of the three sons could be Jesse's father. (Accounts of Estates, 1769-1800, Part 1, Loose Papers, Duplin Co., N.C. at Raleigh; Will Book A,pp. 220, 221, Estate of James Hollingsworth, wills of Elizabeth & Jacob Hollingsworth.)

Timothy⁴ Hollingsworth died in Camden County, Georgia, in 1814. Fortunately, he left a will and the writer has a copy. He left only one son William (born 1790) who later died in Jefferson County, Florida. (REGISTER, Vol. 2, pp. 61-63.) Timothy was too young to be the father of Jesse. In this process, we can eliminate Henry⁴, James⁴ and Timothy⁴, leaving Zebulon⁴ and Valentine⁴ as the only two possibilities. The above information made them very good possibilities! (Camden County, Georgia, Will Book A, page 134.)

According to Clyde Hollingsworth's book, both Valentine and Zebulon Hollingsworth had six children when they came into Georgia.* Book A, p. 658, Screven County Deeds, cited by Clvde, names only four of Valentine's children. They are: Valentine⁵, John⁵, (great-grandfather of Clyde Hollingsworth), Elizabeth and Sarah. Clyde believed, but was unable to give proofs, that some of the six children of Zebulon4 vere: Stephen of Burke, Zebulon and John of Bulloch County, Jacob of Tattnall and William of Burke County, all in Georgia, naming five. It would be unusual if all the six children were boys. But there is no proof that all these were actually Zebulon's children. Some of the descendants believe Jesse was the son of Valentine4 because of the family resemblance between Clvde D. Hollingsworth's family, and the descendants of Jesse! This writer knows full well that family resemblance is of great value in family research. But this is a field which needs more exploration! (Among the Hollingsworths of Co. Wexford, Ireland, from whom this writer descends, everybody looked alike in Ireland, because of the countless first and second cousin marriages!) *Colonial Records of the State of Georgia, Proceedings & Minutes of the Governor & Council, by Allen D. Candler, Vol. 11, pp. 393, 394; Vol. 12, op. 114, 191, 225, set out the petitions of Valentine & Zebulon, each having "a Wife & Six Children." (See this issue, pp.60,61 for Head-Rights.)

The writer prefers to think Zebulon4 was the father of Jesse Hollingsworth, our subject. But preferences have no place in research unless records point that way. The only reason we presently think this is because Zebulon actually lived in the county (Burke) from which Jefferson County was later set off, which is the county where Jesse was living when it was erected. Also: 'Jesse' is a name which arose first in the descendants of Valentinel Hollingsworth through the family of his son Henry, and was a child of Henry's son Zebulon3! Thus the Pattern of a Zebulon having a son Jesse may have been carried on in the Georgia family under discussion.

Stewart's book "Descendants of Valentine Hollingsworth, Sr.," (1925) page 131, must now be considered. There, the statement was made that Jesse Hollingsworth was the son of "Nathaniel and Abigail (Green) Hollingsworth." This is a gross error! Whenever any of the descendants of our Georgia Jesse have been contacted for information, (except those already in correspondence) they cited this incorrect lineare. If these persons are of the type who believe the printed page, no matter who authored it (beware!), Heaven help their descendants. The truth will never come to light. But we are confident that our evidence is sufficient. Nathaniel did have a son Jesse, who married Gulielma Marv Spicer, but that Jesse never left Marvland and was a devout Quaker! Our Jesse was a Baptist and owned slaves! That should make somebody think something is wrong! But he (Jesse of Marvland) was listed by Stewart as born 1796! Take note

THAT in order for this to "work," our Jesse of Georgia had to be a year younger than his oldest son James, who, by Stewart's own account (page 157) was born in 1795! There is the "topper." What more need be said?

Jesse Hollingsworth was a member of the Petit Jury for Jefferson County, Georgia, Nov. 13, 1798, and his actual signature appears on the pages of the same book, dated Feb. 27, 1802. (Superior Court Records Book, 1796-1809.)

The next record of Jesse locates him in Twiggs County, Georgia, in the Tax Digests for 1818. (Earliest available.) The last appearance is in the same lists for 1826. Since his name does not appear anywhere in the 1830 U.S. Census, it is assumed he died between 1826-1830. In the 1818 lists, photostats of which are owned by two of his interested descendants (Mrs. Byron W. Frizzell and Mrs. Gilbert B. Hollingsworth, Jr.,), and by this writer, the names of "Jesse, Jno., and Jas. Hollandsworth," (sic) appear in Captain Wiley Belcher's Tax District. Only Jesse is listed with land, 405. 28 acres on "Barber" (creek?), and taxed also for a Town Lot in Delphas and a carriage of two wheels. (Dept. of Archives, Atlanta.) In Capt. Bostick's District lived an Isaac Hollandsworth, a known Revolutionary veteran. (Many interested people favour Isaac as the father of Jesse, but we have no evidence of this. There simply are not enough Twiggs County records extant, to make a decision in this possibility one way or the other, feasible.) John and James, in the 1818 lists, were doubtless Jesse's two eldest sons. (See list of children which follows.)

As if the destruction of all the records of Burke County, and the majority of those for Jefferson was not enough, it is our displeasure to inform our readers, that in a courthouse fire in 1901 (!) all the records of Twiggs County (except these tax digests, 1818, 1826, 1830, 1833 and 1853) were lost. Further research might be made in records of surrounding and contemporary counties, and in the records of Richland Baptist Church, Minutes 1812-1844, Memberships, 1811-1844; and Stone Creek Baptist Church, Minutes, 1808-1875; and Membership Roll, 1808-1888. (At Archives, Atlanta.) "History of Twiggs County, Georgia," (Jones & Faulk, Columbus, Ga., 1960 page 141,) under "Baptist Churches," lists Jesse Hollingsworth as Messeager for the Mount Pleasant Baptist Church in 1819. The church was in existance only from 1816 to 1820. James, his son, was Messenger to the Bersheba church in 1820. This church was organized the same year. (Ibid.) James and John Hollingsworth, no doubt the same two noted in the 1818 lists, were privates in the Company of Twiggs County Militia for the frontier of the county, 9 August-13 Sept., 1813, Lt. John Keener in command, at Fort Telfair. (Ibid, pp. 31, 32.)

The book "Hollingsworth Genealogical Memoranda in the United States, 1682-1884," names James Hollingsworth of Macon (first in Twiggs county), Bibb County, as "son of Jesse." Descendants of Cornelius Hollingsworth say he was a son of Jesse. Therefore we know these two, at least, are surely correct. Others: Jesse, Jr., William and John Hollingsworth, or five sons. See next page for a short description of their families.

The tradition preserved by Mrs. G. B. Hollingsworth of Birming-

ham, Alabama, about her husband's ancestor, is very worthy of note:

"According to family tradition, this branch of the Hollingsworth family originated in America with a Robert Hollingsworth
who came from Ireland and settled in Norfolk, Virginia. His
descendants came down to Cape Fear River, North Carolina and
from there into Georgia." (THE HOLLINGSWORTH FAMILY (Including Easterling and O'Neal families), by Marjorie Hollingsworth, June 29, 1964, Duplicator Typescript with references. Copy in possession of writer by kind permission.)

Attempting to check out the "Robert" has proved fruitless. But note the association with Cape Fear River. Mrs. Hollingsworth also says that Robert was supposed, in the tradition, to be the father of Jesse, who was absolutely the father of Cornelius. The same information asserts Jesse died in Dooley County, Georgia, and was buried there.

Here are brief notes on the supposed children of Jesse Hollingsworth:

- 1. JAMES HOLLINGSWORTH, Born "about 1795" (Stewart) (but probably about 1790.) Married about 1812, Elizabeth Newberry. (She was born about 1790 in North Carolina U.S. Census, 1850, Yazoo City, Miss., REGISTER, Vol. 1, p. 139.) James is listed born "North Carolina," in the enumeration of the family of his son Isaac Gordon Hollings-vorth in Yazoo City, 1880 U.S. Census, page 425. We haven't had apportunity to check the 1880 returns for other children. But this information, if true, would disqualify either Zebulon4 or Valentine4 as Jesse's parents, if James, Jesse's oldest son, were born in North Carolina. James was Assessor in Macon, Ga., a term. He died between 1840-1850. His widow, Elizabeth, moved to Yazoo City, Miss., with son Isaac.
- Issue: Mary Ann (1813); John M. (1814); Jefferson, (1817); Eliza, (1819); Deborah, (1821); David Marshall (1823); Isaac Gordon, (1825); James (1828); Benjamin Franklin, (1832). Our thanks for these and other records, and unending help, to Mrs. Lucille (Bridgers) Frizzell of Johnson City, Tenn., And Mrs. Frances W. Wright, Crowley, Louisiana.
- 2. CORNELIUS HOLLINGSWORTH, born October 1, 1797, in "Georgia" (information of Mrs. G. B. Hollingsworth, and U.S. Census, 1850, Thomas Co., Ga., p. 34-B. REGISTER, Vol. 2, p. 154.) Died September, 1874, near Pelham, Georgia. Married Sara O'Neal, daughter of Britton O'-Neal. (She was born Sept. 5, 1809 in Georgia.) Records courtesy of Mrs. G. B. Hollingsworth, Jr., of Birmingham, Ala.
- Issue: Henry, (1829); Elizabeth (1830); William (1834); Amanda (1839); Nancy (1841): James (1843); Susan (1845); Sarah (1849); Cornelius, Jr. (1851). (*Probably more likely 1807-1811.)
- 3. JOHN HOLLINGSWORTH (not proved a son), born about 1792. Died about 1832, Twiggs or Bibb County. Tax Lists of Twiggs, 1833, lists Kellev Glover, "Guardian of Orphans of John Hollingsworth." U.S. Census 1830 (REGISTER, Vol 2,p. 111) shows John in Bibb Co. p. 50,

mear James his brother. There are five young persons listed. Although we have no proof of the assertions, we think that the Mary Hollingsworth of Twiggs County (REGISTER, Vol. 2, p. 154, 1850 census) was his widow, and that "Polcy" (female) born about 1826 was a daughter of John & "Mary." Israel Hollingsworth, later of Pickens Co., Alabama, enlisted from Twiggs in the Creek Indian War, Feb. 1, 1836. He resided at Chambers County, Alabama in 1850 (Census) and had married Diana Story. 1850 census shows he was born about 1817/8, but family bible states born 1 August, 1817. One of Israel's sons was named William Jesse Hollingsworth, born 1856. (Pension Records, National Archives, courtesy Mrs. Clyde D. Hollingsworth, Sylvania, Ga., and Bible Record owned by John C. Cheek, Rte 1, Box 186, Oklahoma City, Okla, sent to us by Mrs. Thomas Ashcraft of Favette, Ala.)

4. JESSE HOLLINGSWORTH, Jr., (not proved) born about 1796/7, in Ga. (Lowndes Co., Ga., U.S. Census, REGISTER Vol. 2, p. 152.) First appears in 1830 U.S. Census, Fayette Co., Ga. p. 502. (REGISTER Vol. 2 p. 111.) Probably m. twice.

Issue: <u>Jackson</u> (1831); <u>Jesse</u> (1837); <u>Washington</u> (1839); <u>John</u> (1841); <u>Linda</u> (1847).

5. WILLIAM HOLLINGSWORTH, (not proved) b. about 1802, Georgia. In Macon, Ga., 1850. (U.S. Census, REGISTER, Vol. 2, p. 150.) Probably in Dooley Co., in 1830 (REGISTER, Vol. 2, p. 112) as supported by a deed in Bibb County, Book C-3, p. 411 for land in Bibb County, grantee being 'Wm. Hollingsworth of Dooly Co., Ga.' dated 10 Dec., 1831.

Issue: Thomas (1830); William, Jr., (1832); Martha (1838); Franklin (1838-Twins? Listed 'female' in census); Mary (1840); F.E. (female) (1844); James (1848).

The History of Twiggs Co., Georgia (op cit) p. 58, shows Cornelius Hollingsworth was the Sheriff of Twiggs Co. Jan. 20, 1842. He was a Justice of the Peace in his later years in other counties. The whole family appears to have been of good education; responsible members of their respective communities. We welcome letters of correction. But please do not quote to us Mr. Stewart's erroneous pedigree. We are (frankly) sick of seeing it used. But if you have the real ancestry of Jesse Hollingsworth, we will jump for joy if you will but share it with us!

ADDY FIDELIA HOLLINGSWORTH

In our REGISTER, December, 1965, pp. 158, 162, we published the information that this person (also known as Fidelia Addy Vandvke or Van Dike) was born in "Brandon, Rutland Co., Vermont," per her obituary in a Green Bay, (Wis.) paper. Since then, we received copy of the Civil War Pension file for her brother Daniel Jo. Vandyke (sic), which shows he was born in 1842 in "Grand Isle County, Vermont." An examination of the U.S. Census for the town of Allburgh, Grand Isle County, shows the family of John & Hannah Vandike including Daniel and Fidelia. Therefore, since the family were in Grand Isle between 1842-1850, Addy Fidelia, wife of Dr. J. Samuel Hollingsworth, (great grand uncle of the writer) was born there, no doubt in Allburgh, March 6, 1844, as the bible record shows. We still do not know the exact birthplaces of her older brothers & sisters, or her parents.

HOLLINGSWORTHS IN THE U.S. CENSUS OF 1840 - PART TWO

This concludes our long series of purely statistical census extracts which began in our April, 1965, issue with the 1790 Census. Nearly 500,000 pages of manuscript, on 656 rolls of microfilm have been examined by this writer, in the process of producing the now published results. Miss Jeanne Coan of Bruceville, Indiana, has been the only person who helped, by kindly covering the Indiana schedules in her spare time, for which we thank her again. It should be here noted for those of you who are unfamiliar with the census: With very few exceptions, all the census from 1800 through 1880; is in manuscript form. That is, it is not indexed! When the editor says he covered "one hundred and ninety-two thousand, four hundred and seventeen pages of manuscript (192,417) in the 1840 Census," he means it! It was necessary, over a 4 month period, during spare time at the Los Angeles Temple Genealogical Library, for him to go carefully through each roll, turning the crank of the microfilm reading machine, past all of those pages, examining every column of "Names of Heads of Families," in order to present to you this series. The 1850 Census is even more difficult, presenting 42 names per each page, with names of every person being given, not just the Head of the Family as in the First through Sixth Census. We already have combed eleven of the states in the 1850 census, and parts of several other states, to present the other series which is running here. As far as we are able to tell, no other family has ever had such a record presented, and we think this is the singularly outstanding feature of the REGISTER to date. (See Vol. 2, p. 111 for explanations of catagories.)

MORE QUAKER HOLLINGSWORTHS

It seems that at least one descendant of Valentine Hollings-worth, a lawyer, once wrote in a letter which this writer happened to read, that "Valentine Hollingsworth (was) the first Hollingsworth in America." A History of Washington County, Maryland, in introducing a Hollingsworth sketch, advises that all Hollingsworths then living in the United States owed their existance to Valentine! This writer is obvious evidence of that fallacy. Our article, "Seventeenth Century Chronology of American Hollingsworths," presented on page 115 of the October, 1965 issue of Hollingsworth Register, debunked the idea of Valentine being the first settler of his surname in our hemisphere. That documented chronology showed him to be the TENTH settler. (It must be acknowledged, however, that he may have been even farther down the list, because we cannot claim that we had all records at our call.) Lately, we discovered another Hollingworth (sic) family among Quakers, in London. (REGISTER, Vol. 2 p. 93) Now we find more AMERICAN Quaker Hollingsworths. Read further.

The following is an extract from the Third Haven Monthly Meeting of Friends, in Talbot County, Maryland, Volume I., Men's Minutes, dating from 1676 - 1746 (indexed) pp. 83, 101:

(P. 83) "Att our Monthly Meeting at the home of William Stevens at Dividing Creek, The 22nd. day of the 8th month, 1686/

"James Ridley and Rebeccah Berrv Laid their Intentions of Marriage before this meeting it being the first time the Meeting appoints Charles Hollinsworth and James Barber to Inquire into the Mans cleerness and to give accompt to our next Monthly Meeting/"

(P. 101) "Att our Monthly Meeting at Our Meeting House att the head of Tradehavan Creek the 31st day of the 3rd month 1689...

"This meeting finding a concern upon their minds in the Love of god to Vissitt Daniel Toas (?) and his wife, Inquires what friends are willing to Vissitt them as from this Meeting. William Kenton, William Lockwell, Thomas Cook, Charles Hollinsworth and John Pitt is Willing to Vissitt them as from this Meeting..."

So we learn of another "Hollinsworth", this one in Talbot County. Marvland, who was a responsible member of a Quaker Meeting! The duties assigned to him in the two above cited minutes provide assurance to us that he was no recent convert. Yet, the thorough indexes to these volumes seem to indicate no other reference to that surname occur! More research is needed here.

However, Valentine Hollingsworth, one may advise, was in New Castle County, Pennsylvania (Now Delaware) in December, 1682, while the first minute above is dated October 22, 1686! Agreed. But turn, please, to October, 1965, REGISTER, page 131 in the article, "A Marvland Collection." There you will see the abstract of the Will of Robert Martin, Talbot County, dated 24 June, 1675, in which he names his "son" (actually son-in-law) Charles Hollinsworth, Jr."

A deed in Talbot County, dated 1666, from Robert Martin to his daughter, "Damaris Hollingsworth," shows that Charles was his son in law, and, incidentally, that this Hollingsworth or Hollinsworth family were in the colony nearly twenty years before Valentine left Ireland! Of course, we are not sure they were at that early date members of the Society of Friends. (See Americana, & Encyclopedia of American Biography, volume XVI., pp. 154-158.) Still another court record of Maryland (reference Ibid, p. 154), indicates Charles Hollingsworth, was 21 years old in 1660, the date of the record being Sept. 7 of that year. If this man is the same Quaker of 1686, he was 47 years of age at that time.

Charles Hollingsworth was Executor and sole legattee of one John Best, whose will was dated 12 March, 1684 in Talbot County. William Hollinsworth was a witness to the document! (REGISTER, Vol. 1, p. 131.) Charles Hollinsworth was named Overseer in the will of John Singleton, Talbot County, dated 3 May, 1676. (Ibid.) We assume all these refer to one men. But note: In the one above reference, that of the will of Robert Martin, he is called "Junior!" This implies that an older Charles was in the vicinity, tho it is wrong to assume he was this man's father. (In older days, "Junior" or "Senior" did not necessarily mean father and son.)

In view of this new information, along with other surprising data found in the records of Marvland, we will close this article and hope that in a forthcoming issue, we can present some more definite answers to the questions which are raised by these discoveries.

A postscript: "NEISBOROUGH" was the name of a survey of 100 acres, on the North Side of Chester River, then in Kent County, Maryland, laid out for Charles Hollingsworth 13 July, 1683. Another tract of the same amount, called "NEW HOPE" was surveyed the same date. At the time the Rent Rolls of Lord Baltimore were set out, these two tracts were possessed by John Swift and Thomas Usher. It is probable that this was the same man, because Kent was set off alongside of Talbot County. Hollingsworths seemed to be at times regarded as "of Kent County," and at other times "of Talbot Gounty," so that there may have been some boundary disputes between the two. (Talbot was originally erected from Kent in 1662.) (See p. 116, Vol. I. REGISTER in regard to Charles Hollingsworth, born 1639, who was brought to VIRGINIA, to Northampton County, by one Col. Edward Dowglass, who demanded 600 acres there for these services. This seems to be the same man.)

GEORGIA HOLLINGSWORTHS IN THE HEAD-RIGHT INDEX

By way of explanation: The first Georgia "Act For Opening the Land Office", was passed June 7, 1777. It was actually never in force or used, mostly because of the Revolutionary War. The effective Act was the second one of the same name, passed Feb. 17, 1783. It provided for a head-right grant of 200 acres to the 'master or head of a family' and required him to cultivate three out of each hundred acres. The law continued in force until repeal of all such laws in Georgia, Aug. 13, 1909. No information whatsoever as to county of a man's residence or names of members of his family, appears on either the warrant for survey or the plat or grant.

In short, the only thing these grants are good for, genealogically speaking, is to establish the person and the land in the locality. Since so many Georgia courthouses were burnt, meagre information like these grants provide, seems like a "gold-mine." The Grants and plats, surveys, are in the Department of the Surveyor-General, Atlanta, Georgia, 30334. The cost for each document is \$1.00. We are reproducing here all the information from their card-index: Full name of Grantee, County where the Land was located, Book Number, page number(s), amount of acreage, and the year of the grant. JOHN & CATHERINE (TYLER) HOLLINGSWORTH (Part Two From Page 16)

SAMUEL³ HOLLINGSWORTH, probably the second son of John² (of Valentine¹ & Ann (Calvert) Hollingsworth) Hollingsworth, was born between 1707-1722, in New Jersey, Pennsylvania, Delaware or Maryland. (See the Part One of this series for the movements of John Hollingsworth prior to his death in 1722.) Maryland enters the picture now. The Calvert Papers, Rent Rolls for Cecil Co., Md., p. 150, show John Hollingsworth received a grant of 200 acres called in the Survey "Fair Hill," 15 Sept., 1714 at the head of Elk Valley, patented 10 Sept., 1716. No other John at present can account for this grant, which was made at same time so many of the family rere obtaining grants on Elk River.

Samuel³ Hollingsworth moved with his widowed mother, and sister Ann Sutton and brothers, Rev. Stephen, and Valentine Hollingsworth, to Cape Fear River, the North West branch thereof, about 1735. This date is based on the date (Sept. 9) when Stephen and Catherine Edwards his mother received North Carolina Land Grants. Stephen deeded lands in the amount of 640 acres (one of his grants) to his brother Samuel in 1744. (See REGISTER, Vol. 2, p. 144, Deed "h".) Shortly afterward, Samuel, who was a farmer and shoemaker like Stephen, moved to the Welsh Tract on Pee Dee River in South Carolina. He obtained three so-called "Pre-Revolutionary Grants," in that locality. (See Vol. 3, REGISTER, p. 16.) After having a family of at least one son, Samuel, and a number of daughters, the man died rather young, about 1754. The writer obtained a photostat of his Recorded Will, which follows (from the original Charleston Will Books, not the typed transcripts):

"In the name of God Amen the Twenty fifth day of December, in the Year of our Lord one Thousand Seven hundred and fifty three I SAMUEL HOLLINGSWORTH of the Welch Tract in Craven County and Province of South Carolina Planter Being very sick and weak in body but of a Perfect mind and memory thanks be Given unto God Therefore calling thto mind ye Mortality of My Body and knowing that it is Appointed for all men once to dye do make and ordain this my Last Will and Testament that is to say principally and first of all I give and recommend my Soul into the hands of God that Gave it and for my Body I recommend it to the Earth to be Buryed in a Christian Manner at the Discretion of my Executors nothing Doubting but at the General Resurrection I shall receive the same again'd (sic) by the mighty Power of God and as touching such worldly Estate wherewith it hath pleased God to bless me in this Live I give demise and Dispose of the same in the following manner and form. IMPRIMIS It is my Will and I do order that in the first Place all my Just Debts and funeral Charges be paid and Satisfyed. ITEM I Give and Bequeath unto my Well Beloved Son SAMUEL HOLLINGSWORTH all the Lands I hold in Pedee River in the Province afsd. Nevertheless if the Child that my Wife now goes with be a Son I desire and Order that the above said Lands Should be Equally Divided Betwixt my Son abovesaid and the Child unborn if it should be a Son ITEM I Give and Bequeath all my moveable Estate to be Equally Divided bet een my well Beloved Wife MARY HOLLINGSWORTH and my Sons and Daughters and the Legacies to be Given to my Son or Sons when they arrive to the age of Twenty Years and the Legacies to be Given to my Daughters when they arrive to the age of Sixteen Years. ITEM I Order and Bequeath that the tract of Land of Six Hundred and forty acres I hold on North West of Capefear River, be Sold at the Discretion of my Exors. hereafter mentioned and the Money to be Equally Divided between my Well Beloved Wife and all my Children. ITEM I order and Desire my Exors are and Shall make a title on one hundred acres of land to my beloved Brother VOLINTINE HOLLINGSWOR. (sic) as appears by an obligation Given by me to my Brother. ITEM I Desire and order my Exors to make Title on fifty acres of Land to my Well Beloved Sister ANN SUTTON, Widow being a part of the aforesaid Tract. ITEM I do Impower and Ordain my Loveing Wife and my Beloved Brother VOLENTINE HOLLINGSWORTH and my Loveing friend DANIEL DEVONALD as my whole and Sole Executors of this my Last Will and Testament and I do hereby utterly Disallow Revoke Disanull all and Every other and former Testaments Wills Legacies and Executors

By me in any Ways Before this time Names Willed and Bequeathed Ratifying and confirming this and no other to be my Last Will and Testament in Witness Whereof I have hereunto set my hand and Seal the Day and Date above written.

The above is recorded in Book OO of Charleston Wills, pages 222-224. Typed transcripts are now at Charleston but the originals are at the State Archives, Columbia, S.C. The editor had to work for half a year to obtain the photostats because the old books are not in a fit condition to submit to such activities. The original will itself is reported to be lost. The Inventory of Samuel's estate is recorded in Charleston too. We have a full copy and plan to publish it soon. Among the items appraised are some "old Shoemaker's tools," indicating his occupation. The total appraisement was Ll,769.9.0d. A considerable personal estate for those times. James James, Phillip Howell and John Evans were the appraisers. (Charleston Inventories, Book 1753-1756, pp. 266-268.)

There are only two deeds recorded at Charleston, in the name of our subject. Here they are (not counting the Grants mentioned):

- (1) Book SS, page 178: THOMAS BOWEN of the Welsh Tract in the Country of Craven and Provence of South Carolina, Weaver, to SAMUEL HOLLINGSWORTH of the same, Yeoman. Dated 11 Feb., 1746. Tract of 100 acres in the Welsh Tract on Pee Dee River's east side now in the Possession of said SAMUEL HOLLINGSWORTH, bounded on north by a tet. of land late JOHN CURTIS'S, now the said SAMUEL HOLLINGSWORTH's, together with a Plat and Grant of said 100 acres. Witnessed by Walter Downs and Abraham Kerslake. Recorded Dec. 15, 1757. (This land is evidently one of Samuel's grants, it being assigned by Bowen.)
- (2) Book QQ pp. 204-206. Lease & Release...INDENTURE made 15 April, 1751 between SAMUEL HOLLINGSWORTH Yeoman and ANN SUTTON Widow, both of the Welsh Tract in Craven County, S.C. "WHEREAS His Exly. James Glen Esq., Governor of S.C. did grant (dated 29 Nov., 1750) a Parcell of 145 acres to said SAMUEL HOLLINGSWORTH in Welsh Tract, bounded on the West by Pee Dee River, North by Richard Barrows and other sides vacant...for the sum of £100.0.0d. Current, does Grant to ANN SUTTON same land... Witnesses John Evans, Thomas James. "N.B. This Lease was not Proved." Recorded 9 January, 1756. (In the Lease part, Samuel let this land to Ann Sutton for the period of one whole year at the yearly rent of one pepper corn at the Feast of St. Michael Archangel. William James, Justice of the Pease, acknowledged these deeds.)

There is one deed for Valentine Hollingsworth, Samuel's brother, which we plan to publish with other records about him.

It is not known if the child born after Samuel's death was a boy or girl. Probably it was a girl. Besides his son, Samuel Jr., the daughters of Samuel Hollingsworth of Velsh Tract, S.C. were

probably: Elizabeth, who died unmarried in 1772 in Craven County, S.C., Mary Horry, Tuah Howell, Sarah James, Catherine Evans,

This list is derived almost solely from the Last Will of Elizabeth Hollingsworth, recorded in Will Book 1771-1774, page 303, Charleston Wills. It is dated 15 April, 1772; proved 14 October of the same year. She styled herself as "of St. David Parish in Craven County..." The writer hasn't had the time necessary to try and get the names and/or the families of these girls. The above gives us five girls and one boy to Samuel3 and Mary Hollingsworth. If it is a complete list, the children were born in an approximate 12-year period ending about 1754 which would mean Samuel was married at least by 1740. He went from North to South Carolina between 1744 and 1746, according to the two above mentioned deeds.

As for Samuel's vidow, Mary Hollingsworth, it is evident that she as a young woman. It is possible that she remarried soon after Samuel's death as widows were obliged to do in those hard times. But in the records of deaths for the Welsh Neck Primitive Baptist Church, constituted in 1737 on the Great Pee Dee River, we find the following:

"Mary Hollingsworth on membership roll, 1778.
"Mary Hollingsworth died September 4th, 1784."

(Courtesy of Mrs. Gilbert B. Hollingsworth, Jr., now of Miami Shores, Florida, from typed lists sent to her by Mr. Leon S. Hollingsworth of Georgia.) In the same lists were deaths of William (Oct., 1751), Valentine (March 26, 1760), another Valentine (Aug. 6, 1778) Hollingsworth. One of these Valentines was probably Samuel's brother. Who William and the other Valentine were, or which one was Samuel's brother, we don't propose to answer here - because we don't know.

Ann Sutton, widow, probably had been married to John Sutton, Sr., judging from the name of John Sutton, Jr., appearing on Samuel's will. John Sutton also signed the will of Elizabeth Hollingsworth in 1772.

The book "South Carolina Baptists," by Leah Townsend, Ph.D., (Florence, S.C., 1935) page 72, lists a Partial Membership List of Welsh Neck Church, from the Record Books, 1759-1804, including Eleanor, Mary, Velentine, William Hollings orth, Hannah and Lydia Howell, John Sutton and Elizabeth his vife, among others. This adds another William and an Eleanor about whom we know nothing. "Tuah" Howell of the typed copy of Elizabeth Hollingsworth's will, might be a corruption for "Lydia." ('Well, back to the old originals!')

Welsh Neck Church was founded in 1738, and had been settled 2 years earlier, by Welsh Baptists who originated in the Welsh Tract of what is now New Castle County, Delaware, then a part of the Province of Pennsylvania. It is natural that John² Hollingsworths descendants would accompany these zealous ventures. Even as Valentine Hollingsworth the Quaker, their grandsire, had stirred himself and come from Ireland in 1682 to take a leading part in America's early affairs, these Welsh Baptist Converts were prominent in the push southward. (Need we mention intrepid Henry, the father of the original Valentine, who left his place in "Olde Englande," to dwell in the shadow of danger in Northern Ireland before 1631?) More in our next issue on this family.

Probates of Hollingsworth Estates, Union District, South Carolina

These are on film at the Salt Lake Genealogical Library, available on inter-library (intra-mural) loan to their branches. Films contain the original series of Estates. Estates are numbered and the papers (Bonds, Appraisements, Inventories, Bills of Sale) are placed in Packets, the Packets stored in Boxes which are also numbered. The Packets are numbered within each box 1-10 etc. The Boxes numbered 188 by the year 1953. The Index covers up to the last decade, but filming of the estates themselves terminated about 1875. Below we list all HOLLINGSWORTH estates from the beginning to 1875. Listed thereafter are the names appearing in the index.

An examination of these records will be disappointing to the genealogist. No relationships are generally given between the decedent and the Administrator or Administratrix; No Petitions listing the names and addresses of heirs are given up until the middle of the 19th century. (Guardianships would include minor children, but these - a separate series - were examined and nothing whatever was noted for Hollingsworths.)

First Hollingsworth Family in Mississippi - Part Two

JACOB HOLLINGSWORTH, brother of Isaac Hollingsworth (See Vol 3, pr. 1 - 6) was born about 1775 in "North Carolina." He died in 1852 or 1853, in Madison County, Mississippi, at the age of about 77 vears. He was a farmer or planter. His wife was SARAH. We do not have any record of her surname. She was born in South Carolina about 1785. (See Census 1850, Madison Co., Miss. p. 134B, REGISTER, October, 1965, Volume 1, p. 137.)

He married her about 1798 or 1799, judging by the ages of Sarah and their son Isaac, who was 50 years of age in 1850. Both of their sons, Isaac and John, were born in Georgia. The census is consistent in this information.

Here is a full copy of the Last Will of Jacob Hollingsworth. Book A., pp. 192, 193, Madison County, Mississippi, Will Books,

"JACOB HOLLINGSWORTH'S WILL, Williamstown, Madison County, State of Mississippi. November the twenty eighth in the year of Our Lord One Thousand eight hundred and forty eight.

"Know all men by these presents that I JACOB HOLLINGSWORTH, being in sound and disposing mind, do make and establish this my last Will and testament rescinding and revoking all former Wills Codicils and instruments of all kinds -

"I first bequeath my soul to god, "Secondly, I will and bequeath to my wife Sarah, These Negroes, to Wit, One man named Evans and one woman named Rose, and one small bov named Robert. And I also give and bequeath to my wife Sarah, two Eighths of land, one the Eighth on which I may be living at the time of my death together with all houses and appurtenances thereunto belonging, and one Eighth adjoining the same, and I also give and bequeath to her all the household and Kitchen furniture, and I will that at my death, that all my horses and stock of every description whatsoever, that I may possess, shall be equally divided between my two Sons, JOHN & ISAAC, and my Wife SARAH and all the other property not willed to my wife SARAH that I may own or possess, at the time of my death after paying all of my just debts shall be equally divided between my two sons JOHN AND ISAAC.

"Signed, Sealed and Published in the Presence of WILLIAM W. SMITH (Seal) WILLIE J. SMITH (Seal) WM. J. WILLOUGHBY (Seal)

(Signed) JACOB HOLLINGSWORTH (Seal)

Proved in October Term of Probate Court, 1853.

Jacob Hollingsworth's name doesn't appear in the Territorial Census of Mississippi for 1816. He first appears in the 1820 Federal Census of Lawrence County. Judging from these facts, Jacob came out to Mississippi and joined his brother Isaac in that area between 1816-1820. Listed in the 1820 census with the two adults are two males, one 16-18, and one 16-26. Usually the "16-18" catagory is overlapping, which would mean this was only one male 16-18, enumerated in both catagories. However, in this case we believe the en-umerator made an error because the ages fit the two known sons, Isaac (then aged 20) and John (then aged 18). One slave was owned. (See REGISTER, Vol. 2, page 9.) In the 1830 Census, (REGISTER, Vol. 2, page 113) Jacob "Hollonsvorth" is listed in Hinds County, Miss., with brother Isaac, Senior, and Jacob owned 6 slaves. Two males 20-30 again fit the two sons' ages. In the 1840 Census (See this issue, page 53) Jacob and son Isaac are listed in Newton County, and John seems to be in Clarke County, but the ages given in this census all are a bit off! In the 1830 census, it should be noted, it seems Isaac may have been enumerated twice, once in his own household, and again with his father. But this may be incorrect. In the 1850 Census of Madison County (REGISTER, Vol. 1, p. 137) Jacob & Sarah, Isaac and his family and John and family all appear together.

We are sorry to say that this is about all the information we at present have about Jacob himself. There are a few land deeds in his name in Madison County Records, of which we have notes from the Index: (Courtesy Mrs. Byron W. Frizzell, Johnson City, Tenn.) An examination of these may prove helpful. Now we present a brief account of his two sons and their families:

In the June issue of The Genealogical Helper, an internationally distributed magazine, a long query by your editor was published, asking for names of parents, brothers, exact birthplaces, of Isaac & Jacob Hollingsworth of Mississippi. We hope to have results!

)))))) A LEGEND COMES TRUE: ((((((

The Legend:

- (1) "Our Grandfather, Michael Hollingsworth (sic), had brothers, I do not know how many. Our Great Grandfather was killed in the rebellion of Ingland and Ireland, over I think the Little Red School House. Some fought on one side some on the other; it was a bloody fight. Great Grandfather was killed in that war. He was a mounted officer and our Grandfather rode beside him; he was the eldest of the family. Witnessing that was a tough blow to him. When all was over America (sic) was the place he came to. My Brother John Hollingsworth, we always called him Jack, being Father's eldest son, was Grandfather's pride, as he was his eldest son Edward's firstborn to carry on the name. Brother Jack said Grandfather used to put his uniform on and mount his horse, and as he was a boy it fascinated him, that Blue Cape, lined with red, and his shining sword, a child never forgot. He also said there was a bit of a Scotch Burr in Grandfather's speech, which meant Scotch-Irish."
- (2) "Grandfather and Great grandfather was in the Irish Rebellion, and Great Grandfather was killed in that war. There was much more in detail... I was not told... That's the story father told meand looked down at me with his piercing blue eves. Then, my oldest brother John, or Jack, we called him (I was his favorite), said to me that he, being the first son of Edward's family, was Grandfather's

pride. He remembered Grandfather riding his best horse, having his English Uniform on - and he was so proud of Grandfather. There was a Blue cape lined with Red, and a nice, shining sword..."

Thus did the editor's Grand Aunt, Anna Elizabeth (Hollingsworth) Belden, twice describe the old family legend - the oldest surviving story in our own family. The first quotation is from her letter dated June 21, 1955, and the second, in another letter dated April 4, 1956, both being addressed to her first cousin, Mrs. Gladys Ruth (Hollingsworth) Smith, then of Portsmouth, New Hampshire. (Our thanks to Cousin Gladys for her extreme kindness in lending us a whole packet of such delightfully interesting old letters!) Of course "Grandfather Hollingsworth's" name was FREDERICK - not Michael. We shall probably never know where Anna Belden got this idea. She was born six years after her grandfather died. That may be a factor in accounting for it. "The Little Red School House" was not a battle in Ireland. Such a colloquialism refers to early American educational buildings. Probably, Aunt Anna was innocently corrupting the name of the great "Scullabogue House & Barn Massacre", a major event during the Irish Rebellion of 1798 in County Wexford, Ireland, wherein hundreds of Protestants were roasted alive. (The prefix "Sculla" in Gaelic, does mean "school," by the way.)

Clearing away that error, the description of the military uniform remains to be tested. Indeed, the whole legend was for many
years under suspicion because of the several bold face errors found
in it. But, be that as it may, the implication is that Frederick
Hollingsworth served in the "English Army," and brought his uniform
to America with him:

The Legend comes true:

Thus Aunt Anna's report about the "Blue Cape lined in Red" is

probably true! The Irish Militia and Yeomanry (two distinctly different services, the former having existed for many years; the latther being crected in 1796 and disbanded in 1834) generally wore uniforms of blue, with blue cloaks about the shoulders, which were lined red. They carried swords and muskets. But the infantry is what startled this writer. We fully expected to find that Frederick was in the Yeomanry Cavalry, thus befitting that part of the legend still to be proved, about his father having been a mounted officer.

Frederick Hollingsworth arrived in New York on 20 July, 1829, aboard the Brigantine "William," from Dublin. (REGISTER, Vol. 2, p. 131.) It was necessary for him to terminate service in the veomanty to emigrate. But why he left the service in 1825, four years befor emigration - is not answerable. Much more research will naturally be done, most of it probably fruitless. But now, a seven year research project nears success! No doubt if Frederick was able to wear his uniform as late as the 1860 period (Jack his grandson was only aged 8 when Frederick his grandfather died), it is most likely he was buried in it. But as you steady readers know, an extremely dilligent research in Iowa failed to reveal the place of his burial.

It was first in Mrs. Belden's letters that the editor heard of this legend. Now it has, at least, in part, come true. Thank you, Aunt Anna, wherever you are!

Frederick³ Hollingsworth, 4th child and third son of Edward Earl² & Rachel (McFadden) Hollingsworth, was born Dec. 30, 1867, near Grinnell, Poweshiek Co., Iowa; died July 9, 1905, at about 9:00 A.M. (Sunday) of disease of the liver, in Los Angeles, California, aged 37 years, 6 months, 9 days. He is buried in the plot in Rosedale Cametery, Los Angeles, between his father and older sister Nettie May Stinson. Painter, carpenter, shingler.

He married, Sept. 5, 1890, in Los Angeles, ELIZABETH FIRSICH, (originally VIRSICHT or FIRSICHT) daughter of Michael and Catherine (Hofreiter) Firsich, natives of Germany. She was born Nov. 19, 1862, at Dover, Dearborn Co., Indiana; died Nov. 22, 1934, Los Angeles, of Apoplexy, aged 72 years, 3 days old; buried in Mt. Calvary Roman Catholic Cemetery, Los Angeles.

Fred Hollingsworth was born in Iowa in Jasper County, but in Rock Creek township so close to the Poweshiek County line that he is said to have been born in Grinnell. He staved with the family there until they moved to Waseca, Minnesota. His younger sister Anna, in her memoirs, recalls that Fred was very careful then using his father's carpenter's tools, selecting an item, using it, and replacing it in the rack immediately after using it. This incident was when he made himself a shoeshine boy's kit at the age of about 10. After his parents divorced in 1880, Fred lived with his mother and brother Lee (Levi David) in Waseca, Minn., until they all came to Los Angeles in 1887. It has here that he met "Lizzie Firsick." She was a Catholic girl, and the whole Hollingsworth clan was dead set against

any such "mixed marriage." But Fred Hollingsworth had a strong will like the rest of his family. In Ireland, such a courtship would have brought curses down on both sides of the house. But in the United States things were different. Love shattered the ancient walls of politico-religious hatred like the curtain in Jerusalem's Herodbuilt temple had torn to shreds when the Messiah died on Calvary. Fred married his Lizzie, and the rest of the family had to swallow it. But, seeing the spunk of their young brother, it all was accounted to his credit and nothing more came of it. The marriage was a happy one. After all, Jack, the oldest, had married Marv McGovern another Catholic girl. So what was all the noise for? It is hard to understand, sometimes, situations like these when we are removed from the event by more than three quarters of a century!

Fred Hollingsworth was 5 feet, nine inches in height medium complexion; had blue eyes & dark hair. He first registered to vote in 1889 at 21. His residence in 1892 was 1343 Myrtle Ave., occuration: Lather. Not much has been researched on his vife's ancestry. Lizzie's mother arrived on a sailing vessel from Germany.

In Los Angeles in 1887 Fred lived (before marriage) with his mother Rachel at No. 22 Laurel Street. When they married, Fred & Lizzie made their home at 1330 Prospect, which was the name of a part of the now famous Hollywood Boulevard, in "the old days."

Fred Hollingsworth worked in "tract houses" as well as free-lance. He was a lightening-fast shingler, filling up his mouth with shingle nails, and driving each one "home" with but one blow of his hammer! It is said that this practice is what led to some form of poisoning in his kidney-liver system, which brought him to his death at so untimely an age. He worked with his brothers Jack, Lee and Charley in such "far away" places as Bakersfield and Riverside, and was part of the crews who erected the first homes in those communities.

He built the home he died in, located at 2844 Glassell Street, Los Angeles. He was found dead in his bed on Sunday morning when his wife and four boys returned from attending Mass. Thereafter, Lizzie Hollingsworth remained his widow, and carefully raised her sons singlehandedly. She remained in the affections of all who knew her, and when her boys became men, all could see her work had been well done.

THE HOLLINGSWORTHS OF PRESCOTT, ONTARIO

SAMUEL HOLLINGSWORTH came to Grenville County, Ontario, in British America, early in the 1820 period. He joined with one Daniel Mooney in making a Petition to the Governor (His Grace, Charles Duke of Richmond) for lands in the "Township of Edwardsburgh" in Grenville County. His petition shows that he was a native of Ireland, and had arrived at Quebec in the summer of 1817. He had been employed in the Engineer Department at Fort Wellington a while, but when work slackened he was discharged. Hence, the petition. There is no evidence such a grant was made. However, not long thereafter, Samuel Hollingsworth purchased the West Half of No. 16, King Street, North Side, including 20½ perches of land, for the sum of L25., in the town of Prescott. The deed is dated 26 March, 1822. He obtained another lot of 41 perches at No. 22 King Street North Side for L175. under date of 15 March, 1831. We think it was for a livery stable, because his sons John & Samuel were engaged in the business. (References: RG5, Al, vol. 256, Public Archives, Ottawa, Petitions; Abstract Index to Deeds, Prescott, at Dept. of Public Archives, Toronto, Canada.)

Samuel Hollingsworth died on the 14 September, 1833, at Prescott at the age of 32. He is buried in Sandy Hill Cemetery. The memorial stone has the inscription: "a native of Wexford, Ireland." (The expression refers to the county of Wexford.) See the list of other burials in the next article following. Because his will is short, we publish it in full:

"In the name of God, Amen, The fourteenth day of September, one thousand eight hundred and thirty three, I, SAMUEL HOLLINGSWORTH, being very sick and reak of body, but of perfect mind and memory thanks be given unto God; therefore calling unto mind the mortality of my body Knoring that it is appointed once unto all men to die, do make and ordain this my last will and testament; that is to say, principally and first of all I give and recommend my soul unto the hands of Almighty God that gave it and my body I recommend to the earth.

"And as touching such worldly estate wherewith it has pleased God to bles me in this life I give demise and dispose of the same in the following manner and First I give and bequeath unto MARY my dearly beloved wife one third of my property moveable and immoveable conjointly with her two children as long as she remains unmaried. And in case she gets married she is to receive two hundred and fifty pounds currency only and the remainder to be equally divided amongst the children. I also appoint as my legal executors to this my last will ALPHEUS JONES, Esqr. and ALEXANDER McMILLAN Esqr. both of Prescott, Uper Canada.

Signed, sealed, published, pronounced and declared by the said Samuel Hollingsworth as his last will and testament in the presence of us the Subscribers, (signed) HENRY MOUNT, M 12 CSL, JOHN HAYES, JOHN ANDERSON, Surgeon, CURTIS CROSSMAN." (Filed 1st Nov., 1833. Johnstown District Surrogate Court Records, now at Archives, Toronto, Canada.)

The signature in the above vill is very weak and smeared. The Bond and Inventory are also in the papers, dated 1 Nov., 1832 & 15 July, 1835, respectively. The widow had evidently married a Mr. Burke in the interim, signing as "Mary Burke, Admx." Wm. Candell & Moses Murphy appraised the personal property at 168.16.0d. The only interesting items in this inventory are "2 jackets, one blue and one green - valued at 17/6d." They may be the Military attire of the Irish Yeomanry or the Royal Irish Constabulary.

Please see "ONTARIAN HOLLINGSWORTHS," (REGISTER, VOL. 2, p. 163) et seq. for Church records dealing with this family.

This Samuel Hollingsworth was born about 1801 "in Wexford (Co.), Ireland." This much we know. Now: Who were his parents? We think we have the answer. (See REGISTER, Vol. 1, p. 71, Baptism 4.)

There, the reader will see the abstract of the Baptismal Register for the Church of St. Mogue (also called St. Aedan), Ballycanew, Co. Wexford, Ireland, and the baptism of "SAMUEL HOLLINGSWORTH, son of Nicholas & Mary Hollingsworth, baptized Dec. 21, 1801." There are virtually no other Samuels (tho' there are assuredly plenty of them) who fit this age and birthplace. It is a possibility he was the brother of Thomas Hollingsworth of Yonge township, in the adjoining county of Leeds, Ontario, who came to Canada in 1846, bacause a similar baptism of another child of the same Nicholas and Mary fits the known age of Thomas. (See article CORRECTIONS ON LEEDS COUNTY CENSUS in this issue.)

The town of Prescott is situated upon the St. Lawrence River, directly across from the town of Ogdensburg, St. Lawrence County, New York. There may have been correspondence and some visiting between the Prescott Hollingsworths, and those living in the vicinity of Morrisville in Eaton, Madison County, New York. We have no evidence of this.

Following are the only two children of Samuel & Mary Hollings-worth:

- 1. Samuel Hollingsworth, Jr., born 1831; died July 5, 1914,
 AT Prescott, aged 84 years. Buried in Sandy Hill Cemetery.
- 2. John Hollingsworth, born 1832; baptized Dec. 27, 1832 at

 Augusta Episcopal Church. Last heard of in 1861, when
 he was living with his brother Samuel. Occupation: Livervman. (1861 Census, Prescott.) (NOTE: There was a John
 Hollingsworth working as a fireman in Sacramento, California in 1880 (Census) who was single, born in Canada. The
 age is not exactly right, but this might be the same man.)

Samuel Hollingsworth, Jr., was married three times. His first wife, Nancy Barnett, whom he married in 1853, died in 1859 leaving him with children John (born 1854) and Mary Ann, (born 1856). He then married Catharine Campbell (date unknown, but about 1866) by whom he had Catherine (1867), Samuel Lyman (1868) who died in Syracuse, New York, U.S.A. about 1942, and Clara Eugenia (born April 18, 1870) and her mother died at that time, shortly after. (Bur. May 2, 1870 in Sandy Hill Cemetery age 24. He then married (Dec. 28, 1870) Elizabeth Turnbull, who was born about 1836 and died in 1926 aged ninety. By her he had James Gilbert Hollingsworth, born 1872. (By the first marriage, a child Gilbert had died in infancy in 1855.)

A fine letter from Phyllis Stephenson, Corresponding Secretary of the Grenville County Historical Society, 744 King Street West, Prescott, dated January 4, 1967, conveyed to us (besides the list of burials following) the information that the name Hollingsworth has been known there many years. The Hollingsworth residence stood on the north side of King Street across from what used to be the old "Starch Works" but now owned by the Canadian Government. It stood not far from the Alexandra Hotel. Both buildings are now gone, and a gasolene (petrol) service station stands where Sam Hollingsworth (Sr. and Jr.) lived for about eighty years! (A mechanical "Car Wash" stands where the hotel stood!) At the time of his death, Sam Hollingsworth, Jr., was His Majesty's Custom's Agent, and his oldest son John Hollingsworth was Registrar at Prescott until his own

about July 8, 1914, just three days after his father! He was sixty.

Miss Stephenson advised us that a descendant of this man was living a few years ago at P.O. Box 635, Durham, North Carolina, and her name was Dea Townsend, nee Ernst, probably the daughter of Walter & Mary Louise (Hollingsworth) Ernst. Mary Louise was the daughter of John & Agnes (Kennedy) Hollingsworth and granddaughter of Sam Hollingsworth, Jr. (REGISTER, Vol. 2, p. 164.) Our letter to Mrs. Ernst was neither returned nor answered! (It should be noted here, that, while the descendants of Valentine Hollingsworth are always most cordial and helpful in replying to this writer's queries - even though he is no relation to any of them - the Wexford's make it a chronic custom of ignoring letters altogether! To be sure, some of them are more than helpful, making up for the others, but to those others we can't help but say BAH!)

The enumeration of the 1871 Census for Prescott informs us that the Hollingsworths were all of "Irish Descent," except Elizabeth the third life, who was born in Ontario, but of "Scotch" descent. (Naturally, she was a Turnbull!)

(References: Death Record 1914-05-019095 Registrar General, Toronto. Canada, Samuel Hollingsworth;)

Samuel Hollingsworth, Jr., deeded both of the lots by quitclaim to his brother John under date 28 Dec., 1859. We do not understand this. But it is evident he again acquired title to them, perhaps by the sudden death of John. Samuel Jr. made his own will dated 2 Aug., 1901 but proved 13 Oct., 1914. He named neither his wife nor any of his children by name, calling them "my wife" and "all my children." Executors James Turnbull and John Kellev Dowsley, both of Prescott. His wife was to receive an annual income of all the balance of the estate not to exceed the sum of \$400.00 a year. After her death the real and personal estate to be sold and divided equally among the children. (We haven't looked for this document.) Liber 11, folios 1106-1108, Surrogate Registrar of Prescott.

The 1857 Directory for Prescott lists the name of Samuel Hollingsworth as a liveryman. He also was a joiner by trade, as was his father.

This is the sum of our present information about the Prescott family. In 1905, Prescott had a population of 3,500. Today there are 5,100. A Du Pont Chemical company and Brockville Chemical plant are nearby, bringing a rise in population. The citizens hope to keep it "scenic", according to Miss Stephenson. Old Sam Hollingsworth, we know, would say "Amen" to that:

This family were supposed to have settled directly in Yonge township, whose 1851 schedules were lost. No deeds for Thomas Hollingsworth's land in the Fifth Concession, lot 5, were found despite this writer's diligent search. The land may actually have been in Yonge, or he may have been a tenant.

MORE ABOUT MOTTRAM, IN A LETTER TO THE EDITOR

"UNIVERSITY OF CALIFORNIA, SAN DIEGO.

11 April, 1967

"Dear Sir: Your letter of 1 April, which reached me here (directed mistakenly to Kent, England, Ed.) finds me at a great and obvious disadvantage. I have no relevant books or papers, added to the fact that I have done very little about these things since leaving Cheshire in the mid '50's. If I were in England I could at least search my card-indices, but here I am nearly helpless.

"My first recollection is that early records for Longdendale (i.e. to about 1250) are very sparse indeed, to the best of my knowledge (No doubt at that date it was largely barren hill country). There is (as you must know) an early de Burgh charter in one of the Record Society publications (Calendar of Charter Rolls or Cal. of letters Patent, probably), I cannot say who the witnesses were. Thereafter I know of nothing but the Society of Antiquaries series, but it might be worth enquiring at the Lancashire Record Office, Preston, whose (often very remarkable) early series often spill over into that corner of Cheshire. I think you would find the archivist, Mr. Sharpe-France, co-operative. (We did - Ed.)

"For the rest, I agree with vou that the idea of a descent reaching back to 1022 is sheer myth. (Our underscoring - Ed.) I cannot see how it can be asserted that the family was either "pure Anglo-Saxon" or "Norman." My own guess would be that, as you say, there were "veoman families", which rose in the 12th century, & that the "waste-land" of Domesday was at that period gradually opened up, cultivated & settled, & then - as people prospered - manorialized. But I should not expect any "manorial family" at the time of the Norman Settlement - indeed, what evidence there is seems to indicate that Longdendale was a unit by itself (perhaps a 'Soke') & one must remember that the Manor was not really usual in that part of England in the 11th Century, as Marsland & Venogradoff & others showed. So I would view any attempt to carry the history of the family back beyond about 1200 A.D. as unplausible and misguided. This was an area of backward & late economic development.

"But that, I am afraid, is all I can say, & I apologise for its inadequacy, of thich I am only too well aware.

(NOTE BY EDITOR: This epistle will open up someone's eyes!)

The above letter from Professor Geoffrev Barraclough, was very welcome. It confirms our feelings about the "myth" of a supposed Manor house called "HOLLINGSWORTH HALL" on the edge of the Macclesfield Woods, as Stewart's book styles it, in the pre-Conquest days! (See pages 38-40 of this volume.) Professor Barraclough is esteemed as an expert on this period and area in English History. This does not mean that we intend to desist from our probing into what may remain of records from that period, or even before the Conquest. But it does put a stamp of truth on the findings that we have already made and reported. Capt. Robert De Hollingeworthe of Hollingworth Hall was undoubtedly the perpetrator of the "myth" of an ancestry dating back to A.D. 1022. How Stewart came to get it and publish it is probably due to the following:

From <u>Dictionary of the Landed Gentry of Great Britain & Ireland</u>, by Burke, Volume I. (1846) page 583.

"HOLLINGWORTH OF HOLLINGWORTH... Hollingworth, Robert, Esq., of Hollingworth Hall, Co Chester, b. in 1791; late capt. in the 6th Dragoon-guards, now a magistrate for the counties of Chester, Derby, and Lancaster, and a deputy-lieutenant of the former.

LINEAGE:

"Antecedently to the Conquest, the ancestors of this most ancient family were seated on their manor of Hollingworth, in Cheshire, in the thich county as tell as in Nottinghamshire and Yorkshire, they possessed considerable estates. Matlev Hall and its township, which came into the family, temp HEN. VIII., by the marriage of John Hollynworthe, with Catha ine, dau. and heir of John Hewwood, Esq., remained with the Hollingworths to the time of the late JOHN HOLL-INGWORTH, Esq., of Hollingworth. That gentleman, who was the son of Jacob Hollingworth, Esq., by his wife, Mary Leigh, of Cranbrook, disposed of the estate of Hollingworth &c. to the ancestor of the Rev. Daniel Whittle, who sold back the property in 1831 to the present Capt. Hollingworth. By Mary, his wife, daughter of Rayner, Esq., of Bearsted, co Kent, he had a son, THOMAS-ROBERT HOLLINGWORTH, Esq., who m. in 1788, Mary, daughter and co-heiress of John Green, Esq., of Maidstone, and had a son, the present ROBERT HOLLINGWORTH, Esq., who purchased back in 1831 the estate of Hollingworth.

"ARMS - Az., on a bend, arg., three holly-leaves, vert.

"CREST - A stag, lodged, ppr.
"MOTTO - D. sce ferenda pati.

"SEAT - Hollingworth Hall, Cheshire."

The above was published probably before Capt. Hollingworth decided to change his name to De Hollingeworthe. The first part of the "lineage" above is, as we have said before, "pure balderdash," and it is hard to believe such a responsible man could foist such a myth. A beginning ancestor-hunter, finding this old book, eagerly "eats it up" because it sounds good. But it is a plain lie.

The way the motto, crest & arms are described is verbatim the way they are quoted by Stewart and by the 1884 Hollingsworth Memoranda book.

Thus we believe that Wm. B. Hollingsworth of Baltimore, Md., and Joseph Adger Stewart of Louisville, Kentucky, in their research, were taken in by the above lie and have unwittingly passed same on to "us." The REGISTER repudiates it all forthwith!

Those of you following this series will recognize the above man as the husband of Mrs. Newell Barron who gave the information to Mr. Alexander Knox (who published it in his History of Co. Down) about her descent from John Newell whose daughter Elizabeth married Henry Hollingsworth (or, Hollinworth) of Kinghill. Note that his child was styled "Pierse Barron-Newell," in accord with the tradition that the heir to Kinghill take the surname of Newell.

GRIFFITH'S PRIMARY VALUATION-HOLLINGSWORTHS IN COUNTY DOWN, IRELAND

Sir Richard Griffith was the man behind the original valuation of all Ireland, during the 1850-60 period. Valuations were printed in many books, divided by "Poor-Law Union" arrangement, and posted so that those who wanted to appeal the valuation of their lands, could examine them. Subsequent valuation books were manuscript only. The Primary Valuation reached Co Down about 1863. Below we present The Rathfryland Family's records, extracted from these books.

THE HOLLINGWORTH SCOUNDRELS!!!

25 Sept., 1644 To HENRY, Earl of Kent; OLIVER, Earl of Boling-broke; and the Commissioners of the Great Seal...

MARGARET HOLLINGWORTH, widow, formerly the wife of William Wells, and Charles Liddall and lately the wife of ARTHUR HOLLING-WORTH, citizen and upholder of London, complains: After the death of Liddall MARGARET had estate worth L2,000. and upwards. HOLLINGWORTH asked her to marry him stating that he had estate equal to hers,

whereas he had none. HOLLINGWORTH promised to secure to her four children L880., being part of MARGARET'S estate, to go to them at 21 years of age or at marriage. ROBERT & FRANCIS HOLLINGWORTH, brothers of ARTHUR, plotted to frustrate the settlement, and drew into the confederacy their kinsman, DANIEL HOLLINGWORTH. The confederates bought a yard in the parish of St. Mary Magdalen, Bermondsey from OLIVER CLOBERY & GEORGE FLETCHER, merchants of London by indenture of 28 May 12th year of Charles I. (1636/7) (SOURCE: Chancery Bills, Charles I., in the Public Record Office, Chancery Lane, London, Bundle H-33/28.)

Of course, this is the lady's allegation in court. The "Answers" to these allegations are not available to us. (The Answers use the spelling Hollinsworth.) The above family of Hollingworth was the pedigreed clan from Mottram which moved early to London and were in the Drapery business. Daniel Hollingworth died Feb. 5, 1661 (REGISTER, Vol. 1, p. 173) and was the son of THOMAS HOLLINGWORTH, (d. c1598) who was the son of JOHN HOLLINGWORTH of HOLLINGWORTH HALL in Co. Chester, Gent. Robert, Francis and Arthur Hollingworth, therefore, may be cousins (kinsmen) to Daniel, and grandsons of this same John. (Were they all really such conniving scoundrels?)

CAPTAIN HENRY HOLLINSWORTH

Henry Hollinsworth was born 31 January, 1788 "in the service," which probably means his father was serving in the British Army at that time. Henry himself entered the army at the age of 10½ years! (Unbelievable? Not in those times.) He held the rank of Private in the 20th Regiment of Foot (Infantry) as of 29 August, 1798 and served them in Holland in 1799 under Sr. R. Abercrombie & His Roval Highness the Duke of York. In 1801 the lad was serving in Egypt under Sir Byre Coote. As a Corporal in 1808 (at 20 years of age) he was at Vimiera under Sir A. Wellesley and at Corunna under Sir John Moore. Promoted Serjeant that year, he was at Walcheren under Earl of Chatham. In the year 1813 he served at Vittoria, Roncesvalles & in the Pyrenees

Possibly the most interesting part of this soldier's career, is the fact that, as Serjeant-Major in 1813-1814, Henry Hollinsworth served under Field Marshal the Duke of Wellington, entering France, and was at St. Helena, being one of the guards of Napoleon Bonaparte! After this, he served in India as Adjutant & Ensign, and Adjutant & Lieutenant ('Leftenant'). The above campaigns were the Battle of Maida, The Peninsula War and the Expedition to Walcheren in the Netherlands. He received the War Service Medal, 1793-1815, with nine clasps. He was admitted a Military Knight of Windsor, Lower Foundation, 10th Feb., 1852, delayed due to service in 2nd Regt. Yorkshire Militia overseas, until 2nd Nov., 1857. He died 14 Sept., 1865, ae 78 and was buried at St. George's Chapel, Windsor Castle. A long & honourable career!

He married, May 18th, 1815, at Mary le Bone, Old Church, London, ALICE RUTH PEARSON, who died at Bombay, India, 24 Feb., 1823. By her he had issue: HENRY ANDREW (8 Nov., 1817, Boyle, Co Roscommon, Ireland) and EMMA ANN, (b. 24 Feb., 1821 on the Island of St. Helena.) (SOURCE: Military Records, P.R.O. London, searched by Mrs. B. I. Pugh, May, 1967.) We believe he belongs to the Rathfryland Family.
