MEANING OF THE NAME

The surname Hollingworth is derived from a place in northeast Cheshire, of the same name, supposedly the place called "Holisurde" in the Domesday Book for Cheshire, and pronounced "Hollis-worth," but probably intended to be "Hollinworth." It is in the Parish of Mottrem-in-Longdendale, a few miles south of Manchester. It is possible that several separate families using this place as a surname came into existance at an early day. There are also two other places with this name in Lancashire north of Manchester. The Cheshire place was barren, and called waste at the time of Domesday (1086) and it was not until about the time of Magna Carta (1215) that we find any person using the name as a personal family name. This was "Tomas De Holinewurth" (here the name is transliterated into Latin) who was a signatory on a charter of about that period. The two Anglo-Saxon words, Holegn (or Holyn), a Holly bush, and Worp (or Worde) meaning an enclosure, or farmstead, are said to be the origin of the name for this place now called Hollingworth in Cheshire, or, "A farm (homestead) enclosed by holly bushes," or simply "Holly Farm." In later centuries a medial "s" came to be used by some of the families, but not as a general rule earlier than 1620. There are now five generally used forms: Hollingsworth, Hollinsworth, Hollingworth, Hollinworth and Hollandsworth. These are regularly found in the indexes to vital records from 1837 at St. Catherine's House, London, and in most telephone or city directories for large cities in England and America.

INTENT OF THIS QUARTERLY

Hollingsworth Register is now entering its eleventh year of publication. It started in April, 1965, and its purpose remains as it was at that time: To publish verbatim copies or abstracts of records of the family world wide from the earliest times to the present day. Nearly every name of our family from the U.S. Census, 1790 through 1860, has been published here. About 1,700,000 pages of census were scoured to produce that result. We think no other family has thus been served.

HOLLINGSWORTHS IN SCOTLAND - PART I.

The Partick Family

North Britain was an old term used to designate Scotland. So far, we have discovered no family of our surname who made a permanent settlement there prior to the Nineteenth Century. This article concentrates upon the one which is still represented today in the city of Glasgow, the ancestors of whom came there over 130 years ago.

We do not know the Christian name of the first Hollingsworth - or Hollinsworth - in the small village of Partick, Lanarkshire. He was dead before the earliest census (1841) and we couldn't locate a death record in that area. The Christian name of his wife was Cathrine. The family settled in Partick after their voungest child, Elleanor, was born (c1828). That child was born in Scotland but not in Partick as shown by the following census:

(*Ages of adults were rounded off: 20-25; 25-30. Cathrine, Ann and James' ages were not exact.)

It is James Hollingsworth, born about 1818, in England, who must be credited as "Progenitor" of the now known family, until the name of his father can be established. He was the only son. The Above census tends to show that the father came from England, but might have been born in Scotland, married Cathrine, a native of Scotland, in Scotland, before 1816, had child Ann there, and moved to England before 1818, remained there until about 1826, came back into Scotland (but not into Lanarkshire) before 1828, and on to Partick before 1841. We haven't made any searches to determine the life histories of any of the daughters.

James Hollingsworth remained in Partick until his death, which occurred after 1871. His grandchildren live in Glasgow today. We did not examine the 1881 or 1891 Census Schedules. In order to illustrate the contents of the British and Scottish Census Schedules, let's show the family of James Hollingsworth in 1851, 1861 and 1871.

The son, James Hollinsworth, Junior, now lived at his own address. He was born about 1848, and married Janet Campbell on July 16, 1869, at the Domanhill United Presbyterian Church, Partick, Mr. Thomas M. Lawrie, Minister. Janet was aged 20, and a daughter of George and Jane (Dalglish) Campbell, Crown Place, Partick. The marriage record shows that the names of James Hollinsworth's parents were James and Isabella (McKean) Hollinsworth, 55 Orchard Street, Partick. Here is the schedule:

The names of the other children, except one, are not known. Another James, the third, was born to the above couple, on August 29, 1872, the third child. He was bartized the following November 21st in St. Andrews Church, Glasgow, by Dr. J. F. S. Gordon, D.D. The birth record gives his father's middle name as "Phemfry," and his own as "Pemfry." This is a puzzle to those of the present generation, who still bear this name! Members of the family were contacted. On Feb. 28, 1966, Mr. James Hemphrey Hollinsworth, 9 Prince Albert Road, Glasgow, W. 2, Scotland, penned us a fine answer. He explained to us that his father's middle name was, contrary to the "birth lines," actually the same as his own, "Hemphrey." He kindly turned copies of our letter over to two of his relatives, one of whom is also named James Hemphrey Hollinsworth, of 55 Bowden Drive, Glasgow S.W. 2! (Yes, the name surely runs in this family!)

An interesting sidelight should be told: This last named James H. Hollinsworth works for the DAILY RECORD in Glasgow, and there is a Mr. Michael Hollinsworth on the same staff, who hails from Arklow, County Wicklow, Ireland: Except for Mike's Irish Brogue, these two men

could easily be mistaken for brothers, both of them having blue eves and dark wavy hair, just like James H. Hollinsworth's father (John Gilmour Hollinsworth) and his grandfather, James Phemfry Hollinsworth. Blue eves and dark hair, but with sometimes a reddish hue, were characteristic of the Hollingsworths of south Ireland. Mr. Michael Hollinsworth is a cousin of the editor, a member of the growing clan of Roman Catholic Hollingsworth families in Ireland.

THE HOLLINGSWORTHS AND PROCTER & GAMBLE OR: Frederick Hollingsworth's Sojourn in Cincinnati

I knew nothing about the contents of this article when I published the March, 1968, HR. It shows how much might come to light in so short a time, while in contrast, one may wait a lifetime just to secure one scrap of information on another avenue of research.

When Thomas Hollingsworth left his home in Ireland and set sail for America, little did he dream that in less than ten years he would become personally acquainted with one of the first American Millionaires, Nicholas Longworth, and with the founder of one of the largest and most successful corporations in history, James Gamble. Thomas Hollingsworth was, I think, vet another brother of my ancestor, Frederick Hollingsworth, and a son of Samuel & Anne (Earl) Hollingsworth of Ballinakill. He was born between 1794-1800, one of the older children in a supposed family of ten. ("Supposed," is right! pretty good records on these ten, as individuals; but almost nothing to connect them with each other or to Sam and Anne except genealogical inuendoes which constantly substantiate my theory!) Thomas died about Nov. 21, 1842, in Hamilton County, near Cincinnati, Ohio. came to Cincinnati about 1818. He as originally laid to rest in the old Methodist Episcopal Churchyard, which later was torn up, his body now resting in the Weslevan Cemetery, Cincinnati.

Thomas came to New York, or perhaps Philadelphia, thence across the continent to Pittsburgh, and from there down the Ohio River on a flatboat. I don't have this history written up for me in any family documents; I am only judging by the general pattern of immigration in the early days. The first Cincinnati Directory (1819) shows he lived on Walnut Street between Second and Third Streets, occupation Soapboiler and Tallow Chandler. (Page 124, Farnsworth's Directory.) The 1825 Harvey Hall Directory, p. 50, lists him in same occupation, nativity Ireland, at the corner of Race & Greene Streets. (HR Vol. 4, p. 10.) Up until this year, I had only this small item as a clue to the man's origins, but could only wonder who he was until films of the Hamilton County Deeds were made available for research purposes.

The 1829 Robinson & Fairbanks Directory of Cincinnati, page 63, lists Thomas at same address "Race between 2nd and Third" with a "Candle Factory." This is the last time the name appears. The 1830 directory is missing. He had purchased the lots at this address in October, 1819 from Nicholas Longworth. (See page 51, Deed No. 3.) There are seven deeds or mortgages between these men listed in the Hamilton County books. (NOTE: 71 of the deed books suffered deliberate destruction by fire during the riot of 1884 and I don't know if an index to these thousands of lost instruments exists.) Longworth was not just the great grandfather of the Nicholas Longworth who married Alice Roosevelt, he was famous in his own right as the first mid-western millionaire. I verified this by checking his census in the 1850 schedules. There, he is disted as having "no occupation," but owning real estate valued at Two Million Dollars!

George Gamble, whose home in the north of Ireland was the town-land called Graan, in the Parish of Devenish and Barony of Magherabov, County Fermanagh, brought his wife and children to Cincinnati in 1819. His reason for emigration was the bad state of finance in Europe and the British Isles after the Napoleonic Wars. He was on his way by flatboat to Shawnee Town, Illinois, when his young son, James, became very ill, and George got off at Cincinnati and never went any further. James recovered and his father went into the nursery business near the Corporation line of Cincinnati, and made a success of it until his death in 1843, a few months after Thomas Hollingsworth's death.

James Gamble was his father's oldest son. Soon after arrival, he became apprentice to Mr. William Bell, who also ran a soap and candle factory. Not long after that James worked for Thomas Hollingsworth. Before 1830 he was at work for himself. He married, in 1833, Elizabeth Ann Norris, daughter of Alexander Norris, who also came from Co Fermanach, and who was probably related to James Gamble's mother, whose maiden name was Mary Norris. Another daughter of Alexander Norris, namely, Olivia, married Mr. William Procter, fresh from England. Mr. Procter was a candle maker. Norris suggested that his new sons-in-law go into partnership. Thus was born "Procter and Gamble Company," in 1837.

Thomas Hollingsworth's wife was named Lucy. I think she was related to the Gambles. When Thomas died, it was James Gamble who ordered his burial. They all worshipped at the Methodist Church. James acted as Trustee for Lucy and her son, William H. Hollingsworth. (See page 53.) On one of the deeds between Lucy and son William, the witnesses who signed were Elizabeth Ann Gamble and Olivia Procter! All this suggests a close relationship.

Now, how does my Frederick Hollingsworth fit in? As you know, he arrived in New York on 20 July, 1829. I have found that he made his ay directly to Cincinnati. I am sure that it is the family of Thomas Hollingsworth who appears in the 1830 census, 4th Ward, erroneously listed as "B. Hollingsworth" (I have found no evidence of any person ever living in Cincinnati who bore this initial.) Thomas would be the man aged 30-40, Lucy as the woman aged 20-30, and William H., the son, the male child aged 5-10. A female listed 10-15 cannot be accounted for. But there is also "I male aged 20-30," as well as "I alien, foreigner nor naturalized." This is not Thomas, for he was not listed as an alien in the 1820 census. (HR Vol. 2 page 114 Ohio No. 5.)

Frederick Hollingsworth purchased 53 acres of land adjoining the farm of Thomas Hollingsworth in Sycamore Township, just northeast of Cincinnati. It seems that Thomas retired from the soap-making business about 1831 to live on his farm. Frederick made his purchase - from Thomas - on 28 March, 1831. You will also remember that Frederick bought 75 acres in Tate township, Clermont County, from Thomas Kidd on 16 May of same year, only to sell it on 15 September to Matthias Edwards. (I found that Edwards' wife was Mary Kidd, a sister of Thomas Kidd!) Frederick Hollingsworth sold his property in Sycamore township, Hamilton County, on March 1, 1832. (See page 52, Nos. 11 & 12.) Whether he immediately left that area is a matter of conjecture. The men to whom he sold, Campbell and James Johnston, who were merchants of Cincinnati and natives of Ireland, (proved by City Directories cited above.) may have been related to the Hollingsworths. (HR Vol. 4, pages 1-5.) Thus ends the narrative of my ancestor's brief stay in the Queen City.

Lucy Hollingsworth remarried Zachariah Connell, May 7, 1846, in Warren County, Ohio (Marriage Book 2 page 298.) Thereafter, this couple sold their Race and Greene Streets houses, lots and soap factory, to James Gamble, and removed to Lancaster, in Fairfield County. I haven't found the Connells in any census. William H. Hollingsworth, the son, studied medicine and became an M.D. With Fisher W. Ames, another physician, he visited Sacramento, California, in 1850, and stayed there about two years. He was enumerated twice, first with his wife Susanna, in Union township, Butler County, Ohio, and also in Sacramento. Fisher Ames was also duplicated, in Sacramento as well as with his father, Daniel Ames, a wealthy soap and candle manufacturer, in Cincinnati. (HR Vol. 4, p. 35.) I do not know what became of Dr. William H. Hollingsworth after that.

When Edward T. Hollingsworth came from Ballinakill and settled in Cincinnati in 1849, later marrying Susannah Kidd his cousin, he named two of his ten children Lucy and William H. Hollingsworth - seemingly after the above relatives! (See HR Vol. 4 pp. 6,7.) Mrs. Veo White of Nebraska, in her letter of April 2º, 1968, recalls that her father, Edward Lee Hollingsworth, "had a chance to buy into the Procter & Gamble Company," which seems to suggest a relationship. The Edward Hollingsworths of Cincinnati were friends of the Alphonso & Peter Tafts, Parents & grandparents of the late President of the United States, William Howard Taft, and grandparents of the late Bob Taft, Senator from Ohio! Edward Hollingsworth's sister Eliza Johnston had a son named Samuel Howard Johnston (HR Vol. 4 p. 3.) I wonder if President Taft's middle name is the same as the two William H. Hollingsworths?

Before concluding, I must remark about James Gamble's exemplary life as a great Methodist Layman and totally honest businessman. When he died in 1891, he left a lasting legacy to his heirs. May I also say What a fine teacher Thomas Hollingsworth was, but especially what a remarkable apprentice James Gamble was! I cannot help but wonder: If Thomas had been a bad teacher, would the world have seen Ivory Soap, Ivory Flakes, Oxydol, Chipso, Duz, Lava Soap, Drene Shampoo, Camay, Cheer, Gleem Toothpaste, Dreft, Dash, Gain, Crisco Shortening, "Ice-Blue Secret Deodorant," Spic and Span, Crest Toothpaste, Tide, Bold, Salvo, Cinch, Top Job, Joy, Comet Cleanser, Downy Softener & Mr. Clean, and of course - good ol' tallow candles and hard laundry soap?

THE AGAR RELATIONSHIP

Wouldn't you think that time and circumstance would turn their smiles upon us mortals early, instead of late, just once in a while? With this Agar family relationship, it was late - as usual! Here is a brief explanation.

In 1961 we obtained the list of Hollin(g) sworth entries in the Index to Ossory, Ferns & Leighlin Diocesan Marriage-Licence Bonds. An entry read: "HOLLINGSWORTH, MARY, & JOHN AGAR 1828." (HR Vol. 1, p. 70.) Now, as some of you American readers know, there is a Hollywood actor, John Agar. This is his right name, and he at one time was married to Shirley Temple, that beloved child star. When this writer took a close look at Mr. Agar, in a number of his movies, he was at once startled by the likeness (in this opinion) of Mr. Agar, for Frederick Hollingsworth, who died nearly 100 years ago. It was also discovered that a John Agar, and his brother, Luke, settled in Cherry Valley, Illinois, a mile or so from Frederick Hollingsworth! was in 1962 and it precipitated a several year hunt-down of all of the descendants of these men to learn if their parents were the John & Mary Agar of Ireland. These two men, of course, were born in Ireland, in the 1830 period. Indeed, all of the living progeny of these men were at length contacted. But not ONE source could verify the names of any one of their parents or a clue to a Hollingsworth connexion! We wrote to all of the Rectors of the Church of Ireland in the county of Carlow - whence it had been deduced, these men wriginated. But nay! It could neither be proved nor disproved. (These two, by the way, changed their name to AGER, for some unaccountable reason or whim.) After three years, we threw up our hands in defeat. (Wouldn't vou?) We did find some Lukes and some Johns, and did find a Luke and a John born to same courle, but ages were 'way, 'way off - too far off to be certain.

Much later - in 1966 - we contacted once more, the rector of Dun leckney, Co Carlow, the parish which encompasses the town of Bagenalstown. We ordered a blanket search of all the Agar baptisms from 1820 through 1840 and then we did find the right couple. (We should explain, that it was a five year wait until we could get a cooperative clergyman at Ballycanew to issue us a certificate of the marriage, which showed that John Agar was "of the Parish of Bagenalstown, Co Carlow." You will see in HR Vol. 1, page 71, marriage # 16, that we did not know in 1965, the parish of his origin.) The other rector had refused to answer our letters and denied our cousin in Ireland the privilege of a visit to the church! (Christian gentleman?) The present rector, unfortunately, is of the same ilk, having taken our money a year and a half ago and failed to issue us any of the certificates we asked for.

It can be seen that your editor had been so busy trying to prove that the Cherry Valley Agars were nephews of our Frederick Hollings-worth, that we never seemed to bother to look for children of "John & Mary Agar." No: in case you wonder - the John and Luke Agar of Cherry Valley, Illinois, were not his nephews! (This isn't saving that they weren't nephews of John Agar, sent to that location on the recommendation of him, which is likely how it happened.) No, although they had a son John, they had no Luke whose baptism could be found. Besides, we now know their son John couldn't be the Cherry Valley man.

Here are records from this family which we obtained:

- (1) "JOHN AGAR of the Parish of Bagnalstown & MARY HOLLINGSWORTH of the Parish of Ballycanew were married in this church by Licence this the 25th day of November 1828, by me, Hawtry White Browne, Rector." (Ballycanew Parish Church, Co Wexford witnesses names not given.)
- (2) Baptisms from the Registers of Dunlecknev (Bagenalstown) Parish, County Carlow:
 - a. SAMUEL, son of JOHN & MARY AGAR, born Nov. 1, baptized Nov. 26, 1829, by James T.C. Saunders. (Page 18, No. 189.)
 - b. WILLIAM, son of do. Born July 19, Bap. Aug. 5,1831. (22-226.)
 - c. FREDERICK, son of do. B. Dec. 6, 1833; Bap. Jan. 6, 1834. (27-276)
 - d. JOHN, son of "JOHN (& MARY) AGAR, Bagenalstown, Grocer," born Oct. 3, 1838, bpt Jan. 20, 1839. (New Register p. 4, #25.)
- (3) Burial of JOHN AGAR, aged 45 years, of Bagenalstown, Sep. 30,1845.
- (4) Index to the Prerogative Wills, Ireland, 1811-1858, Public Record Office, Dublin: AGAR, JOHN, Proved 1846.

Just the other day in the library, talking to another professional, discussing books like "Who's Who" and their use in genealogy, it popped into our mind that John Agar, the actor is the son of John George Agar, a Chicago Meat Packer! Hurrying to the book room, we leafed through all the books and then struck gold - right under our nose all these years:-

From The Book of Chicagoans, Ed. by John W. Leonard, of Who's Who in America, Chicago, A.N. Marquis & Co., 1905 edition, p. 16 -

AGAR, JAMES SCANLON, packer; b. Chicago May 17, 1864, s John & Ellen (Scanlon) Agar; ed. Lincoln (public) School, 6hi., to 1878; m. Chi. Sept. 15, 1887, Minnie A. Dye; children: Eleanor, Ruth, John, Louise, Kathryn. After leaving school was for five years in employ of the National Bank of Ills. In 1885 formed firm of Agar Brothers (with William G. Agar) and engaged as wholesale dealers in meats until 1899, when consolidated with Agar-Marshall Packing Co. under style of AGAR PACKING CO., of which has since been vice-pres. & treasurer. Pres. of Meat Dealers' Assn. of Chicago. Republican, Club: Chicago Athletic. Office: 70-72 N. Green St. Res: River Forest, Illinois.

AGAR, JOHN, packer: b. Carlow Co., Ireland, Oct. 3, 1838; s. John & Mary (HOLLINGSWORTH) Agar; educated by private tutor; m. in Ireland 1862, Ellen Scanlon: children: James S., William G., Woodbury S., John T., Ellen. Established in 1869 as a pork packer & sausage manufacturer, and has so continued, now being pres. of The Agar Packing Co., with plants at Chicago, Des Moines, Iowa, and Memphis, Tenn. Republican. Baptist. Club: North Shore. Office: 70-72 N. Green. Res. 630 Cleveland Avenue. (See p. 32, 16th Ward, Chicago, 1870 Census.)

So far, our letters to the Agar Packing Company have not been answered. William Agar, born July 19, 1831, came to New Orleans and was a wealthy sugar manufacturer. He died June 23, 1915 aged 84. He m. Theresa Price and their son, John Giraud Agar did make "Who's Who in America," and "Who's Who in New York." (Born 1856; died 1935.) The latter has two sons - Herbert Sebastian Agar of England, and William M. Agar of New York, (co-founders of Freedom House, etc. etc.) Great literary giants, but they cannot tell this writer about their grandfather, or the Hollingsworth connection! (Who's Who in America; Current Biography, 1944, 1949; Who's Who; Leslie's History of the Greater New York, etc.) We hope our luck will change soon!

This is a classic example of how not to do genealogy. Let it be a lesson. Or would another hackneved cliche, Better late than never, be more appropriate?

EDWARD T. HOLLINGSWORTH - ADDITION

Adverting to our article on page 5, the following additional information was obtained: The son and last survivor, WILLIAM H. HOLL-INGSWORTH, died in Apr. 1948, 1913 NW 1st Terr. Miami, Florida, ae 86. His wife ANNA ROBBINS died Feb. 9, 1946 at the same place, aged 84. They had no issue. Both are buried in Lot 39, Section 3, Highland Lawn Cemetery, Terre Haute, Indiana. He left no will. His wife wrote out hers in longhand. It is an interesting one which we will publish in a later issue. But the Family Record, said to have belonged to William H. Hollingsworth, as last heir, has never been found!

Extracts of Hollingsworth Deeds (PART ONE)

The Hamilton County Courthouse has had its share of fires and then some, three to be exact. The last one was deliberately set by arsonists in 1884 during a great riot. Thousands of records of priceless value were lost at the hands of these worthless trash, who offered no replacement, leaving the honest and peaceful citizens to pick up after them. It reminds one of the similar experiences we have had in the last few years, and we wish - just once - that the authorities over our society would repay the just "eve for eve" revenge and crush these people utterly and ruthlessly and stamp them quite out of existence! But to return to genealogy: Seventy-one (71) of the deed books were thusly consigned to the flames. Remarkably, many were saved or re-recorded through the cooperation of interested and law-abiding persons who brought their original records to court for recopying.

IRISH REBELLION OF 1798

Our Wexford County Hollingsworths all passed through that terrible trouble which began on 23 May, 1798 - just 170 years ago to the day on which this article is being typed. All the old Episcopal families in the south of Ireland have their traditions about that catastrophe, many so muddled as to be historically worthless, others accurate to the name and incident. The sinister political and religious elements involved in that affair produced a very far more horrible result than all of the American black riots we have vet seen combined. In fact, that rebellion would make a "Watts Riot" look like an afternoon children's tea party. It just came to our attention the feelings which were suppressed for generations afterward, when we had a discussion with one of our cousins, whose father was born at Ballycanew, County Wexford, and who was a Hollingsworth. We are not at liberty to give out the name of our informant, but the Irish born gentleman was named William Samuel Hollingsworth, born probably at Ballinakill, son of William and Eliza (Jones) Hollingsworth. When our informant was a young lass, her father was quite strict, but with a touch of tenderness toward all his children. But at one time she became acquainted (in Canada) with a young, handsome Roman Catholic chap. When William S. Hollingsworth learned of this, he took his child aside and asked her not to see the fellow again. When she honestly asked why, he said it was nothing against him, except his religion! She was even the more surprised at this, and then he told her, in the most serious voice, "Dear, I don't want you ever to tell this to anybody, but your great-great-grandfather was burnt at the stake by the Roman Catholics just because he refused to abandon and renounce the Protestant faith." She has only told this to us in confidence. Of course, it really is not so much of a precious secret as all that. But it was to W.S. Hollingsworth! In discussing this, it was brought out that he never said whether the murdered man was a Hollingsworth. It probably wasn't. But several persons named Jones were killed, one of them in the Vinegar Hill affair in June, 1798. Also Henry Johnston of Ballynastraw, the ancestor of the Johnstons of Tomagaddy, who died 27 May 1798.

It occurred to us that it has been very difficult for us to get any concrete information about our Hollingsworth family in connexion with the Wexford Rising of 1798, even from those cousins still living almost on the very site of the event. Could it be that it is to them, as it was to Wm. S. Hollingsworth, a thing to be forgotten?

FREDERICK HOLLINGSWORTH FAMILY - GENERATION THREE - CONTINUED ANNA ELIZABETH (HOLLINGSWORTH) BELDEN

ANNA HOLLINGSWORTH was the seventh child and fourth daughter of Edward² & Rachel (McFadden) Hollingsworth. She was born June 18, 1875 near Kellogg, Jasper County, Iowa: died Mar. 19, 1961, Menlo Park, San Mateo Co., California; aged 85 years, 8 months, 1 day. She is buried in Inglewood Park Cemetery, Los Angeles County, California.

She first married, August 21, 1901, Los Angeles, JOSEPH EDWARD VEZINO, known also as "VEZINO de VEZINO," parents unknown, who was born in 1860 in France; died in California about 1940 aged 80.

She married lastly, June 21, 1917, at Santa Ana, Orange Co., California, HENRY WILLARD BELDEN, son of William Henry & Laura (Day) Belden, natives of Ohio. He was born Jan. 19, 1868 (headstone) at Warren, Trumbull Co., Ohio; died Dec. 28, 1941 at 2:55 P.M. in Los Anæles, aged 72 years, 11 months, 9 days. Buried beside his wife. No issue by either marriage. One son born before first marriage. See below.

Anna was the smallest of the family. She was scarcely over five feet tall. She was very beautiful. She always was affectionately called "Aunt Annie" by those who loved her. It was she alone, out of all her generation, who began to write her memoirs and collect some of the family history, which fell like a mantle on the willing shoulders of this writer. But her venture began too late in her life to bring to us the facts which now, perhaps, never shall be known, about her grandfather's father in Ireland, the "Irish Rebellion," and all the curious legends which were handed down. She was in her mid seventies when she began to collect data, but soon was confined to a rest home. Her physical and mental state then finally deteriorated and she lost the will to continue, much to our sorrow. Her memoirs are in our possession, half written. She opens with her birth facts. and continues saving she was born in a "sod shanty" near Kellogg, Whether this is fact or fancy we don't know. Her father was a house builder, cabinet maker and contractor, painter and paperhanger. With his large family, we imagine he could build a good frame house as easy as piling up sod! Before she was very old - in about 1877 -Ed ard Hollingsworth gave up his saloon in Kellogg, and his rented farm, and moved to Waseca, in southern Minnesota, probably to build houses. Annie remembered living in a house by the railroad tracks, and she also recollected her brother Freddie using their father's tools. He was making himself a shoe-shine kit. As quickly as he was finished with one of the implements, he would hurry to hang it in its proper rack! Such was the strictness of Dad Hollingsworth, which made dignified men and women out of his children! (A lesson which should be hung around the necks of the disobedient brats who are running wild in our century!)

As told before, Edward & Rachel Hollingsworth parted company in 1880 after the birth of their ninth child. Little Annie remembered meeting her father's mother, Elizabeth Hollingsworth, coming to visit from Kellogg, Iora. "A clean and neat little lady," was Annie's description. She took sister Lucy back to live with her. Rachel had lost her temper and beaten Lucy one day, and Edward decided she had better go to Iowa. Not long after, Nettie May and little Annie also

moved to be with Grandmother Hollingsworth a while. Although Nettie soon went back to cold Minnesota to be with her mother and her mother's parents, William and Anna (Peterson) McFadden at Woodville, Annie remained in Iowa until 1884. She got to remember her father's brother "Uncle Jake" Hollingsworth, and also Uncle Wallace Hollingsworth who ran a music and drug store in Kellogg.

Edward E. Hollingsworth divorced his wife Rachel 12 November, 1880 in Waseca, Minnesota. (Register of Actions, Book B, p. 32; file Number 1401 County District Court.) Annie was never aware that her parents actually divorced; she always said that they merely separated. Now the story Annie tells about her adoption, can be added here. The burden of a large family was too much on Edward alone.

Near the Jacob Hollingsworth farm just outside of Grinnell, Iowa, leved the Hoovers - Samuel and Sarah. These folks came from Ashland County, in northern Ohio. Sam Hoover had worked for Sarah's parents, Jacob and Sarah (Springer) Figley, and in late life he married her, and they removed to Iowa. Jacob E. Hollingsworth, who lived to be 94 and with whom this writer corresponded, confirms Aunt Anna's story. Samuel Hoover, of whom we own a nice picture taken in Davenport, Iowa, in the 1870's, was at work in his field one day when he suffered an attack of "spinal fever," and his hired hands carried him to the house where he died. (Soinal fever might have been apoplexy, a stroke from a cerebral hemmorhage.) As Sam and Sarah had no children, this left Widow Hoover all alone. One day she was at Jacob Hollingsworth's farm, and, by coincidence, little Anna was there. Sarah picked her up tenderly and squeezed her to her breast, saving 'I wish you were my little girl.' It seems that she went farther than just wishing: for the Adoption papers are on file at Newton, Iowa, at Book 126, p. 606, under date of March 10, 1884. The Articles recite that Edward and Rachel were husband and wife, June 18, 1875, and living at Kellog, when Anna was born, and that the divorce took place as we have described it (this paper led us to find the divorce papers) and the final paragraph reads:

"WHEREAS, E.E. Hollingsworth desires to give said child Annie E. Hollingsworth to Sarah Hoover of Jasner County for the purpose of adoption as her own child...The child shall hereafter be known as Annie E. Hoover..." And so her name was legally changed and soon her new mother took her back to Ohio. She staved there, at Mansfield, in Richland County, for about ten years.

During her stay there, she wasn't under her father's watchful eye, and had a love affair with an unknown young fellow she used to refer to as "Frank Hoover," who, she said, was related to her adoptive mother. She gave birth to her only child, and named him Franklin Ross Hoover.

Her adoptive mother wished Annie to not forget her real parents, who by then had moved to Los Angeles, California. She went out to visit them, and stayed, only returning when Sarah became ill and died in 1901. Anna brought little Frank with her.

When she married Mr. Vezino she went with him almost directly to live in San Francisco. He was a barber. This marriage was indeed an unhappy one. But a far more terrible experience was to befall her in the city by the bay! On an early morning the whole city began to

tremble and chatter. Buildings fell; gas and watermains exploded: a general panic ensued, and a fire started such as has never been erased from the minds of those who saw it all take place. As so many did. Anna Vezino escaped actual injury. Plucky and industrious, she immediately volunteered in one of the hastily set up emergency food stations. She fed hundreds, maybe thousands of destitute people in food lines, until a semblance of order had been restored. Ironically the place where all this feeding and life-sustaining ministration took place was an old cemetery on the outskirts of San Francisco! Yes, all this in the spring of 1906 was too much for Anna, who then hurriedly returned to Los Angeles. Her father and sister Nettie and her favourite brother Frederick were dead. Her mother overated a rooming house in Los Angeles. Anna once more became a dressmaker to feed herself and her son. Shortly she met Hanry W. Balden. a fine man, and it may be said that her life with him - nearly 25 years - was a happy one. He worked for many years for the Los Angeles Department of Public Works. For a few years the couple lived at Trona, California, while Henry did some hauling for the mining companies operating there; but the climate was much too hot.

The last home they made together was at 333 West 120th Street in the southwestern part of the city of Los Angeles, which is now inhabited by Negroes and is only a few blocks from the centre of the Watts Riot of 1965. It was a lovely little house surrounded by a fence of white palings, and with lattice work all around. This writer first saw Aunt Annie Belden there. But soon Henry died, and the memories were too much for her; so she returned to live with her beloved son Frank Hoover in San Francisco. She remained there the rest of her life. Frank's wife Rose died after a long illness, and so Anna lived with him once more. In her early seventies they took several long drives across the United States, and into southern California. She really enjoyed life.

She broke her hip, as so many of our beloved older folks do -be-cause they are doing something unselfish for the younger ones, usually. Being confined to a nursing home and the painful circumstances, a change came over her. Though she returned home a while, more broken bones sent her away again, and she never was able to go home again. This writer visited her at Millbrae, California, in the rest home, on Feb. 27, 1960, taking copious notes about all of the recollections she spoke of. So many of her stories were absolutely accurate, after a period of nearly seventy-five years in some instances, that this writer used her memories as a proper basis for searching up public records. In most cases he was able to verify Anna's tales completely.

Anna Elizabeth Hollingsworth Belden was named after her two grandmothers - Elizabeth (Brown) Hollingsworth and Anna (Peterson) McFadden. She will never be forgotten. Sleep well, Aunt Annie.

ISSUE: FRANKLIN ROSS HOOVER4 born Nov. 16, 1891, Mansfield, Richland County, Ohio; died May 22, 1961, in Menlo Park, California, after a fall from his room in the upstairs of a rest home, to the sideralk below. Buried in the Italian Cemetery, Colma, San Mateo Co., California. Aged 69 years, 6 months, 6 days. Married, Mar. 7, 1914, San Francisco, Mrs. ROSE AURELLIA (DeMATTEI) ORCHETTI, a widow, daughter of Giambartiste and Svlvia (Devincenti) De Mattei, natives of Italy. She was born Nov. 13, 1893; died June 26, 1940, both events in San Francisco. Buried with husband. A beautiful ladv.

Her untimely death shocked the family. Frank Hoover did not remarry. He followed the trade of interior decoration all of his life, in later years making quite a financial success. He was foreman, and then supervisor, in the decoration and maintenance of large office buildings in the bay area. But his mother's and his own illness in the late 1950's made heavy inroads into his savings, though he was not totally destitute at the time of his death. It is unfortunate that there were no children to carry on this branch of the family. Anna E. Belden was the only member of her own family (as far as we know) who had a mind to collect family history or make a genealogical record.

"THE WAR IN WEXFORD"

Wheeler and Broadley wrote an account of the Irish Rebellion of 23 May, 1798, giving it the above title. On page 290, mention of a member of our family is made. Thanks to James E. Godkin, Brockville, Ontario, we quote:

"Every non commissioned Officer to see that those men under his immediate command come to Parade clean and fully accourred, under the penalty of two Days pay which shall be stopped from the Private, in case it appears that sd Private refused to comply with such orders from his superior.

"Ordered by Command of General Taylor, that NICHOLAS HOLLINWORTH and Benjamin Jackaberry (sic - Tackaberry-Ed.) and Robert Lee be dismissed from the Camolin (Yeomanry - Ed.) Cavalry for Neglect of Duty, and that they be required to deliver up all their appointments under the Penalty of ten pounds, pursuant to the Yeomanry Act - Mt. Norris, Cartain of the Camolin Legion, May 1st, 1799. Headquarters, Camolin."

The above Nicholas Hollin(gs)worth was probably the man who lived on Townland Ballycanew. He died in 1826 and was buried January 20, of that year, aged 64. His wife's name was Mary, who is probably the Mary Hollingsworth, aged 73, buried on Oct. 26, 1835. They had at least three children, Harriett (born 1799), Samuel (1801) and Thomas (1804). Mary, as widow of Nicholas, is possibly the "Mrs." Hollingsworth who held 53 acres, 3 roods, 7 perches of second quality land in Townland Ballycanew as shown by the 1833 Tithe Composition Applotments. Harriet Hollingsworth the daughter also had a small plot of ground amounting to 12 perches. (HR Vol. 1, pp. 71, 73; Vol. 2 pp. 36, 73.) It is believed that Harriet married Thomas Earl, March 9, 1836, at Ballycanew Church (HR Vol. 1 p. 71) and that Samuel the son born in 1801 settled in Prescott, Ontario, Canada, and Thomas in Carlton Place, Ontario, both men being ancestors of large families. (HR Vol. 1, pp. 174-176; Vol. 3, pp. 77-81.)

ALL OF US FROM ADAM!

Let HOLLINGSWORTH REGISTER here go on record that all human lineage pedigrees end up in Adam! The line from Adam through Noah, a space of ten generations, belongs to us all, Noah being also the common ancestor of all the families on earth today. We reject, as well as publicly condamn as "hogwash," any theory which would say that Adam was only the "ancestor of the Hebrews." This theory is advanced by those who wish to straddle the fence of compromise between the erroneous teachings of the late and unlamented Charles Darwin and his gang of fanatic followers, and the family history of mankind as preserved in the ancient Hebrew Scriptures. In rejecting evolutionary anthropology and the false foundation upon which it was erected, namely, uniformitarian geology, let us recommend the reading of the volume, "The Genesis Flood," by Morris & Whitcomb (1961) and "The Deluge Story in Stone," (1931) as primary study. For a serious student, we recommend a deep research in the early chapters of the bible book called Genesis, and the Book of Jubilees, which is an expanded version of Genesis. The latter work is considered by some to be spurious, but is generally accepted as a targum or explanatory expansion of the early history of mankind. It was evidently written in the form now available in libraries in the translation by Dr. R. H. Charles, about the period 105-135 B.C.

The Genesis account traces the lineage from Noah through his three sons, Shem, Ham & Japheth. From these three all of the people on earth descend. It is highly probable, due to intermarriage in the earliest generations, before the dispersion at the Tower of Babel, that modern man descends from all three of these children of the great Patriarch.

The ancient British Isles were inhabited by immediate descendants of Noah - great grandsons, according to the manuscripts of Irish and British antiquity which John O'Hart published in his "Irish Pedigrees." The 'stem of the Irish nation,' according to that work, is rooted in Magog, the son of Japheth, son of Noah. We should cau-

tion the reader that the present authorities (whoever they are) are not at all enthusiastic about accepting this connection! It is hard to tell whether it is their modernist antipathy for anything smacking of Creationism, which might even bring them to reject the truth unsweetened, in favour of honey-smeared lies, or an honest attempt to test all the theories before accepting any.

The Book of Jubilees is the only work we can find in print, that gives the names of the wives of all the patriarchs. We will reproduce them here, because they are 'ours , the Hollingsworths, too:

- 1. ADAM, the son of God, was married to Eve. (According to Josephus this couple had 56 children, 33 sons and 23 daughters.) The named children in "Jubilees" are Cain, Abel (murdered by Cain), Seth (of whom further), sons, and Awan and Azura, daughters. Cain married his sister Awan: Seth took Azura his sister as his wife. Adam died at age 930: Cain violently killed thereafter.
- 2. SETH, born when Adam was 230 years old. (We are consulting the Greek "Septuagint" translation of Genesis for these figures. 100 more years to this figure.) By Azura, his sister & wife, Enos and Noam were two of his offspring.
- 3. ENOS or ENOSH. Born when Seth was 205 years old. Married his sister Noam. Their children: Kenan, Mualeleth & Barakiel.
- 4. KENAN. Born when Enos was 190 years old. Married his sister Mualeleth. Children included Mahalalel and Rasujal, sons.
- 5. MAHALALEL. Born when Kenan was 170. Married his first cousin, Dinah, daughter of Barakiel his father's brother. Their children: Jared, and Danel, sons.
- 6. JARED. Born when Mahalalel was 165. Married his first cousin, Baraka, daughter of Rasujal his father's brother. (Enoch I. says that shortly before Jared's birth, 200 angels came to the earth to contribute to the general corruption which led to the Great Flood. Jared's name was called this, because it means "Descent," or the descending of the angels.) Children included: ENOCH, the great prophet, and Azrial, sons.
- 7. ENOCH, born when Jared was 162. Married his first cousin Edna, daughter of Danel his father's brother. (He took up speech and writing material to condemn mankind as well as the angels who were immorally living on earth and marrying with women to produce huge monsters later celebrated in the Greek Myths as Cyclops, etc.) Children included: Methuselah and Barakiil, sons.
- 8. METHUSELAH, born when Enoch was 165 years. Married Edna, his first cousin, daughter of Azrial his father's brother. (Lived to the age of 969, longest age recorded in history for a human.) Children included: Lamech, and Rakeel, sons.
- 9. LAMECH, born when Methuselah was 167. Married his first cousin, Betenos, daughter of Barakiil, his father's brother. Children: Noah. No record of others. (Lamech prophesied that Noah who was named as "Comforter" would see a change in history.)
- 10. NOAH, (NOACH) born when Lamech was 188. Noah married his first cousin EMZARA, daughter of Rakeel his father's brother, by whom he became father to SHEM (oldest), HAM (KHEM), 2 years vounger than Shem, and JAPHETH (IAPETOS of the Greeks), 3 years younger than Ham, all born after Noah was 500 years old.

Noah and his family lived in peace some hundreds of years after the world-wide cataclysm was over. Dissention arose over the cursing of Canaan and the omission of Ham in Noah's blessing, Ham becoming very angry and leaving his father's presence. In old age, Noah called his family together and caused them to draw lots for the purpose of dividing the earth into three portions, one for each of his sons. Shem drew the portion "to the east of the garden," (evidently the location of the Garden of Paradise was yet known by some landmarks which survived the Flood), Ham drew the southern portion, and Japheth the northern. The descendants of these are, even today, generally distributed in the same localities. The question as to the origin of the "true orientals," (Japanese, Chinese, etc.), the American Indians, Eskimos, and South American tribes, has not been satisfactorily resolved.

A great-grandchild of Noah, Nimrod, or n'Merodach, later called Merodach by the Babylonians, his descendants, opposed the scattering and settlement as called for by Noah. He built the tower of Babel and the first city of Babylon. The tower is described as having been over 5,000 feet high - nearly a mile - greater than any building ever known to mankind before or after. This work took forty years to complete. Noah died in the meantime. The angels came down and destroyed the tower and divided the language of men into the portions which Noah had set for the scattering and settlement of the earth.

The confusion of tongues meant a total loss of the original unifying language inherited from Adam. Men were not able to write their new languages until writing for their specific tongues could be invented anew. Some of these tribes never bothered to adopt a written language and have none today. Others, near the Mediterranean Sea in the "commercial" area, adopted a picture-sign writing impressed into clay tablets. In a few years a better system, called Cuneiform from the stylus used, replaced the pictures. Several of the different families used this writing, even though their spoken tongues were not the same. At that point, a few years after the Tower of Babel catastrophe, our present unbroken period of "history" began. The archaedogical evidence abounds to prove that the arts, civilization, language writing, etc., sprang up about that time in many parts of the earth, as witness of the post-Babel settlement of earth. Before the Tower, men lived all in one vicinity, at the foot of the "holy mountain Lubar," or Ararat. Modern history began about 3.800 B.C.

The pre-Flood world, before Noah, was so utterly wiped out that no evidence of it exists, with the singular and awe-inspiring excention of the fossils, vegetable and animal, impressed into the rocks of the ages! The dinosaurs, so-called, the mammoths, saurians of the waters, and every other fort of creature and plant, which had abounded in the old world beyond the flood, were all instantly crushed by hundreds of millions of tons of water and ice, crashing down from the sky where it had been suspended "above the firmament" up until that time. Only Noah and his family and a selection of animals herded into the great chest or ark by Noah and the angels, survived. The ark was over 500 feet long and quite ample to hold the basic kinds of animals, and enough food to feed them for the permod of one year in which they rode out the storm.

Shem became the ancestor of the Hebrews, Arabs, Hindus, Chald-eans, Elemites etc.

Ham was the ancestor of the Egyptians (Mazor or Mitzraim), the Negroes of Africa including the Ethiopians (Cush), the Tuareg tribes of the African sands, and possibly the Incas of South America, as of the ancient Canaanites. (Canaan, according to Jubilees, squatted unrightfully in Shem's allotment, whereby he was warned of punishment in due time. This explain's Joshua's destruction of the Canaanites.)

Japheth became ancestor of the Greeks, over whom he personally ruled as Iapetos. Perhaps "Jupiter" or "Theos," or "Zeus," all of these names for the chief god of the Greeks and Romans, may be actually corruptions of the name "Japheth", none of which, by the way, are the correct pronunciations of these words in their original languages. He also was ancestor of the Romans, the Scandanavians, the English and Irish.

Shem married Sedeqetelebab; Ham's wife's name was Neelatamauk, and Japheth's wife was Adataneses. (Strange names!) (Jubilees, chapter 7, verses 13-18.) They were probably all first cousins.

Japheth first built a city he named in honour of his wife, near Mt. Lubar. His children were Gomer, Magog, Madai, Javan, Tubal, Meshech and Tiras. Josephus, the Jewish historian who lived not long after Christ, says that Madai is ancestor of the Medes who ruled in Persia; Javan of the Ionian Greeks. Others claim that the Russian cities of Tobolsk and Moscow (Muscovy) celebrate the names of Tubal and Meshech. John O'Hart publishes pedigrees which show that Magog, as above, with his family, not long after the destruction of the Tower of Babel, set sail for the north, and his descendants settled in the British Isles, becoming the ancient inhabitants of them.

It is far too involved and uncertain to try to enumerate the post-Magogic generations here. But suffice to say, our article is concluded with the hope that the reader may have some ammunition with which to fire some counter-vollies against those who think stubbornly that men evolved from something less than mankind! It is not so!

NOTES: There are different manuscripts extant of the ancient Hebrew histories. The Greek Septuagint version (translation) dates from at least 200 B.C. and has the so-called "long chronology" which assigns 2,242 years between Adam's creation and the Flood of Noah, and the Sinaitic, dating after the birth of Christ, assigns 1308 years for the same period. The King James and Catholic Douay English translations are each based on the Masoretic Text, done about 600-700 years A.D., giving 1656 years for the same period, which was used by Bishop Ussher in his dating system on the margins of the King James. The Septuagint is, therefore, nearly 1,000 years older than the Masoretic, and we think, should have precedence. (It must be understood, however, that, singularly with regard to this chronology do these three well-known early copies differ to any marked degree.)

The period following the date of the Flood, up until the Tower of Babel, also has a three-fold set of chronologies in the three manuscripts above described. The Book of Jubilees assigns 1308 years to the pre-Flood period, and 379 years from the Flood to Babel's destruction. It, therefore, constitutes a fourth version of the chronology. We leave researchers to solve the discrepancies. They are most vital! The true chronology would be wonderful to discover. The King James & Catholic versions in English are obviously wrong in their chronology from the Flood to Abraham's day. This point we will make before con-

cluding this review.

The Masoretic Text used in the King James and Douay Translations of the "Old Testament" assign but 101 years from the beginning of the Flood to the "Division of the Earth" when Peleg was born, and 292 years from the Flood to the birth of Abraham! Yet the same text assigns 500 years to Shem's life after the Flood, and 350 years to Noah for the same period! This would mean both Shem and Noah were living when Abraham was born, and, indeed, that Shem continued to live even into the lifetime of Isaac, and of Jacob, Abraham's son and grandson. This is totally absurd. All of the manuscripts unite in assigning a full 600 years to Shem's life, with 500 of them lived after the Flood. There is, therefore, no question about this figure. It is the figure assigned to each of his descendants, down to Abraham, at the age they successively became the father to the next in line, which is at odds in each manuscript. (There are some rather violent explanations, some tainted with anti-Semitism, circulated as reasons for these differences.) The Book of Jubilees, if it dates to 105 B.C. is really "next oldest" to the Septuagint itself, and we must remind the reader that the Septuagint "originals" don't exist, but exist in the form of later copies only, dating to post-Christian times. Jubilees presents the best chronology, giving 258 years from Flood to the Division of the Earth, and 379 years from Flood to the destruction of Babel. or. 29 years after Noah's death. It also shows that Shem was long dead and buried by the time Abraham arrived on the scene, giving 568 years from Flood to Abram's birth. The Septuagint gives many more years -1,171 - for this period! If we Holling(s)worths ever work our pedigree backward as far as Magog, we hope by that time you Scripture experts will have solved the chronology behind that time!

GEORGIA HOLLINGSWORTH FAMILIES, PART TWO OF A SERIES (From Vol. 3, Page 51.)

ISAAC HOLLINGSWORTH OF TWIGGS COUNTY

For this second of our Georgia Hollingsworth series, we have chosen the man whose family origin and descendents are shrouded in mystery. We might have placed his name last in order, except for the fact that it may help to air out this file and let others read what we have accumulated. The published material about him is very meagre. There is nothing more aggravating than to have this so well known material re-hashed to us by well meaning people. So we are going to print everything to have here to hopefully avoid this in the future!

Isaac Hollingsworth was in Twiggs County by 1818. That is the date of the first Tax Digests for the county. He is listed in Camtain Bostick's District. The 1826 Tax Digest shows Isaac in the same district. (Typed copies; we have not consulted the originals at the Department of Archives & History in Atlanta.) We assume he died between 1827 and 1830, for his name appears neither in the Federal census of 1830 or the Tax Digest for the same year. He last appears in the Land Lottery of 1827.

It might be fit to report the sad status of Twings County records. A fire in 1901 (of all times to have one) totally destroyed all the court records prior to that time, with the exception of these Tax Digest Books, 1818, 1826, 1830, 1833, and 1853. It is not known to us how they managed to escape. In addition, the 1820 census for the county is also missing, only one of two (the other being Franklin county) which are lost. The 1790, 1800 and 1810 Federal census for all of Georgia is missing, as most of you are aware. This is very nearly a total catastrophe, far worse than the situation with Irish records. You now might understand the problem with Isaac.

Isaac Hollingsworth claimed to have been a soldier of the Revolution. This would put his birthdate probably between 1750-1765. Both the 1820 and the 1827 Georgia Land Lotteries show that he claimed such status. This was not necessarily due to Georgia service. Unfortunately, to qualify, the claimant needed no written documents, only an oath or affirmation of his service. Thus, we have no documents as usually would be the case. His name never appears upon any roll, state or Federal, in behalf of a pension. No record can be found of the military outfit he served in or the officers he allegedly served under.

We have a Xerox copy of his land grant for the 1827 Lottery, page 58, Original Grant Book "Early-District 9-10" in Georgia Archives. The grant is dated 30th October, 1827, to "Isaac Hollansworth, R. Sol., of Evans's District Twiggs County, his heirs and assigns forever...all that lot containing 250 acres...in the 9th District of Early County...number 373...(Signed) G.M. Troup, Governor."

The most significant item yet found is the following from the newspaper files of "THE GEORGIA MESSENGER," Milledgeville, (weekly) Oct. 16, 1834:-

"TWIGGS COUNTY: - JAMES WATSON, Guardian of the orphans of ISAAC HOLLINGSWORTH applies for leave to sell lott 219 in the 5th District of Carroll County." (The Georgia Geneslogical Magazine, April, 1968, published by Folks Huxford.)

As skimpy as the item is, it is surprisingly helpful. It is a rare thing when a Revolutionary soldier left orphans in the 1830's! Although his name doesn't appear in either the 1830 Tax list or the Federal census, the name of "Mary Hollingsworth" does, and her name had not appeared before. What is more significant, she is in the District of Captain Bostick, the same one in which Isaac had appeared. Mary Hollingsworth also appears in Bostick's district in the 1833 Tax Digest and the 1840 and 1850 Federal censuses and the 1853 Tax Digests. She appears in the 1830 Census (HR Vol. 2, p. 111, item 13, Georgia) page 80, with 1 male 5-10; 2 females under 5; 1 female 5-10 and 1 female 30-40 who appears to be Mary herself.

The children would appear to be the "orphans of Isaac Hollings-worth" all born after 1820, and therefore still minors in 1834. Although this deduction is probably correct, remember that the total loss of the court records such as wills and marriages makes all of this still tentative. Another Isaac Hollingsworth, a supposed son of the soldier, might be the father of the orphans and the husband of Mary, even though there is nothing to show any other Isaac ever lived in Twiggs County. At any rate, if Mary was the Revolutionary soldier's wife she probably was a second wife.

The 1853 Land Lotterv lists Mary Hollingsworth in Smith's district with 202 acres. The 1850 census shows:

Above is on page 169B. (HR Vol. 2, p. 154) John is obviously not a child of Mary's, but probably a grandchild. Polly is either a daughter or daughter-in-law. This is the only Hollingsworth family listed. The 1840 census, page 392, shows Mary Hollingsworth's family with one male 15-20; 2 females 10-15, and 1 female 50-60. In the 1840, the families of Cornelius, William Jr., and William, Sr. Hollingsworth also appear in Twiggs County. (HR Vol. 3, p. 18, items 4,11,19,25,26.)

Wilkinson County, from which Twiggs County was set off in the year 1809, also suffered the loss of most of its public records! It is virtually impossible to trace anybody through either of these counties. It is also not possible for us to afford to have such private records as church records searched. We hope that the readers may be able to help. But for the record, before closing, let us speculate as to Isaac Hollingsworth's backbround.

Catherine (Tyler) Edwards, widow of John Hollingsworth, who was a son of Valentine Hollingsworth the Quaker Immigrant, in her will of 1753 in Bladen County, North Carolina (see full conv in HR Vol. 2, p. 142) named three grandsons, one of them being Isaac Hollingsworth. These three probably were sons of her own son, Rev. Stephen Hollingsworth the renowned Baptist preacher of North Carolina. Also, in two of the extant Bladen County deeds (HR Vol. 2, page 145) an Isaac Hollingsworth appears in transactions in 1785, one of which is a lawsuit and the other a sale of land belonging to him. These are the only appearances. It is possible that these two references, the will and the deeds, are of the same person. It is possible also that the Revolutionary soldier of Twiggs County was the same man. Born before 1753 he would have been in the 70-80 age bracket in 1827 when he drew his land. It also means he would have become the father of children in his seventies, not an impossible, but an unusual thing, all of which makes us warn the reader to compare these facts with caution. Too, there seems to be no record of any Isaac Hollingsworth having served in the Revolutionary war from the state of North Carolina! Before we charge our Twiggs County, Georgia, gentleman with fraud, we should say that the North Carolina military records aren't complete.

Whether he was in any way related to the Jesse Hollingsworth of Twiggs county, whose children we have somewhat dealt with in our other Georgia article, we cannot sav. Was he also the father of the two men Isaac & Jacob Hollingsworth of Mississippi? Does anybody know?

For those of you the follow this Rathfryland Family series, the two above fully copied documents are of the highest interest. Elizabeth Hollingsworth of Cavan, Clonduff Parish, County Down, was the widow of John Hollingsworth of Cavan, and ancestor of a widely scattered host of descendants who have distinguished themselves in the service of their country several times over. Henry Hollinsworth of the priceless 1696 letter was a distant ancestor of John's. This letter turned up in the collection of papers received by the P.R.O.N.I. from the Earl of Roden, so kindly called to our attention by the Deputy Keeper. It alters our previous beliefs. It proves that the Hollinsworths were at Kinkill (now King Hill) fourteen years before the same Henry Hollinsworth, then resident at Tymore, in County Armagh, purchased several leases from his brother-in-law, John Newell, of lands at King Hill. (HR Volume 1, page 59, Deeds Numbers 1-3.) 'Ould Mistress Newel' possibly is the grand mother of Henry's wife, Elizabeth Newell, daughter of John Newell, Clerk of the High Court of Chancerv in Dublin, who had died in 1693, probably leaving his mother to the care of the Hollinsworths.
