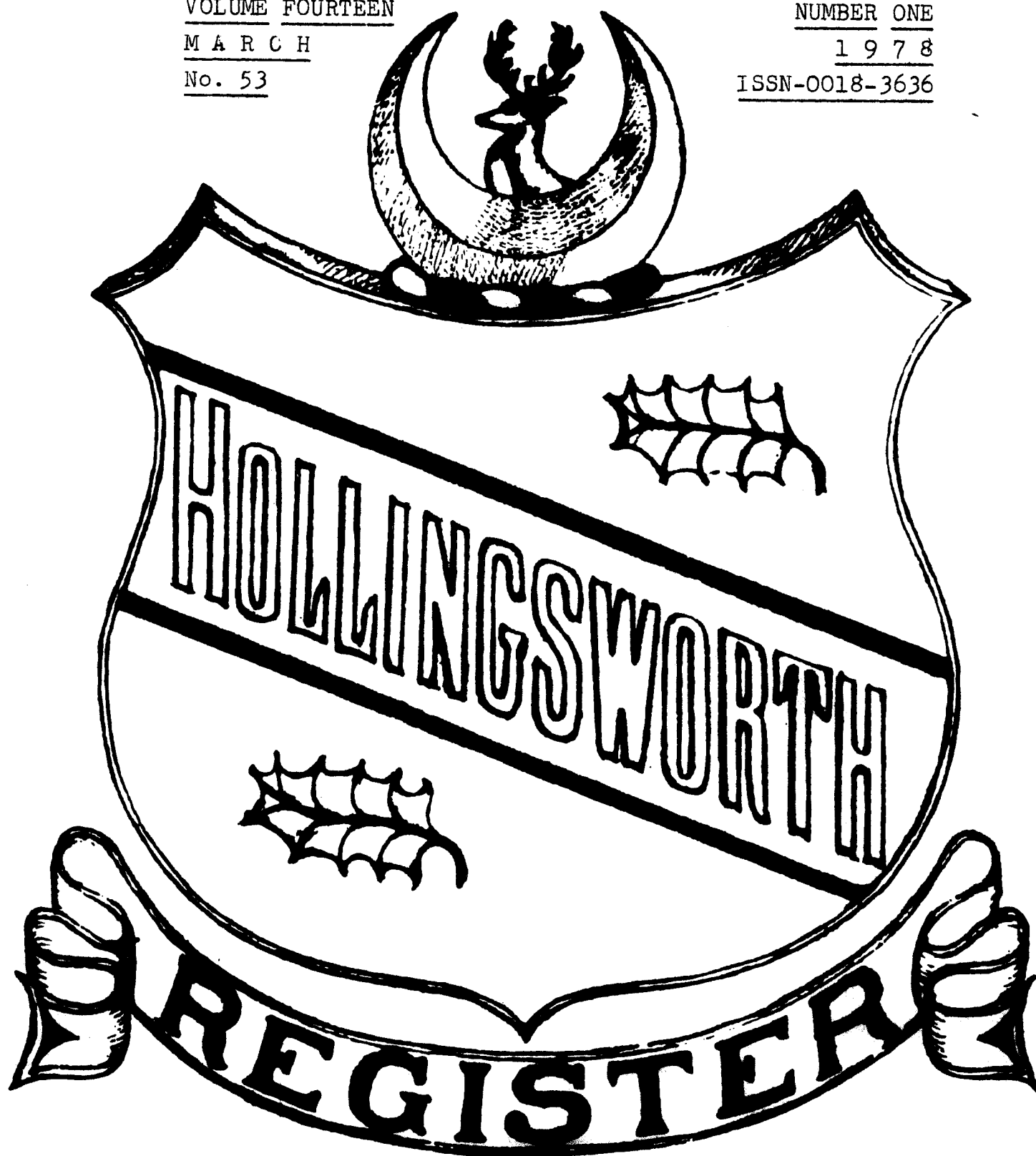

MEANING OF THE NAME

The surname Hollingworth is derived from a place in northeast Cheshire, of the same name, supposedly the place called "Holisurde" in the Domesday Book for Cheshire, pronounced "Hollis-worth," but probably intended to be "Hollinworth." It is in the Parish of Mottram-in-Longdendale, a few miles south of Manchester. (It is possible that several separate families using this place as a surname came into existence at an early day. There are two other places with this name in Lancashire north of Manchester. The Cheshire place was a barren wasteland at the time of Domesday (1086) and it was not until about the time of Magna Carta (1215) that we find any person using the name as a personal family surname. This was "Tomas De Holinewurth" (here the name is transliterated into Latin) who was a signatory on a charter of about that period. The two Anglo-Saxon words, Holegn (or Holyn), 'a holly bush,' and Worp (or Worde), meaning an enclosure, or farmstead, are said to be the origin of the placename Hollingworth in Cheshire. More loosely, it signifies "A farm enclosed by holly bushes," or "Holly Farm." The earliest form of the surname was Hollingworth, in the old orthography, Hollyngworthe, but in later centuries a medial "s" came to be used by some of the families, not much earlier than the early 1600s. Five generally used forms, Hollingsworth, Hollinsworth, Hollingworth, Hollinworth and Hollandsworth, are found in the indexes to births, marriages and deaths for England beginning in 1837, and in most of the telephone or city directories of the large cities in England and the United States of America.

INTENT OF THIS QUARTERLY

To publish verbatim copies or abstracts of records of the family world wide from the earliest times to the present. Hollingsworth Register is now in its Thirteenth Year. Nearly every instance of the surname in the U.S. Census schedules, 1790-1870 has been published in this quarterly. About two million pages were searched to produce that result, not to mention searching all kinds of other records. We know of no other family magazine which has even attempted to do this.

LAWSON D. HOLLINGSWORTH

Lawson D. Hollingsworth, whose pleasant home is situated near the corner of Colorado and Hollister avenues, is one of the oldest and most substantial citizens of Pasadena. The family of which he is a member was one of the first to settle in colonial America. He descends directly from Valentine Hollingsworth, who accompanied William Penn to America on the good ship Welcome (see note: Ed.), and in 1682 settled in Newcastle county, Delaware; subsequently he was intimately identified with the rise and progress of the Society of Friends. He married Catherine, daughter of Hugh Cornish, high sheriff of London, who, during the reign of James II, was executed October 23, 1685 (see note: Ed.). Eleven children were born of their marriage. The eldest son, Thomas, became a resident of Winchester, Va., and there died about 1732 (see note: Ed.). He was twice married. To his first marriage a son, Abraham, was born January 19, 1686. The latter married Ann Robinson; he died in 1748 and she a year later. They left four children, of whom George married Hannah McCoy, of Virginia; Margaret became the wife of Benjamin Carter, of Virginia; Lydia married Lewis Neill; and Isaac chose as his wife Rachel Parkins, of Virginia.

Next in line of descent was George Hollingsworth, whose children by his first marriage were Joseph, Isaac, Robert, Abraham and Ann. Joseph was twice married, his first wife being a Miss Frost and his second Margaret Hammer; he made his home at Bush River, Va (see note: Ed.). Isaac married Susanna Wright and settled in South Carolina. Robert married Susanna Rice and made his home in Winchester, Va. Abraham married Margaret Wright and moved to Ohio. Ann became the wife of a Mr. Brock. After the death of his first wife George Hollingsworth was again married. To his second marriage the following-named children were born: James, who married Sarah Wright; Henry, whose wife was Sarah Cook; George, who married Jane Henry; John, who was united with Rachel Wright; Nathan, who died unmarried; and Mrs. Susanna Mott.

The line of descent is traced through John Hollingsworth, who married Rachel Wright and died in Ohio in 1807. His children were: James, who in 1818 married Esther Cadwallader; Henry, whose first wife was Addie Skinner, daughter of a Revolutionary soldier; Jane, Mrs. John Cammack; Charity, wife of Jonathan Cox; John, who married Mary Vestal; Nathan, whose wife was Elizabeth Vestal; George, who married Jane Henry (see note: Ed.); Hannah, Mrs. Samuel Cammack; Joseph, whose first wife was Rachel Vestal and his second, Adaline Bell.

The subject of this sketch was born in Warren County, Ohio, June 14, 1823, a son of Henry and Addie (Skinner) Hollingsworth. He spent the first nine years of his life on his father's farm in Warren county, and then accompanied the family to Richmond, Indiana, where he attended the common schools. Early in life he apprenticed himself to the millwright's trade, which he followed until about 1847. December 19, 1844, he married Miss Lucinda Maudlin, who was born in Wayne county, Indiana. Both were spared to celebrate, in health and happiness, the occasion of their golden wedding, at which time their Pasadena home was the

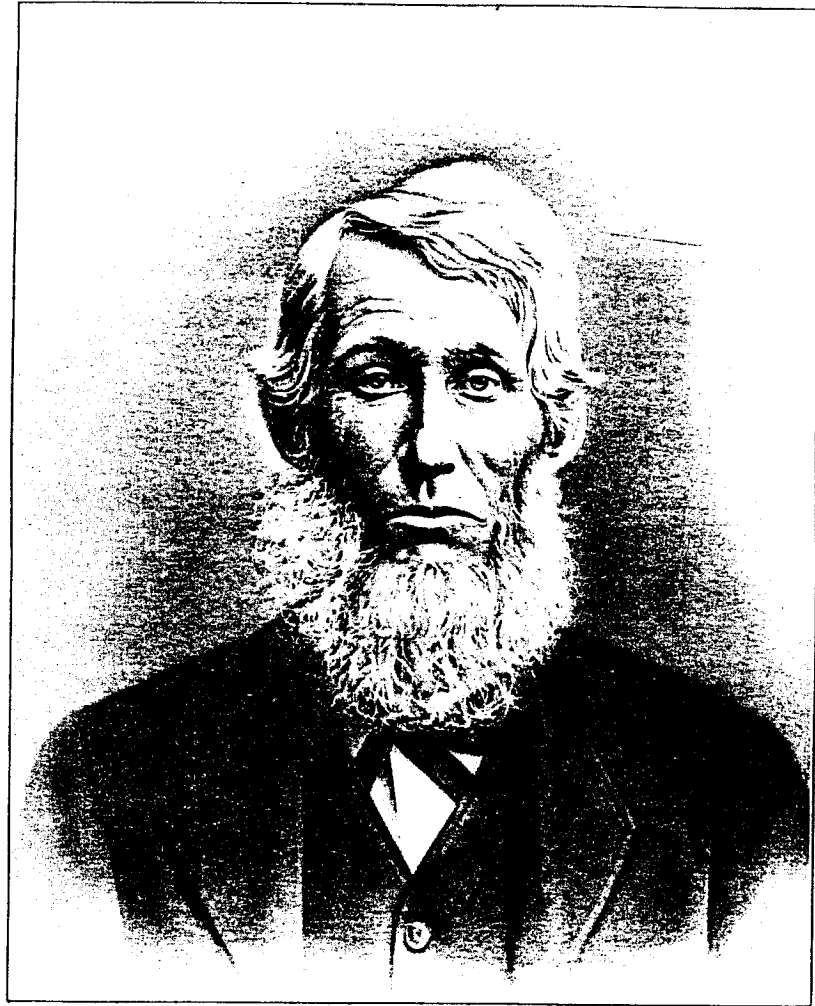
scene of a family reunion, some relatives coming from Iowa purposely to attend the celebration. They were the parents of six children, four of whom are living, viz.: Henry T., who was the first postmaster and one of the first merchants of Pasadena, and is now living in Los Angeles; Arthur S.; Ellen, wife of William Vore; and Jennie E., wife of Joshua Reed Giddings, all of Pasadena.

In March, 1845, Mr. Hollingsworth and his wife removed to Henderson county, Illinois. His last work as a millwright was the erection of a mill at Oquawka for his uncle. Soon afterward he rented a farm in Peoria county and remained there until 1853. He then crossed the Mississippi river into Iowa and settled on a farm near Iowa City. While he devoted considerable time to raising grain he also gave much of his time to the nursery business, in which he acquired such a reputation that people came from long distances for the purpose of securing a fine grade of nursery stock. After a time he gave his entire attention to the production of fruit stock and made his headquarters in West Branch, Iowa. In 1876 he came to Pasadena, traveling almost the entire distance by train, but staging the last one hundred and thirty miles of the journey. At once after reaching this place he bought ten acres near the present site of the Methodist Episcopal Church. This property he placed under cultivation. He engaged in its improvement until ill-health forced him to relinquish active labors. After years of industrious and successful effort he is now living in retirement. His course in life has been so honorable and upright that every acquaintance has been made a friend and every associate a well-wisher. It has been his principle to identify himself with public affairs, not with a view to office-seeking, but for the purpose of promoting the public welfare. He is a stanch Republican in politics. His first presidential vote was cast for Henry Clay. For several years he served as a trustee of the Pasadena schools. In religious belief he and his family are identified with the Society of Friends.

NOTE:

Your editor obtained photostats of this material over ten years ago. It was to be published in Hollingsworth Register at that time. But the glaring errors found in the first two paragraphs kept us from doing so. All this was published before Stewart's 1925 book, but the 1884 book by William B. Hollingsworth of Baltimore must have been used to give the incorrect statements: (1) Valentine Hollingsworth did not come on the Welcome with Penn. He probably came on the Antelope the same year. (2) He did not ever marry any Catherine, Cornish or whoever. (3) The sheriff of London - one of two - was Henry, not Hugh, Cornish, but there seems to be no connection between these families. (4) Thomas Hollingsworth, son of Valentine, died in New Castle County, Pennsylvania - now Delaware - in 1727, and never settled at Winchester, Va., and, by the way, was not killed by a bison or buffalo, either. (5) Bush River is in South Carolina, not Virginia. (6) One, but not two, George Hollingsworth, married a Jane Henry, but this is another problem yet unsolved. The above Lawson Duncan Hollingsworth died the same day his wife died, in 1902, at about the time this volume was being distributed.

Harry L. Hollingsworth, 45, 1727 Central Avenue, manager of U-Rent-It Centers Inc., 1807 Central Avenue, died yesterday in Wishard Memorial Hospital. Mr. Hollingsworth was shot in the back Sept. 14 by one of two holdup men at his place of employment. Homicide detectives said no arrests have been made. A native of Danville, Illinois, he was a resident of Indianapolis 25 years.

He was an Army veteran of the Korean War and was a member of the Fraternal Order of Police and the Schwitzer Bowling League. He had been a manager of the U-Rent-It firm six years.

Services will be held at 2 p.m. Wednesday in Jordan Funeral Home, with burial in Stilesville (Indiana) Cemetery.

(4) Percy Norris, Centerville, Iowa, 1978.

Long-time car dealer, Percy Norris, succumbs. Percy Ellsworth Norris, 71, prominent Centerville businessman, retired auto dealer, civic worker, former mayor of Centerville, active Republican, long-time member of the Centerville and Indian Hills school boards and churchman passed away Friday night, January 6, 1978. Mr. Norris had been ill several months, but was at his 832 South Park Avenue home until Friday. He was hospitalized at the St. Joseph Mercy Hospital in Centerville when his condition suddenly worsened and he died Friday night at 8:40 p.m.

His death removes from the local scene a man who was a moving force in Centerville over a long period of time. He had served in wide-ranging capacities. Consider these activities: - Served on the Centerville School Board for 25 years, much of that time as chairman. -Served on the Indian Hills Community College Board for seven years. During that time he was in the forefront of the fight to obtain the new Centerville campus. -Served on the Centerville Chamber of Commerce Board for many years and was active in a multitude of Chamber projects. -Served as mayor of Centerville in 1974-75 at a time Centerville was moving into many new undertakings. Previous to that he served a term as a city councilman. -He was a delegate to the Republican National Convention. At one time he was a candidate for Congress, and through the years an active party worker. -Served 12 years as a member of the Iowa Aeronautics Commission.

-Served as a lieutenant of the Air Patrol during World War II and until 1950. He was a charter member of the Lions Club and held a long-time membership in the Rotary Club. His civic interest continued to the Centerville Building and Development Corporation, a unique major housing program planned just east of Centerville. The program was financed by a special HUD grant and was regarded in civic and governmental circles as very unusual and unique.

However, his most cherished activity was his church work. Mr. Norris was a member and elder of the Gospel Chapel and had served as treasurer of that church. He was a charter member of Gideon's International. The Centerville camp was established in 1960, and he served as chaplain and treasurer. He served as director of Willowbrook Bible Camp. It was his business activity that required most of his time despite his heavy civic and church schedule. He was a 1925 Centerville High graduate and joined his brother, Glen Norris, who had an automobile agency. Shortly thereafter, Percy headed the Norris Motor Company. He continued as head of the auto firm until 1974. His long business tenure established him as one of the deans of the business community.

Born March 27, 1906, in Numa, he was the son of Jacob A. and Anna (Rains) Norris. He attended Numa and Centerville schools, and was graduated from Centerville High School in 1925. In 1936, he was married to Willa Mae (Billie) Thompson in Des Moines, and she survives. Preceding him in death were his parents, three brothers, Glen, Harry and Paul Norris; and one sister, Mary Grace Norris.

Survivors besides his widow include one daughter, Mrs. Keith (Carolyn) Owen, Centerville; three sons, John D. Norris, Fullerton, Calif., Robert E. Norris, Garden Grove, Calif.; and Capt. Richard M. Norris, Ramstein A.F.B., Germany; four grandchildren, three sisters, Mrs. David (Edna) Lawrence, Centerville; Mrs. Paul (Lou) White, Wayzata, Minn. and Mrs. Doyce (Veva) Wright, Adel, Iowa; and two brothers, Charles Norris, Centerville, and Harold Norris, El Cajon, California.

Services will be Tuesday, 1:30 p.m. at the Miller-Wehrle Funeral Home in Centerville, with his brother-in-law, Pastor George D. Leest of Redlands, Calif., officiating. Burials will be in Jerome Cemetery. A memorial has been established to the Gideon Bible Society. Memorials may be given at the funeral home. (5) Chester Hollingsworth, Plymouth, Indiana, 1970.

Chester A. Hollingsworth, 71, Bremen R.R. 1, formerly of Kokomo, died Thursday at 8 p.m. in the Marshal County Shady Rest Home near Plymouth following a heart attack. He had been supervisor of the home since July 1. Born in Hemlock, March 25, 1899, he was the son of Wesley and Ellen (Welty) Hollingsworth.

He moved to Mishawaka from Kokomo in 1924 and had moved from there to the Bremen-Bourbon communities where he had lived for the past 28 years. He was married to Pauline (Polly) Randolph, April 20, 1918, and she survives.

He had retired in 1965 from the Koontz-Waggoner Electric Co. in South Bend where he had been employed as a representative. He had also operated the Chet and Polly's Ceramic Playhouse.

A birthright member of the Hemlock Friends Church, he had been an advisor of the Marshall County Rural Youth for the past 17 years. A member of the International Brotherhood of Electrical Workers and was a veteran of World War I.

Surviving with the widow are one son, Dale Hollingsworth, Mishawaka; one sister, Mrs. Alma Vettel, Peru, and seven grandchildren. One son, five sisters, and three brothers are deceased.

The body will be removed from the Deaton Funeral Home at Bourbon to the Fenn Funeral Home here where funeral services are set for 10 a.m. Monday with the Rev. Chester Mitchell officiating. (1) Student Backs Away from Spanking Rule. With the heading of that title, The Washington Post of Nov. 16, 1977, tells us of Rhonda Davis of Jones, Oklahoma. She is a sixteen-year-old cheerleader who was late for school five times, and, according to the rules, she must submit to a spanking by the principal. Her mother, Peggy Davis, says "It's a ridiculous rule carried to ridiculous extremes." Rhonda had a minor traffic accident which caused the final tardy complaint, which, under the school's rules, requires either a spanking or dismissal on an indefinite term. Coleman, now of Apapa, Nigeria, writes that a ferry developed and operated by Levi8 Hollingsworth (Joseph7, Joseph6, Abraham5, George4, Abraham3, Thomas2, Valentinel, HenryA) within Heard County, Georgia, across the Chattahoochee River is still operating. Further information on this is expected. Similar data is requested from other readers.

(3) The editor's father, Harry Hollingsworth (1888-1947) often talked about the late opera star and antique automobile collector,

James Melton. Hollingsworth's widow, Nan Hollingsworth, told of how Harry appeared with Melton in a movie, and that Melton would not fraternize with anybody else in the cast but Harry Hollingsworth. However, she remembered that Melton had an aggravating idiosyncrasy. It seems that when he took Dad to lunch at the commissary, Melton would sit and read the newspaper extensively, ignoring Hollingsworth throughout the whole meal! Your editor happened upon a copy of Who's Who in Hollywood and looked up the surname Hollingsworth. There was Harry, and only two credits - My Favorite Blonde with Bob Hope, and "Sing Me a Love Song," starring James Melton as Jerry Haines, and at the bottom of the cast, published in the December 26, 1936 New York Times, p. 15, col. 2, is the credit: "Detective Harry Hollingsworth." In the cast were Hugh Herbert, ZaSu Pitts, Allen Jenkins, Nat Pendleton, Ann Sheridan, Walter Catlett, and others well known in those Depression Days to the Hollywood scene. Of course, the flick was a flop. But it kept the Hollingsworths eating. It paid to be a Warner Brothers day player in those uncertain times. (See New York Times Film Review.)

(4) Mrs. Margaret Sparks, of the staff (News Editor) of Tri-State Trader, in Knightstown, Indiana, sent us a tidbit from Three Centuries of American Art (Universe Books, N.Y.C.) p. 33. It is an illustration of a beautiful dress and its undergarment, worn circa 1795-1799. It is a pale-blue silk brocade dress, with tightly fitted bodice with three tabs accenting the waistline. It is said to have been worn by Rebecca Hughes of Philadelphia, who died in 1792 aged 22. Another similar dress, more subdued, was worn by Rebecca's Quaker cousin, MARY HOLLINGSWORTH. The Quakers simply took the current fashions and copied them in exquisite materials, but omitted any applied adornment - "plain dress" was their motto. (Doesn't look plain to your editor!)

(5) Mr. Chapman Sullivan of Margate, Florida, sent us a copy of a letter of Jan. 19, 1978, from Mrs. James H. Gardner of Lakeland, Florida, in regard to Lake Hollingsworth. It seems that two sons of Stephen Hollingsworth (who had come from Sampson County, North Carolina, to Jefferson County, Florida in 1840) in 1852 applied for land grants in the vicinity of present Lakeland, Fla. John Henry Hollingsworth, the second eldest son of Stephen, settled on the south side of a lake, later named for him. Thus the origin of Lake Hollingsworth. John Henry's brother, Stephen Thomas Hollingsworth, was the grandfather of Mrs. Gardner's husband. Mrs. Gardner reports that John Henry later removed to the Peace River area and was very severely wounded at the Seminole attack on the Tillis homestead near Fort Meade. He died later in Manatee County and is buried in the old Joshua Creek Cemetery east of Arcadia, Fla. For more details, she advises to send \$1.50 for a copy of Issue # 6 of South Florida Pioneers, care of Richard Livingston, P.O. Box 166, Fort Ogden, Florida 33842. This contains a sketch of John Henry Hollingsworth's life.

(6) Damon Veach publishes a free query section in his Your Texas Ancestors column in the Fort Worth Star-Telegram. Query must be about a Texas connection, of course. His July 29, 1973 issue had this to say about our magazine: "Hollingsworth is publisher of one of the finer surname quarterlies, titled "Hollingsworth Register." Unlike so many family publications, it is packed with original source data, has no queries common to many similar magazines, and is quite large...This one is

excellent and should be added to all descendant's files.

B. B. Hollingsworth: Not Stiff and Stodgy

In the highly traditional funeral industry, Service Corporation International of Houston and its 34-year-old president B.B. "Ben" Hollingsworth stand out sharply. But few people outside the burial business have heard of either. The company is the nation's largest corporate owner of funeral homes - 160 throughout the country - and Hollingsworth, who recently celebrated his tenth year with SCI, personally helped acquire some 155 of them. So when former president Sam Douglass stepped down at age 43 "to allow other young men with new ideas and a fresh approach the opportunity to contribute even more to the future growth of the company," he tabbed Hollingsworth.

To some funeral industry onlookers, it seemed an unlikely choice. Hollingsworth had never run a funeral home; he had never been in the "back room" of a mortuary before he joined the company. But the one-time Rice University quarterback ('62 and '63) was a chief financial officer who had the operational side down cold. As a CPA with the Houston office of Arthur Young & Company, SCI's auditors, he had worked on the account.

Hollingsworth is an innovative manager. He encourages SCI's youthful management team to take on more responsibility, to run their own show. At the same time, he is smart enough to know that funeral directors, many of whom owned their mortuaries before selling out to SCI, can adopt sophisticated business techniques but cannot be managed like a field force. "These people have built premier funeral homes in their cities and are often prominent people in their own right. We don't try to tell them, we try to sell them."

To be sure, Hollingsworth has got a healthy company on his hands. Profits and sales have had an uninterrupted climb for the last five years. He's also a strong supporter of funeral directors, whom he claims are often misunderstood. "I don't know of any industry where people are as sincere and dedicated to personal service," he insists. And they are not stiff and stodgy. "At a funeral directors convention," he admits, "they can really let their hair down." Dear Mr. Hollingsworth:

This is in reply to your letter of February 1, 1978.

I'm sorry you are upset over the reprint of Descendants of Valentine Hollingsworth. This edition is a reprint and not a revision and was never intended to be a revision. I talked to the authorities at the Archives of Georgia and Atlanta and asked their directions. They told me that unless I wanted to do a new book that if I was going to

duplicate the original that would be the thing to do. They suggested doing a reprint and giving Adger Stewart full credit for the work. That if I wanted to add corrections they would have to be an appendix, etc. But if it was to be a reprint it would have to be exactly as the original was. As I am 78 years old, have had open heart surgery and two light strokes it was an impossible job for me to do a revision. Mr. Stewart cleared his errors by stating he knew they existed and I did the same.

If these errors upset you why not put out a revised edition yourself! I did not know the material you sent to me even existed. There is a lot about this family I do not know about. I could have added a lot to the Stewart book myself because it only lists my mother's generation and says who my grandmother married. My part of the book picks up my Grandmother Butler's family and expands on her father and mother's family and expands on that. I did not know of your publication and other sources you mention. However, this does not bother me because I am too old to do anything about it. I did the best I could with what I had to work with and can vouch for the authenticity of part two of my book.

The material you sent to me (Note: Editor sent offprint of the Sept. 1969 article updating Valentine Hollingsworth's family) is interesting and I would have added it in an appendix to the first part of my book. Too late now. My readers will just have to accept my book as a reprint and not a revision. If they are misled that is just too bad.

Thanks for your information. I'll keep it in my file for some younger person to deal with. Research is fascinating to me. I have worked on three of my families and have published books on all three. I don't expect to attempt to add to what I have.

Ellis Hollingsworth Plaque Unveiled

A plaque honoring Ellis Hollingsworth, who contributed ten thousand dollars toward the construction of the present town hall in Braintree, Massachusetts, in 1912, was unveiled recently in the foyer of the hall by Thomas Pattavina, of Hollingsworth House Retirement Home, Washington Street, Braintree. John D. Keefe, chairman of the board of selectmen, was also present.

Mr. Hollingsworth came to the rescue when there was a ten thousand and dollar deficit in the building fund for the new hall, begun in 1912 after the burning of the original wooden hall the previous year.
