## The Myth of Catherine Cornish

Hollingsworth Register has spent nearly twenty years debunking many falsehoods in print and trying to publish the corrections. instance, Descendants of Valentine Hollingsworth, Sr. (1925) by Joseph Adger Stewart, is known for its errors. However, Stewart corrected errors put forth in print by William Baker Hollingsworth in his "Hollingsworth Memoranda" in 1884. Stewart's errors were honest. were either omissions or the placing of certain lineages in the wrong column, so to speak. That could have been, and probably was, a result of his accepting material from donors on face value. (The D.A.R., at its outset in the 1890s, accepted many members as "real daughters" of Revolutionary soldiers, on their say-so with almost no documentation. What a dreadful mistake this proved to be later, when the lineages were proved false when a later descendant wished to join!) WBH put in print one of the worst falsehoods in the whole Hollingsworth story, and this is, in a way, why we write this disclaimer now. The myth of "Catherine Cornish"! Lord help us. Back with us again. We thoughtit was truth, not fiction, which, when crushed to earth rises again! But here is Myth - Untruth herself - rising up again to scare and to daunt us, like a grussome, lurid phoenix from its putrid ashes!

Wm. B. Hollingsworth seems to have relied foolishly upon a letter written in 1824 from one Henry Hollingsworth to another. In this, the writer says their name (Henry) came from Henry Cornish, High Sheriff of London, who was the father of a Catherine Cornish who was the first wife of Valentine Hollingsworth, Sr., and, consequently, their ancestor, through Valentine's son Henry<sup>2</sup> Hollingsworth. He left the Friends to become more prominent and in favor with men... aside from the fact that he had been condemned and disowned by the Quakers for allegedly fathering a bastard child (HR Sep 1973,p. 75). In other issues of this journal we have shown that there were Cornish families who were Friends in Pennsylvania and involved with Henry<sup>2</sup> Hollingsworth, but no relationship has been found. (See: Henry Cornish - Political Martyr, in HR Sept 1970, pp. 83-86; A Cornish Connection? in June, 1973 p. 59, Sept 1969, p. 99, and other references too numerous to mention.)

We have received two letters in 1983 to the effect that your editor told somebody in writing that "Katherine Cornish" wife of Henry Hollingsworth ... father of Valentine Hollingsworth, Sr., ... died 1675, was the "Daughter of Edward IV. of York." Well, that is worth a big, healthy belly laugh, folks. If Hollingsworth Register were in the business of making up falsehoods in genealogy and history, do you think that we would have Katherine Cornish dying in 1675, and be the daughter of King Edward the Fourth who died in 1483 over two centuries before? As Roy Orbison would say, "Mercy!" Yes, Good King Edward has been dead half a millenium - 500 years. April 9th marked the day. We can trace a probable origin of this almost inconceivable error to our magazine in this way:

In HR June, 1974, at page 60 we published the happy story of the marriage of Jacqueline Hollingsworth, of our Wexford family, to Admiral William Right Hollingsworth of the Valentine Hollingsworth family.

Your editor stylishly, (in the grip of some euphoric passion) likened the wedding to the marriage of King Henry VII (Henry Tudor, Earl of Richmond - who became king only because Sir William Stanley treacherously changed sides at Bosworth and murdered King Richard in 1485) to "the daughter of Edward IV. of York." Those are my own words in HR. I was referring to Shakespeare's play Richard III. in the conclusion of which Henry Tudor, speaking a mighty eloquent speech over the corpse of Richard, talks about uniting the "red rose with the white". He was referring to his own marriage which united the houses of York and Lancaster, bringing an end to the Wars of the Roses. (Read Richard the Third, by Faul Murray Kendall (1955-56) and you may change your feelings about King Richard, Henry VII., and especially about William Shakespeare, a good playwright, but a lousy, sycophantic biased-towards-the-Tudor Monarchs historian! The book seems to show that Richard was a devout, Christian man, whom the people loved, especially the inhabi-tants of the City of York, and that Henry may have had the young heirs to the throne smothered, a horrible murder long attributed to Richard by his orders. The day after Bosworth, York went into mourning and proclaimed the foul murder of their king.)

In our article, I was thinking about the tie, at long last, between the Valentine Hollingsworth family and the Vexford Hollingsworth-now-Hollingsworth family. (I had not yet read the Kendall book!) "Edward IV. of York" was my phrase, and probably never used elsewhere, since it would be confusing terms. It appears that the Cornish myth was somehow tragically connected to this phrase. But not so, readers. Although I cannot say that Henry Hollinworth of Ballyvickcrannell, father of Valentine! Holling(s)worth the Quaker, was not married to a Katheran Cornish, I can indeed say that Valentine never was!

In our informant's letter is also a new twist, that Henry was identical with the Henrie Hollingworth baptised 24 August 1589 at Everton, Nottinghamshire, son of William Hollingworth, a find I made a few years ago. This statement is no wise proved. Also, they have him dying on 27 Oct 1675! That is the date of 3 leases or agreements between the Blackers and Valentine Holling(s)worth before he left Ireland, for details of which see HR June 1971 p. 45. In them, Henry was deceased at the time they were signed. He did not die on that day. Ridiculous! He may have died in the 1641 rebellion. He certainly did not remain at Ballyvickcrannell at that terrible time, when The O'Neill and his rabble were murdering, burning, raping and drowning every Englishman and woman they could lay their fiendish hands upon. But I am of the opinion that Henry survived into the early 1670s and is the man who signed the marriage as I wrote in HR 6:127-131, on 8 Oct 1671, as Hen: Holinworth, His grandson of the same name then being only 13, and being better educated, always signed as Henry Hollingsworth.

Be assured that we are investigating the Everton registers, and other registers where Henrys were baptised. Suppose, now, that we locate a burial for this Henry baptised in Everton Church in 1589? Buried as a child. As Karl Malden would ask: Then what will you do? What W I L L you do?

Please ... no more myths. Let Catherine Cornish sleep, and rest, if, indeed, she ever lived at all outside of the imagination.

#### Hollingsworth Cemetery, Simpsonville, Kentucky

The location of this burial place is south off of U.S. 60 on Cardinal Drive, and l\(\frac{1}{2}\) blocks to an alley. Turn right and the cemetery is about halfway down on the left. Only eight stones found and published by the Shelby County Historical Society, Inc., in 1979, a year after your editor visited New Castle, Kentucky, not far off from Simpson-ville and nearly died of a sudden asthma attack while pulling up weeds away from stones trampled by cattle. Their work Cemeteries in Shelby County, Ky., is a fine one, and this cemetery appears on pp. 313-314. We publish all the entries here. This is the family of Robert Hollingsworth who married Susannah Rice (of George Abraham, Thomas, Valentine, Henry Hollinworth, and although she is buried here, Robert is probably buried back in Virginia (See HR Sept. 1979, p. 41 et seq). The actual survey was made 17 July 1976. Most of the stones, say the publishers, are covered with bushes.

- 1. JAS. HOLLINGSWORTH / BORN / Oct. 21, 1789 / Dec. 5, 1869. / IN THE 81st YEAR / OF HIS AGE. / Blessed are the dead that die in the Lord. (The name is arched.)
- 2. Susan P. Hollingsworth / Died March 22nd. 1842 / Aged 56 Years (Above the name is a sculpture of a lamb under what appears to be a willow tree.)
- 3. JOHN P. / HOLLINGSWORTH / Died November 30th 1836 / Aged 18 Years. / Tho, lost to sight: / To memory dear.
- 4. Hannah / Hollingsworth / Died June 30th 1833 / Aged 41 Ys. 10 M.
- 5. SUSANNAH / Hollingsworth / Died June 29th 1833 / Aged 81 Ys 10 M. (This is Susannah Rice Hollingsworth HR Editor.)
- 6. JOHN YOUNG, / DIED / Dec. 31, 1827, / AGED / 45 years. The name is arched. SD.
- 7. SACRED / to the memory of / DAVID WHITE Sr. / who was born Novr / 10th 1750 / who departed this life / July 27th 1838 / Aged 87 Years 8 / Months and 17 / Days / May he that rests, beneath this clay / Enjoy a blessing on that day / When all the dead shall arise / In glorious triumphs to the skies.
- 8. SUSAN R. YOUNG Died Sept. 16, 1838 Age 28 yrs. This stone was not found during the survey of July 16, 1976 but appears on a list of this cemetery prepared by Joyce Lay and dated March 18, 1966.

COMMENT: Susannah Hollingsworth's date here, 30 June 1833, differs from the bible record (HR Sept. 1975, pp. 69, 70) which gives 29 June 1835. The cemetery reading might be faulty - mistaking a 5 for a 3 (we have seen 4s mistaken for 1s!) but the 29 from the bible should acceptable provided it was a contemporary entry. The above James (1) is Susannah's son (no death entry in bible); Hannah (4) another child, whose entry matches the stone. No. 2 is the 1st wife of James,

(1) Susan Pleasant Russell, and the date of her death matches that in Stewart's book, p. 37. John P. Hollingsworth (3) is their son, born 28 Oct 1818, and deathdate as well in Stewart. John Young is probably the same who Stewart says married Esther Hollingsworth, another child of Robert and Susannah. Susan R. Young would probably be a child of his, not carried out in Stewart (p. 36). But who was David White?

#### Jasper County, Iowa in A.D. 1875

The Andreas Atlas of Iowa, 1875, is a goldmine of data. It was reprinted in the 1970s. We have seen the original also, a huge tome very reminiscent of a ledger from a County Courthouse vault. The reprint can only receive one criticism: the print is too much reduced. The business Directory for Kellogg, Jasper County, lists:

Brown, Adam W., hotel Hollingsworth, E.E., saloon and fancy groceries.

In the Newton section:

Morgan, W. J., Furniture, (Manufacturer and Dealer), Undertaker. Miller, Fred P., Grain, Lumber, Salt, Lime, Cement.

Adam W. Brown was the brother-in-law of Frederick Hollingsworth, half brother of his wife Elizabeth Brown, and half uncle to Edward Earl Hollingsworth above. W. J. Morgan was the undertaker who buried Frederick Hollingsworth on 8 Feb 1869 - but where? Fred F. Miller was the lumber dealer who sold Frederick the 5,000 feet of lumber to build his house.\* That was in 1868. Hollingsworth died without paying. You can read all about it in HR June, 1978 pages 26-34. On page 531 of the Atlas, in the Patrons' Directory, more is given:

NEWTON:

\*Successor or heir of D. T. Miller. Not proved yet - Ed.

Fred P. Miller - Dealer in grain, lumber, wood and agricultural implements; born York Co., Pa.; came to state of Iowa in 1845.

#### Where is Frederick Hollingsworth Buried?

In our issue of Dec. 1980, at p. 65 we hashed this over. Now we present this blurb. The mention of W. J. Morgan, undertaker of Newton, Iowa, brings to mind our visit to that city in 1978. Upon speaking with the Clerks in the Recorder's Office, we went to the City Hall and examined there the burial entry book for Newton Union Cemetery. It was very sad to note that their index book and burial books begin in 1889, 20 years too late for Frederick. Phyllis Franzen said that the first book was burned! We then visited the Reese Funeral Home on North 3rd Avenue East who had the old record book which belonged to the W. J. Morgan Undertakers, but the "earlier book was lost" the one I examined

beginning also in that same year ... (?) 1889! The gentleman in the office said he was not sure, but the "earlier book" began about 1882 and was lost now. Of course, if it only began in 1882 it would be of no use to us. If W. J. Morgan buried Frederick Hollingsworth in 1869 didn't he keep books at that date? Whatever. The entry I did find was disappointing:

Roy Hollingsworth, buried April 13, 1891; died 12th. Jacob Hollingsworth paid for the funeral. A \$12.00 service was ordered with a 3 foot casket.

The director and I examined the entry book and found that only in 1905 was the name of the cemetery given. Therefore, unless in 1869 the name of the cemetery was given, we would be no closer to finding Erederick, Roy's grandfather, than we are now.

The Newton Union Cemetery entry book in the City Hall shows that Jacob Hollingsworth purchased Lot 13 in Block 8 of Section 7 on April 13, 1891. Our visit to the cemetery located this stone:

ROY / Son of / J & G / HOLLINGSWORTH / DIED / APR. 12, 1891 / AGED / 2 ys. 3 ms. 20 ds. (Small, upright marble, west from the road from the Louis Maytag tomb.)

In strolling through this cemetery which stretches up and over a gentle hill, into a newer section which has no trees, I did not at that time think that maybe Frederick was actually buried there. The next step is to get some hint of the actual date of the earliest burial in Newton Union Cemetery.

The other burials of interest to us are:

NELLE HOLLINGSWORTH SHEEHE 1891 - 1963 (Flat headstone).

HOLLINGSWORTH / JACOB / 1842 - 1917 / GEORGIA HIS WIFE / 1856 1915. GRANDMA TITMUS / 1829 - 1901. (All on large granite monument.)

Your editor copied these stones and took snapshots of them on Tues. 1 August 1978 at 7:40 p.m. Roy was the child of Jacob<sup>2</sup> and Georgia (Titmus) Hollingsworth, and Grandma was Sarah (Figg) Titmus her mother.

The Clerk's record shows Georgia Hollingsworth died 25 Feb 1915 in Sec. 9, Lot 31, Block 8, aged 58; Jacob, aged 75, died onJuly 23, 1917, in Sec. 8, Lot 30, Block 8. There is also a Martha Jane Hollingsworth who died there at 81 years on 19 Jan 1925 in Sec 10, Lot 1, Block 14. I did not see her stone, if any and have no idea who she is.

The Sladeks, killed in a car accident, both died on 23 Jul. 1964 (note Jacob's entry) Madge, Jacob's daughter, Nelle Sheehe's sister, in Sec. 1, and her husband Matthew (Matt) in Sec. 2, both in Lot 91 of block 31. I did not see their stones. Ages in the city burial book were not given until 1895. (See HR Dec 1980 p. 74.)

So ... Where is Frederick Hollingsworth buried?

Census omission: Kentucky 1810, Clay County, page 155.

Jas Hollinsworth, 10100 - 00100 (1 male under 10; 1 male of 16 and under 26; 1 female of 16 and under 26). Omitted in our survey of HR Oct 1965.

Accelerated Indexing Systems Kentucky 1810 index, p. 378, which gives all statistics, lists Susannah Hollingsworth in Shelby County, on page 198 as 11210-03010 whereas HR Oct 1965 gives her with 01210-00301. Upon a re-examination we find HR is correct. The surveyor for AIS mistook the tail-end of the surname viz "th" which intrudes into the 1st male column, to represent the stroke of the pen, and somehow shifted the whole situation making Susanna ten years younger! Other than these, AIS came up with same 1810 Kentucky findings as HR. They are to be thanked for finding James.

#### <u>Citizens & Immigrants - South Carolina, 1768.</u>

This is the title of a fine work by Heritage Papers, Danielsville, Ga. 30633 (1980), Mary Bondurant Warren, genealogist. She quotes valuable material and cites the sources, but only uses it for the one year.

Note on above: These are early discoveries, pre Revolutionary settlements of these Hollingsworths. George is doubtless George<sup>4</sup> son of Abraham<sup>3</sup>, Thomas<sup>2</sup>, Valentine<sup>1</sup>, Henry<sup>a</sup>, who went in 1760s from Frederick Co., Va. to S.C. (Stewart, p. 5). Jacob Hollingsworth was married to Betty Trammell, Daniel's daughter as shown by Daniel's will printed in HR years ago. Jacob is thought to be, but not proved to be, Jacob<sup>4</sup> of Joseph<sup>3</sup> and Martha (Houghton) Hollingsworth, of Thomas<sup>2</sup> above, per Stewart, p. 109 - Jacob is not in Stewart - we added him, but have not yet found proof. Jacob died in Union County, S.C. leaving a large family which intermixed with all those other cousins named Hollingsworth Quakers and ex-Quakers, until the sorting out has nearly been impossible. This James is beyond us. Or are we just too tired at 2:30 am to see who he could be?

#### Jefferson Davis and David M. Hollingsworth

The Maury Democrat, 12 Dec 1889, Maury Co., Tennessee, reported the death of former President Jefferson Davis, only chief executive of the Confederate States of America. Under the banner heading: The Dead Chieftain, and datelined New Orleans, the scene of the lying in state of the remains of Davis was painted. He lay in the Municipal Build-Thousands poured in. Then ... "Col. D. M. Hollingsworth this morning brought to the hall an old rifle used by him during the Mexican War which he exposed alongside his body. The weapon which is in excellent condition, bears the following inscription: 'Buena Vista, (Mexico) 23 Feb 1847. First Sgt. D. M. Hollingsworth, Co. A First Mississippi Rifles, Colonel Jefferson Davis.' These rifles were given to the members of the Mississippi Rifles, who served in the Mexican War by Act of Congress. As Col. Hollingsworth deposited the weapon near the coffin of his old commander, he began to weep. The scene was a most affecting one and moved many of the spectators to tears... Floral offers have been pouring in, and the coffin now looks as if placed at the head of a bank of flowers. The Army of Tennessee led with a design ten feet high, one of the handsomest floral offerings ever made here." (Follows a long biographical sketch which shows he was born in Christian (now Todd) County, Kentucky, so the two opposing chiefs in the American War of the Rebellion (pardon us, but that is the official title) were from the same state - Davis born 3 June 1808, Lincoln 12 Feb 1809.)

Jefferson Davis was one of the persons who helped David Marshall Hollingsworth get his pension- see HR Dec. 1973 p. 132, his affidavit dated 23 Aug 1887. Jefferson Davis was finally interred in 1893 in Hollywood Cemetery, Richmond, Virginia, where your editor's great-granduncle, William J. Burt (1827-1898) and his wife and children are buried, alongside Nancy Birt (died 1866) editor's great-grand-aunt, From Maghera, Co Derry, Ireland, on editor's mother's side. (Obit from Obituaries from Tennessee Newspapers, (1980) by Jill L. Garrett, So. Hist. Fress, Silas E. Lucas, Jr. Publisher.)

Here we give the list of our surname, shown on page 290, Column 1, of the book.

Strange to say, almost none of the above names can be matched to the

list in HR 1:19-20. From other sources, we know Mathew (who must have gone to court twice in two different courts) was married to Isabella Johnson in Ireland. She landed in Philly on 31 Oct 1839 and we have the listing, but no Matthew found by our 1965 searcher. The symbols for Country of former Allegiance are Eng. (self explanatory) and GRBI (Great Britain and Ireland - a very confusing term indeed when you do not know if an ancestor came from England, Scotland, Wales or Ireland), and the Court symbols are: CP:: Common Pléas-records now at Prothonotary's office, Philadelphia City Archives, Rm. 523, City Hall Annex, Philadelphia, PA 19107; QS: : Quarter Sessions Court at same address; SC:: Supreme Court of Pa., now at Pa Hist. and Museum Commission, P.O. Box 1026, Harrisburg, Pa. 17120. CC:: U.S. Circuit Court, now at Archives Branch, Fed. Archives & Recs. Center, 5000 Wissahickon Avenue, Phila., PA 19144. (Why did so many immigrants get naturalized in October?) Dates may indicate taking of the oath or of declaration of intention.

#### Joseph P. Hollingsworth

Joseph P. Hollingsworth, farmer, is a native of this (Greene County, Ohio) county, and was born May 20, 1833; reared and educated here, and was here married to Miss Martha Bales, in February, 1860. Five children are the result of their marriage - Emma E., Alonzo, Marion, Charlie, and Hattie, all of whom are living. Our subject has a farm of seventy-four acres, on which he lives, farming to grain and stock. Is a brick mason by trade, learning the trade in this county, which he began about 1848, and has worked at that trade a great portion of the time since then. Is a member of Bowersville Lodge No. 559, I. O. O. F. having united with that order in 1864. (History of Greene County, Ohio (1881 reprint 1974) R. S. Dills, p. 840. Jefferson Township section.)

## <u> Silas Bales</u>

Silas Bales, farmer, Paintersville, is a son of John and Sarah (Lucas) Bales. Mr. Bales was born March 6, 1789, and died March 11, 1864; she died June 8, 1874. He served a few months in the war of 1812, and then returned to this county, where he was married about 1813, and where he passed the remainder of his life. There were twelve children of this family, four daughters and eight sons, Silas being the eldest. He was born in this county, June 11, 1814, and here he was reared, and afterward married Miss Elizabeth Smith, also of this county, by whom he had two children, Sarah and Martha, both of whom are living. Sarah married a Mr. Marshall, now deceased; she then married Moses McKay, her present husband, and has two children, William S. and Edwin F. Martha married Joseph Hollingsworth, whose biography appears in this work; they have five children. Mr. Bales has a farm of 178 acres, on which he lives. Himself and wife have been members of the Methodist Episcopal Church for at least 35 years. He was elected trustee of the township (Jefferson) in 1859, and re-elected in 1860. (Ibid, p. 830.)

#### HOLLINGSWORTH MISCELLANY

- (1) Names of voters at an election held for territorial representative in the 6th election district, County of Dearborn, Indiana, at the home of John Templeton. Judges, Joseph Hanna, Samuel Shannon; clerks, Villis Kelly, Joseph Billings. All votes cast were for Richare Rue. This district apparently comprised the eastern part of the present Union County and the northeastern part of Franklin Co. Indiana Voters included: David, Richd., Jacob, Ezekial, George, Levi, Joseph, Jah. (Jeremiah?) and William Hollingsworth, in that order in the list, Ezekial to William in one continuous series. George Harlin also next to Richard Hollingsworth. (Hoosier Genealogist, July-Aug 1961, Vol 1, #4, p. 8.) The loss of the Indiana Territorial Census of 1810 is somewhat "mitigated" by this valuable list. Oh yes, date: circa 1807:

Married Elizabeth Hollingsworth in Penn. in 1864; she was born in Penn. in April, 1837. Seven children, David A., Joseph M., Harlan H., Demetrius D., Mary M., Anna V., and William W. Vanlew. Served in 137th Penna. Vol. Infantry, enlisted in August 1862, in Army of the Fotomac, 9 months. Member of Presbyterian Church.

- (4) Our correspondent, Eileen H. Gray, of Florence, Oregon, sent us a haymow full of Hollingsworth data! Under The GOOD Hollingsworth, she submitted a squib from the Eugene Register-Guard of 18 Oct 1981, telling of Gerald Hollingsworth, 1610 High St., who was robbed at 1:15 in the after hours, his wife's purse being rifled by a gun wielding intruder. The gunman had a stocking mask on. Kindly, he did not take certain papers he originally intended to steal, "in response to Hollingsworth's request." Under The BAD Hollingsworth, Mrs. Gray sent us another clipping from the 12th October issue of the paper. Headed Salem man, 40, jailed in probe, it tells of arrest of John Tucker Hollingsworth, of Salem, arraigned Wednesday (7th) on misdemeanor charges of promoting gambling in the second degree. He was later released on his own recognizance. He was the second man arrested, with Ralph Wayne Brown (Oh oh! the Browns and Hollingsworths are at it again!), after a six month investigation of illegal poker games.
- (5) The <u>History of Jefferson County</u>, Florida (1976) by Jerrell H. Shofner, p. 215, mentions a meeting held in Nov. 1849 at the head of the Wacissa River to consider opening the rivers to steamboats and other small crafts. As a result, a committee was formed in the following april with Octavius Gadsden, president and Lewis I. Fleming secretary. William Hollingsworth was along too. The idea was to open books for stock subscriptions. Eventually the project was abandoned permanently. (Tallahassee Floridian and Journal, Dec 8, 1849, May 3 and Dec 20, 1851)
- (6) Thoroton's History of Nottinghamshire, England, by John Throsby (1797) Vol III., pp. 320-323 - original edition, Los Angeles Central Library, 630 W. 5th, Los Angeles, CA, Genealogy Division, has a sketch of the parishes of Everton, Scaftworth and Harwell. Everton is our target as a possible English home for Valentine Hollingsworth's father, Henry. The index to these volumes is inadequate, to say the very least! In the reign of King Henry VIII., Everton was a manor bargained for in a suit between George Lassells, Esq., and Richard Towneley, Esq. The Wentworth family, related to the Earl of Strafford, who was beheaded by Charles I., hald claims here. book of free tenants "Liber libere tenanti" dated 1612 lists the owners of land in Everton, including <u>William Hollingworth</u>. This was the name of the father of the Henry Hollingworth ("Henrie") baptised at Everton in 1589 (See page 20 above.) Scrooby is only a short distance away. It was the birthplace of William Brewster, the mastermind of the Pilgrims, so called, and their eventual voyage to Massachusetts Bay, at about the time Henry Hollingworth was going to Ireland. (Val's father.)

(7) Jasper County, Georgia, Deed Book 1, pages 281-285, has two instruments. One is dated 31 Mar 1808 and headed Franklin County. John D. Terrell of Franklin, under power of attorney 18 Oct 1806 from William Hollingsworth formerly of Clarke County for \$200 paid by Benjamin Harrison, Pendleton District, South Carolina, 2022 acres drawn to name of said Lilliam Hollingsworth in the last (1807 Ed.) lottery, lot 62 in 16th District of Baldwin Co., Ga. surveyed by Hugh McDonald. Signed J. W. D. Terrell. Wits: Thomas Gordon, Wm. Gordon. Proved by Thomas Gordon 22 Mar 1809 before Joel Terrell, JP, in Franklin County. Recorded in Jasper County 28 Mar 1809. The 17 Oct 1806 instrument is then entered on p. 283, Headed Franklin County. William Hollingsworth, late of Capt. Robertson's company in Clarke County having clear and unexceptionable right to enroll his name for one draw (denoting a single man - Ed.) in Oakmulgee land lottery, has duly enrolled his name for one draw in the books of John Simmes and Obadiah Echols, persons appointed to take in the names of all persons so entitled in Major Plankston's Battallion (3rd). I, said William Hollingsworth have this day sold same for \$\phi\_3\$. to John D. Terrell of Franklin County. If a prize (lot of land - Ed.) should be drawn in my name, Terrell has power to sell. Signed William X Hollingsworth. Wit: Agness W. N. Potts, John Peterson. Proved by Peterson in Franklin Co. 22 Mar 1809; recorded in Jasper County, Ga. 28 Mar 1809. Identity of this William is not known. Have we got a "Mystery William" too? Oh me, oh my!

#### (1) James Malcolm Hollingsworth - 1968, California

He was It. Col. James M. Hollingsworth retired USAF fighter pilot who was aged 47. He was born 6 Nov 1920, at Edmonds, Snohomish County, Washington, to Claude E. and Sarah E. (Knapton) Hollingsworth. He died 19 Mar 1968 at Hamilton Air Force Base hospital of a massive coronary, resuscitation efforts having been unsuccessful. He left his wife, Nadine, of the family home at Novato, Marin County, California, four sons, James M., Jr., Robert, Ritch and Tommie, and daughter Jeanne. Services were in San Rafael with military burial in Mt. Tamalpais Cemetery. Hollingsworth had been a fighter pilot for 25 years, starting in P 38s at McCord AFB, Tacoma. He saw service in North Africa, England, Japan and Germany during world War Two as well as at McDill AFB in Florida and Hamilton AFB in California. For five months of the war, Hollingsworth was a prisoner at Stalag Luft #1 at Stettin, Poland, from Dec 24, 1844 until May 1945 when the camp was overrun by the Russians. He had been retired a year and a half at the time of his death. He also left two sisters, Eileen H. Gray and Ethel H. VanRooy.(Contributed by Corresp. Eileen H. In good health and sound mind. Executors to discharge just debts. All goods and chattels to beloved wife <u>Caroline N. Hollingsworth</u>. All lands to her too. In case of any child or children at time of decease, wife is to be guardian. She appointed Executrix. Dated 17 June 1857. Signed Wm. W. Hollingsworth (Seal). Witnesses: Wm. D. Cooper, R. Rundle Smith, O. Thompson. Registered 19 May 1864, affirmed on oath of Caroline N. Hollingsworth. Book 53, pp. 87-89, File 255 of original papers, Register of Wills, Philadelphia, book filmed by LDS with serial 5242 part 31, examined by your editor 28 Nov 1967. (He seems to be the William Hollingsworth, 41, in the 1860 Census, page 272, Ward 7, a broker, with wfe Caroline, 38, and children William, 8, Josephine 5 and Mary 2, and 2 servants per HR Vol 10, June 1974, p. 43.)

#### Letter to the Editor

The Vicar at Quarndon, Derbyshire, found a JOHN HOLLINGSWORTH married a HANNAH MARLOW 2 Dec 1805 plus two children, born and died but no Henry. No other Hollingsworth was mentioned in his parish in the 19th century.

Neither 1841 nor 1851 census for Hayfield or Quarndon show any Hollingsworths listed but the 1851 Quarndon Census does show (sic) John Hollingsworth, widower, 68, Farmer's laborer, born Quarndon. (Source: Derbyshire County Council.) His will showed no relatives. I feel quite certain the parents' names are correct, for (Henry) named his first 2 children JOHN HENRY and HANNAH AMELIA. I agree birth dates could be wrong, but the same age is carried correctly on every census and death certificate I have.
