Your Editor's Comments First, a big Thank you! to many subscribers for not pushing the Panic button when HR was so long in coming. Our March, 1992 issue was 3 months late. But this delay with June 1992 being typed in Jan 1993 is a new, unwanted record, believe me! But it was unavoidable. (3) Edward Gerald Hollingsworth - Ottawa, Kansas - 1943
(? Jan) 17, 1944 Hollingsworth Obituary (from unidentified Ottawa paper). Edward Gerald Hollingsworth, was born March 15, 1859, near Johnston, Ohio, died Dec. 18, 1943, aged 84 years, 9 months and 3 days. When a young man he came to Ottawa and located in the vicinity between Ottawa and Pomona, known as "The Island." On Mar 4, 1886, he was united in marriage to Marietta Tolle. Six children were born to them, two boys and four girls, the eldest boy, Willie, dying at the age of 18 months. Surviving are Mrs. Daisy Price, Roy Hollingsworth, Mrs. Hazel Wiley, Mrs. Doris Fisher, and Mrs. Lela Comstock, and 8 grandchildren and 3 great grandchildren.

In 1888, two years after marrying, Mr Hollingsworth opened up a meat market in Waverly: Later he went to Williamsburg from there to Pomona, and on Apr 30, 1912, Mr and Mrs Hollingsworth and family

became residents of Quenemo where he has conducted a grocery and neat market, retiring six years ago. In Mar. 1936, Mr. and Mrs. Hollingsworth celebrated their 50th wedding anniversary. After Mrs. Hollingsworth passed away in June, 1938, he made his home with his daughter, Mrs Hazel Wiley. Mr Hollingsworth was an Odd Fellow of years standing. He also held the honor of being the world's champion horse-shoe pitcher, a distinction he held for ten years. Many boys now grown-up will remember many pleasant trips they enjoyed with "Holly", an ardent fisherman.

Age has dealt lightly with this fine old patriarch. He was keenly intelligent. Each day he kept up on the world's news, enjoyed his family, his neighbors and his many friends. A short time before he passed away he told his daughters, "Life has been a grand game." To him who has loved the right and holy things and who has in life become habituated to the things which made possible a Heavenly existence, death holds no perils. To such the strange beyond holds no disappointment. Thus we pay the last tribute to our fine old friend, one by one they have dropped away as we have journeyed on and yet

life's journey does not seem a long one.

William Irving Hollingsworth, Jr - Los Angeles - 1992
William I. Hollingsworth, born in Los Angeles to W.I. and Hattie Jerome Hord Hollingsworth on Dec 4, 1906; died on May 5, 1992.
Survived by his wife, Betty: children: Patricia Moore, Cindy Wayne, Elizabeth Brown, Craig Griffith, William I. Hollingsworth, Jane Cramer and James Hollingsworth. A World War II civilian nanaval (sic) flying instructor im (sic) Holbrook, Arizona, he was a test pilot for bouglas Aircraft Co. in Long Beach and a realtor-broker since 1937.

A graduate of Stanford University and Heidelberg University, he was President of W. I. Hollingsworth & Co., Vice President and Treasurer of Calci Corp.; Director of Western Federal Saxings & Loan Assoc.: partner of Rossi-Biltmore Assoc. in San Francisco and Valley Plaza Properties, W.I. Hollingsworth and E. Phillip Lyon of Lyon &

Gordon in Los Angeles. His civic activities include:

Director of Central City Assoc. of Los Angeles, Director of Forest Lawn Cemetery Assoc.; first President of Bunker Hill Property Owners Assoc. and Los Angeles Downtown Re-Development.

He was a member of the Beverly Hills Presbyterian Church, a 32nd degree Mason with Al Malaikah Temple, Downtown Businessmens As-

soc., Los Angeles Country Club, California Club, Los Angeles Athletic Club and the Beach Club.

A memorial service to be held 12 noon, Friday, May 8 at Beverly Hills Presbyterian Church. (Los Angeles Times, Fri., 8 May 1992, p. A-46, column 4, paid death stories, courtesy Bonnie Jordahl of Al-Pambra, Galifornia.) This is one your editor missed; even though he resularly checks the Times obits on a daily basis at the coffee shop. William Irving Hollingsworth, Jr. was noted in Stewart's 1925 "Descendants of Valentine Hollingsworth, Sr.," on page 72, There his mother's name is called Harriet G. Hord, indexed only under "Hard." (But that is typical Stewart editing.) His father was a pioneer in Los Angeles real estate, having arrived in Los Angeles one year earlier than John Benjamin Hollingsworth (no near relation), your editor's grandfather, who came in 1887. Your editor's brother John says "W.I. Hollingsworth" (as he was universally known) and J.B. Hollingsworth were well acquainted as central L.A. businessmen after the turn of the century. William, Jr. was known in society and his name graced the L.A. Bluebook for many editions, and the society pages of several of the big city papers. He was married at least six times. Time had passed him by, it seems, for apparently no news article was written about him in any of the surviving dailies. He also developed a reputation of a playboy in the post World War Two years. He was a founding member of the Portuguese Bend Club in the Palos Verdes Pen-insula, which, not long after its inception, was scandalized by the sinking of the land in that region and the debacle of lawsuits and placing of blame which went on for decades (the land still moves, on a sheet of clay, day by day, into the ever-welcoming sea).

The father, W.I., Sr., is to be credited for distributing copies of Stewart's book as well as the 1884 book by William Baker Hollingsworth (subsequently stolen from the Central Library prior to your editor's first visit there in January, 1960) to many libraries.

(5) James Louis Hollingsworth, Eugene, Oregon - 1992.

HOLLINGSWORTH - James Louis Hollingsworth, 40, of Eugene, died

Darly Arrivals in the New World - Documentary Evidence.

The Virginia Patent Books have been printed under a general title, <u>Cavaliers and Pioneers</u>, in 3 volumes. The last two languished for a half century before reaching publication. Here are the occurrences of our surnames in these ancient volumes.

(1) Patent Book No. One, Part Two, page 585. Patent to Thomas Wallis, a practitioner of Physicke, 700 acres called Juring point, James Citty County, 28 July 1638. Southerly upon James River, Northerly upon a Creek parting land of Bridges Freeman, gentleman & said Juring point, West to land of Pr. Benjamine Carrill, North upon land of Pr. Francis Fowler, runing between lands of said Carryls & Fowler. Due for transportation of 14 persons: John Hollingsworth, Sarah his wife, Thomas Wallis, Richard Foster, James Whiting, Thomas Davis,

Samuell Hudson, Robert Allen, Melchesedick Floyd, Richard Weston, Margarett Sanders, William Worminger, Jon. Spencer, Katherine Harrison. (Cav. and Pio. Vol. 1, p. 94, col. 2.) This John and Sarah Hollingsworth, who arrived in Virginia prior to 28 July 1638, are not known to history before or afterward. Their arrival almost matches that of Richard Hollingworth at Salem, Massachusetts, in 1635, and, in truth, may antedate it. Old time descendants of Valentine, Sr. seem always to have been oblivious to these early arrivals: they believed that Valentine was the singular ancestor to all Hollingsworths in the solar system! (Pshaw!)

A note about headrights. Fifty acres was payable for each person (including slaves) transported into the colony. The list was made up legally, and could be transerred legally to another patentee if not used. Assigned lists might wait some time - years - to finally be located. There are some identical lists of names in the exact order, indicating clerical error or outright fraud, in these old books. In the above case, Thomas Wallis, a London physician, was in all likelibood the man who brought the Hollingsworths and others over. How. long Wallis waited to patent his land - rather how long it took the wheels of bureaucracy to turn - so that the patent was completed, is not possible to say. The 14 transportation headrights need not have lived in James City County, nor even in the colony, apparently. They may have died by then. All we can say is they were brought to Virginia before 28 July 1638 by Thomas Wallis.

(2) Patent Book No. 7, page 172. John Battle, 580 acres, in the Upper Parish of Nanzemond, att a place called Kill Many Swamp: 24 Apr 1682. For transportation of 12 persons: Robt. Hubberd, Samll Merrit, Wm. Morgan, Richd. Harrington, Tho. Skinner, David Hollingsworth, Joan Stiles, Mary Bates, Susan Meriday: Toney, Isabel, Bastian, Negroes. (C&P Vol 2, p. 240, column 1.)

NOTE: Nansemond County was down by the North Carolina line, or the Carolina frontier, as it was in those days. The records of that county are horribly incomplete. Again, we know nothing of the later history of this David Hollingsworth. Note that he, too, had come into the American colonies prior to the arrival of Valentine Hollingsworth, or, who got to what is now Delaware 10th of 10th month (Dec.) 1682.

(3) Patent Book No. 7, page 400. Mr. Richard Littlepage, 871 acres, New Kent County, on the South side of York River, & upon the North side of Chickahominy main swamp, 21 Oct 1684. Adjoining Moses Davies; & Mr. Henery Wyatt's path, in line of Mr William Basset & Mr. James Oustin (Austin? Ed.) For transportation of 18 persons: Thomas Stavens, Richard Elsom, William Betham, Thomas Smith, William Johnson, Joan Fuller, Joseph Cox, William Cole, Alex. Richason, Ann Bland, Mary Clarke, James Wade, Wm. Hollingworth, Thomas Russell, Alex. Fleming, Ann Townsend: & 2 Negroes (not named here - Ed.). (C & P. Vol. 2, p. 281, col. 2.)

It is possible some of these arrivals were not from over-seas, but from other colonies. There were men named William Holling(s) worth at that time living in Massachusetts and in Maryland. They could have been used for headrights though not settling in Virginia. We have seen several patents where one man's name appears as a 50-acre headright on all of the lists, with no hint of fraud!

These following two last headright grants are illustrative of the above remarks, as well as interesting to Hollingworth seekers.

- (4) Patent Book # 4, p. 88 (128). Lt. Colonel Edward Dowglas, 600 acres in Northampton County, 16 Apr 1657. On South side of Old plantation Greek, Westerly on same & land of Thomas Burdett, Southerly on land of Mr Edward Littleton & Northerly on his own land. For Transportation of 12 persons: William Prichard, Robert Bowlson, William Barrett, Alice Staples, Alice Alsop, John Powell, Gilbert Couling, Hugh Eglestone, Charles Hollingworth, Marian Cole, Thomas Poynter, William Miller. (C.& P. Vol. 1, p. 344).
- (5) Patent Book # 6, page 483. Captain Danll. Jenifer & Ann his wife, lately called Ann Toft, 2350 acres in Northampton County, 30 Oct 1673... (long text, including) w. 200 acres, part of 2600 acres granted said Ann Toft 9 Oct 1667" and "2150 acres part of surplus within said bounds: due by order &C. For Transportation of 43 persons ... (including these named) ... Wm. Mills, Wm. Prichard, Robt. Boyston, Wm. parrett, Alice Staples, Alice Alepp. Jno. Powell, Gilbert Goalinge, Hugh Eglstone, Cha. Hollingworth, Marryn Cole, Tho. Poynder... (C.& P. Vol. 2, p. 135.)"

 Note that these 12 names are virtually identical, including Charles Hollingworth. These entries are 16 years apart. Was this an example of fraud? Of course, only one Charles Hollingworth is indicated, and he was brought into Virginia prior to 16 Apr 1657. This probably refers to the known Charles Hollingworth or Hollingsworth who was in a court appearance in Maryland dated 7 Sept 1660, giving his age as 21. Moving about in those times was not any more difficult than it is today, in many cases. So we needn't scratch around looking for a 2nd Charles Hollingsworth. This man remained in Maryland and seems to have joined the waskers at Third Haven Meeting. We have no record of

anv children.

(1) Correspondent Clare Hollingsworth, Edmonton, Canada, sent a cutting from the St. Petersburg Times in Florida. Titled "Cleveland man designed was mask in 1912,"it tells of Garrett A. Morgan of Cleveland, who applied for a patent for a 'breathing device' on Aug 19, 1912 and obtained patent # 1,113,675 two years later and only 5 months before the opening of the Great War, 1914-1918. Morgan died in 1963 at the age of 87 years. But Tom Hollingsworth of the National Invention Center in Akron, says parallel inventions of such a device were brought out in England and Germany by that time. Nevertheless, said Hollingsworth, Morgan got recognition, even in the South! He was a black man.

(2) Before Hollingsworth Register came to be, in our search for our own family from County Wexford, we contacted a Mrs. Ethel G. Aycock of Los Angeles. Because we were not at that time seeking any of the Valentine Hollingsworth data, Mrs. Aycock's statements interested us because she was a descendant of an untraced Samuel Hollingsworth of Illinois, which sounded like ours. We just found her Christmas card of 1964, the last time we were in contact. Her name and that of Frances Gibson appear on it. Anyone know of her? The Samuel whom she

sought turned out to be a son of Abraham of Schuyler Co., Illinois. He had served as captain of a company in the Black Hawk Indian War of 1832 as did Abraham Lincoln. Mrs. Aycock knew her Sam Hollingsworth was "a friend of Abe Lincoln." This was a long held tradition. But we would be interested to know if anybody knows of relatives of Ethel Aycock.

(3) A State Census of Alabama, 1820, has long been in print, but lacked one county, Lawrence, which survived. Many county schedules did not survive. We had the pleasure of consulting a Mormon film (1533830) of the handwritten census. The published copy is printed. All of the Hollingsworths were transcribed for printing correctly, except for St. Clair County, page 14, line 3, printed as "Joab" Hollingsworth. Our examination, which took some scrutiny, produced a different interpretation. We think it is JACB HOLLENSWORTH. This fits better with the fact that later censuses show a Jacob was in St. Clair, and we never have seen a Joab at all.

(4) Once again, Wynn Hollingsworth appeared in an episode of "In the Heat of the Night" as "Jeff Dillard." It was scheduled to be shown on Friday, Dec 4, 1992, but was substituted for another segment. The plot deals with child molestation. This was a rerun from some years ago, and would have showed on L.A.'s Channel 5 KTLA TV.

We have no other data on actor Wynn Hollingsworth.

(5) Correspondent Douglas R. Hollingsworth, Bangor, maine, has again contributed a number of clippings. This one is from the Bangor Daily News of 1991. By Gloria Flannery of the staff, it deals with a \$400,000. "Hollingsworth Fund" at Caribou. In 1986, Wilbur Hollingsworth of Belgrade Lakes had donated \$100,000.00 to establish a school scholarship in the memory of his late wife, Luella (Poland) Hollingsworth, a Caribou native. She died in 1984; was a 1927 graduate of Caribou High. Mr Hollingsworth recently threatened to withdraw his original gift if it weren't matched. This started a drive to do just that, culminating in the nearly half million dollar fund. Wilbur Hollingsworth is a retired lawyer, and was described as a "very kind and generous man."

(6) Correspondent John A. Hollingsworth, of Cherokee Village, Arkansas, sent us a cutting from The Ottumwa Courier, Ottumwa, Iowa, Mon. Sept. 16, 1991, p. 16. It tells us "Hollingsworth horses place at fair." Gilbert Hollingsworth and his sons, Garv and Terry, own a stable at Ottumwa, and showed young horses at the Iowa baddlebred Futurity on Aug 17, 1991. They placed 1st, 3rd and 4th in the open weanling championship, third in the open weanling filly class, and a number of other classes, a long and impressive list. A stallion, Inspiration's Choir Boy, placed 2nd in the open fine harness class, and another horse, Uptown's Moongo, placed 2nd in the open five-gaited stallion/gelding class, and 3rd in the Iowa five-gated stake class.

(7) The Set. Nov. 23, 1991, issue of The Indianapolis News, p. 0-2, in the Inside Marion County Section, by Paul Bird, for Pike Township, tells us of Harry J. Hollingsworth, Pike Twp. Historian, and his visit to College Park Elementary School. He entertained the second grade class with an antique corn sheller and ears of dried corn. It was part of the celebration of Fall and Harvest Davs. Mar. Hollingsworth was 73 in 1991. His grandson, Jason Profant, 7, was in the class. His mother is Sandra Hollingsworth Profant. Harry says his family settled in Pike in 1828, and beasted of more than 50 male

voters in the township in 1860, the largest family there. (Thanks to

Mrs. Betty P. Deacon of Indianapolis.)

HOLLET H. SNOW

Mr. Snow in (is-error) the son of William C. and Amanda (Hollingsworth) Snow, and was born in Greene county, Missouri, Dec. 13, 1847. He grew to manhood upon the farm, and in 1868 was married to Miss Mary Lee, of this county. Their union was blest with two boys and two girls. In 1871 he came to Springfield, where he worked at Schmook's mill until 1879. He was then appointed policeman and served on the force a year; then was a deputy constable under D.V. Savage for six months, and from then until the spring of 1882, he was janitor of the public school building. On the 4th of April, 1882, he was elected to the office of city marshal, upon the Republican ticket. His first wife dying, Mr. Snow was married the second time to Julia E. Buckner. They have by this marriage one girl and two boys. He is a member of the Knights of Honor, and his wife is a member of the Christian church. His parents came from Indiana in 1844, and his father died March 28, 1865. His mother is living in Springfield. They had three girls and seven boys, Hollet being the fifth child. In our Dec. issue, page 62 (1991) the obituary of Mary shows the extent of her offspring. Amanda Hollingsworth Snow is one of them. It was pretty obvious to us even in the early 1960s, because this man is surely named after his mother's brother, Hollet Hollingsworth.)

Thank you for your letter of 16 February. I have checked the British Library's catalogues and a variety of biographical sources but have been unable to trace any information about Thomas Hollinsworth/Hollingsworth. I have consulted Johnson, Charles. A general history of the pyrates. 4th ed. 2 vols. London: T. Woodward, 1725 and found that the life of Thomas Hollinsworth is not included in this work, nor is there mention of Hollinsworth in the entry for Captain Kidd. furthermore contemporary accounts of the trial and execution of Captain Kidd do not mention Thomas Hollinsworth.

In addition I have consulted the following works on piracy but have found no information on Thomas Hollinsworth:

Gosse, Philip. The history of piracy. London: Cassell, 1954.

Gosse, Philip. The pirates who's who. London: Dulan and Co., 1924.

Piracy and privateering. London: HASO, 1972. (National Maritime Museum catalogue of the Library vol. 4)

For further advice about your enquiry I suggest that you get in touch with the National Maritime Museum Library (Park Row, Greenwich, London SE10 9NF) and, if you think an Irish connection likely, with the National Library of Ireland (Kildare St., Dublin 2).

As Jack Benny would sav: "Well!" Our letter of 16 Feb had been delayed many years; just to "allow" incremental accessions of the greatest library in the world, and because we had sent a similar query and received a similar reply as the above, 25 years ago. Our source which does prove that there was a Thomas Hollinsworth sailing with Capt. Kidd in the 1690s, is the Calendar of (British) State Papers, Colonial America & West Indies, correspondence, 1696/7 etc., pp. 259 et seq.

The above shows a T.H. was captain of his own pirate ship sailing around Irish ports, and was last seen being chased into Dublin harbour by a French privateer. Kidd was not hanged until 1701.

It's too bad that the extensive bibliography on "The Pyrates," one published only a quarter of a century after Kidd died, make no mention of this Hollinsworth pirate! The State Papers were not printed until over a century later, which probably accounts for it. But why some other source does not notice him is puzzling. Kidd was not the leader of these pirates; therefore Hollinsworth was probably on an equal status with all the co-captains in the adventures on the high seas. Hollinsworth had "now sailed from Galway" according to one of the 1696 letters.

Your editor has always been puzzled by the possibility that our much-sea-faring family of Arklow may descend from this man. But try to prove it! Or disprove it, even. No way, Jose! Of course, Kidd often used phony names, even calling himself John instead of William Kidd, so it might be that "Thomas Hollinsworth" was a pseudonymn. But that is really kind of fanciful: Who would think up such a name as a phony name? (See HR March, 1967, page 6.)

He was in Ireland in 1966 & I enclose for you to read what family information he brought back & also a Copy of the family that my Sister Nan Harrison, Inverleigh, Victoria, Australia, sent me after her visit home in 1947. I am greatly afraid the Hollings-

worth side is not very clear with me but do know Ballinakill well, also Tomagaddy, spent many happy days there with Aunt Lee & Uncle Jack Warren & in Clone House, Monamolin with my urcle Willie Johnston. I have a nice photo of my Grandmother Hollingsworth & often heard my mother say, there was no one like her. She died before I was born.

My 4 brothers have passed on. I have another sister Ethel in Australia. Just we three girls left.

NOTES: If Winifred is living she will be 100 this year. But it seems we heard through Rex Johnston that she had died. The above was about all we got from her. Had we been able to afford long distance telephone calls, or, better yet, personal visits to such precious relations, maybe much more would have surfaced by in-depth conversation.

Ballinakill and Tomagaddy are our Wexford Hollingsworth strongholds! Tomagaddy was mainly held under lease by Tackaberrys, and the great missionary Methodist Minister, Rev. Fossev Tackaberry, was bern and raised in "Tomagaddy House," and read Scripture, it is said, from a large bible which had a great hole through it to the binding, driven by a pikeman during the Irish Rebellion of 1798. (They hated Protestant Bibles - or "heretick books," as they termed them - may the wind always be in their damned faces.) Lily Warren was the last owner of Ballinakill with the Hollingsworth surname. Her father was John Hollingoworth of Ballinakill (died 1902), son of John (1789-1877) the eldest brother (unproved) to our Frederick, son of Samuel Hollinsworth (sic) (1765-1815), son of the original John Hollinsworth of Ballinakill & Monroe, Parish of Ballycanew, Go Wexford, born ca 1714: died 1791; farmer. As you know, before him, we know nothing (Was his father Thomas Hollingworth the right) ing. (Was his father Thomas Hollinsworth the pirate?)

with the thousands of letters like the above we have received with like information, this is only among a handful which dealt with our own family of Hollinsworth/Hollingsworth. The avalanche was overwhelmingly about Valentine Hollingsworth and his family. I don't mind saving that after 33 years, it roally is a bit discouraging.

Letter of Dec 4, 1962 from E. R. Hollingsworth, 2115 Oxford St., Rockford, Illinois (before the advent of zip codes!). He had been our very first contact in 1960 when all we knew was that Granddad and Greatgranddad Hollingsworth were from Rockford. He did not know in 1960 if he was related, but this letter proves he is not, but is from - you guessed it (surprise surprise), Valentine.

Dear Henry: I can shed no particular light on vour question but I will state the following.

My name is Elbert K. Hollingsworth. I was born May 15, 1910 in Rock Island, Illinois where I lived until moving to Rockford in 1935.

I have a brother John (age 56) and a sister Margaret (age 48).

My father's name was Maurice Alden. He had five (?four-Ed.) brothers and I sister. My dad's parents were Abraham (usually referred to

as Abram) and Celeste Mote (Hollingsworth-Ed.).

My dad was born and raised in Southern Ohio on a farm near Oregonia, which is between Cincinnati and Dayton. He came to La Salle, Illinois and then Rock Island about 1900. By dad always said that his line of Hollingsworths, which was English, came from the first settlement in the Carolinas, which was led by Valentine Hollingsworth (you readers, puh-LEEZE do not swallow this line-Ed.).

Because there are four other Hollingsworths in the telephone book (only 1 of which I know) I had sent copies of your letter to them with the suggestion that they write you direct if they have any in-

formation.

My dad was a great man for genealogy, knowing the family tree all the way back. However, I haven't done nearly as well.

NOTE: Stewart's book (1925) page 68 (incorrectly indexed to p. 60 for Mote, Celeste - Ed.), shows Maurice9 Hollingsworth one of the 7 children of Abraham8 and Celestia (sic) (Mote) Hollingsworth who married in 1861. Abraham was a son of Joseph7 and Sarah (Furness) Hollingsworth of Warren County, Ohio (in their table of children it says that Abraham married Celeste Mote); (of Abraham6; Joseph5; George4; Abraham3; Thomas2; Valentine). Abraham and Joseph had come from Newberry Co., South Carolina to Ohio in 1804, which fits the letter above.

A MOTTRAM FAMILY FILE

In April, 1966, the late Frederic Attwood, of New Canaan, Connecticut, with offices in New York City at the time, loaned your editor his file of material he collected on his wife's family, which is our own Wexford family. He made extensive inquiries about "Hollingworth Hall" (whose spelling, oddly enough, he seemed always to get right, to his everlasting credit) and obtained a wealth of material. Because we had to return everything, we typed up a calendar of the contents. Unfortunately, in those days, electrostatic photocopy (pioneened by Kerex) was not readily available. We copied most of the material on old "wet copy" paper which soon turned brown, then almost faded out, but not before the volatile, smelly chemicals in the paper had spread out and ruined about an inch of documents in the same file folder! The items, though just legible, will not reproduce. Where the original is

now is not known, but possibly with Bill H. Attwood, former Ambassador to Kenya and Editor of Look Marazine, Frederic's son. (Bill's middle name is Hollingsworth of course.)
